- 5. That the appellant file application but despite that respondent not implemented the order dated 03/10/2024 which is violation of Tribunal order date 03/10/2024 and amount to contempt of court. Copy of application is attached as annexure-B.
- 6. That the appellant file the instant execution petition on following grounds.

Grounds:

- 1. That respondent not implementing the order dated 03/10/2024, despite of the Honorable Court's direction is the violation of Court's order and amounts to Contempt of Court.
- 2. That being the Apex Court of the Province, the respondents are legally bound to obey the same in letter and spirit, but the respondents are totally failed to reinstate the petitioner.
