- 1. That the appellant has filed the instant appeal alongwith with suspension application against the order dated 13.06.2024 and against the second e. order dated 22/06/2024.
- 2. That the instant appeal was fixed in Preliminary hearing on 03.10.2024 and Honorable Tribunal was kind enough to admit the appeal for regular hearing and impugned orders were suspended. Copy of order sheet dated 03.10.2024 is attached as Annexure -A.

was stopped but till date the appellant not acted upon the impugned order.

- 4. That the appellant didn't relieve his charge and performing his duties at Mardan till suspension order and onward. The appellant performing his duty regularly but stoppage of salary without any reason and justification amount to force labour which is violation of Article-13 of constitution of Pakistan as well as section 17 of Civil Servant Act, 1973.
- 5. That due to stoppage of salary the financial position of the appellant unbearable.

It is therefore, most humbly prayed, that the acceptance of this application the respondent may be directed to release the salary of the appellant. Any other remedy which this august tribunal deems fit and appropriate that may also be awarded in favour of appellant.
