**INQUIRY REPORT REGARDING ILLEGAL APPOINTMENTS AT  
DHO OFFICE BATTAGRAM**

In compliance to DGHS Khyber Pakhtunkhwa Office Order No.13070-73/AE-VI Dated 06/09/2024 (Annex-A), the inquiry report regarding recruitment of various cadres of Technicians by DHO Battagram is submitted as under:

**BACK GROUND:**

- 1) Various Paramedics posts were advertised by DHO Battagram in June 2021 (Annex-B). Meeting of Departmental Selection Committee was convened on 12/07/2021 and appointment orders were issued for CT Radiology, CT Pulmonology, and CT Surgical on 15/07/2021 & 30/07/2021 (Annex-C) and orders for EPI Technicians / Vaccinators were issued on 17/08/2021 (Annex-D).
- 2) On 20/08/2021, an incident was reported through Whatsapp by the then DHO Battagram to the then DGHS Khyber Pakhtunkhwa (Annex-E) that Local MPA came at night along with his gunmen / guards and forcefully took all the record of recruitment process as he wanted his recommended candidates to be selected.
- 3) Due to complaints of irregularities in the recruitment, the then DGHS issued cancellation order of all the appointments made & ordered a facts finding inquiry in the instant case vide office order No. 6028/DGHS Dated 23/08/2021 (Annex-F) & it was endorsed by DHO Battagram vide Office Order No. 1803-08/DHO/BTGM Dated 27/08/2021 (Annex-G) and all Health Facilities were directed not to accept arrival reports.
- 4) Facts finding inquiry was conducted by Dr. Faisal (Regional Director Health Hazara Division) and Dr. Hidayat Ullah (Deputy Director Coordination Cell DGHS office) and inquiry report was submitted to DGHS Khyber Pakhtunkhwa with the recommendations that the recruitments may be cancelled & these posts may be re-advertised due to procedural lapses in the recruitment process. (Annex-H)
- 5) On 05/01/2023, Service Appeals No. 76 to 82/2023 were filed by Abidullah and others against Office Order dated 23/08/2021 issued by DGHS, & Office Order dated 27/08/2021 issued by DHO Battagram and for No Action on their Departmental Appeal.
- 6) Judgment in the above mentioned Service Appeals was announced on 24/01/2024 (Annex-I) the following directions:
  - a) The impugned order is set aside and opportunity will be provided to the appellants to defend themselves as they were appointees of the process.
  - b) Respondents are directed to provide opportunity to defense & hearing to them.
  - c) Appellants who assumed their charge are reinstated into service for the purpose of inquiry.
  - d) Respondents are directed to conclude inquiry within 60 days after receipt of this copy.

7) In Compliance of the judgment, the instant facts finding inquiry committee was constituted comprising of the following members:

- a. Addl: Director General (HRM) DGHS office
- b. Director (Litigation) DGHS office
- c. Director (HRM) DGHS office
- d. Deputy Director Paramedics DGHS

**PROCEDURE:**

DHO Battagram (Current) alongwith his relevant staff & the appellants / candidates were called to DGHS for personal hearing.

Opportunity of personal hearing was provided to all the appellants / candidates but 2 candidates out of 19 did not come for personal hearing (Statement of applicants & statement of Clerk is annexed as Annex-J & J-1).

The then DHO Battagram was also contacted to record his statement (Annex-K) & in his written statement he denied all the charges & according to him the recruitment process was done according to Esta Code.

The committee heard the appellants/candidates one by one & thoroughly examined all the relevant record and noted the following findings:

**FINDINGS:**

- These recruitments were made without ETEA test which is mandatory for appointments of such cadres per Government Policy.
- Short listing committee was not notified which is one of the important step in the recruitment process & consequently no list of short listed candidates was displayed on notice board.
- Departmental representative was nominated by the then DGHS (Annex-L) while it was the mandate of Health Secretariat to nominate representative from Secretariat for such appointments. (Annex-M).
- Two candidates were appointed on one post of vaccinator. It is pertinent to mention here that the vaccinator posts (BPS-06) were regularized under GAVI Act and there are no approved / Notified service rules of paramedics for appointment in BPS-06.
- Majority of the Experience Certificates, were issued by M.S DHQ Battagram to the candidates who worked on volunteer basis and without any notification & some of them have experience certificates which were issued before acquiring of the diploma which is a gross irregularity & mis-use of powers to facilitate the undeserving Candidates.
- For JCT (Radiology), approval for filling of 04 vacant posts was granted while 05 candidates were appointed. Two candidates failed in interview securing 2 marks each but even then they are appointed.

CONCLUSION:

In view of the above, it is concluded that there are multiple procedural lapses in the recruitment process for example

1. Recruitment process without conducting ETEA test.
2. Awarding experience marks to candidates on invalid experience certificates.
3. Appointment of candidates who were failed in interview.
4. Appointment of two candidates on one post of vaccinator.
5. Appointment on Dying Cadre Post of Vaccinator (BPS-06).
6. Appointment on Vaccinator post (BPS-06) without existence of service rules for such posts.
7. Nomination of departmental representative by DGHS instead of Secretary Health.

RECOMMENDATION

- The appointment order may be **withdrawn ab-initio** and all the vacant posts of Paramedics may be **Re-advertised** as per rules / Policy in vogue so that deserving/eligible candidates can be selected to serve the needy people.
- DHO, MS & other officer of health department working on managerial post may be trained on recruitment process as due to procedural lapses this department is facing litigation issues.
- As disciplinary proceedings under E&D rules 2011 has already been initiated against the then DHO Battagram and his office staff who were involved in the recruitment process, so no further action is required against them.
- Dr. Muhammad Rahim DMS DHQ Hospital Battagram & Dr. Rashid Hamayun DMS DHQ Battagram may be censured on account of issuance of experience certificates to the candidates who were not entitled.

**WHEREAS**, in compliance to the judgment of service tribunal a de-novo inquiry was conducted wherein opportunity of personal hearing was granted to all the appellants.

**WHEREAS**, the inquiry committee recommended that the said recruitment process may be cancelled due to multiple procedural lapses in the recruitment process & these posts may be re-advertised as per govt rules/policy.

**And, now, therefore**, the whole recruitment process is cancelled ab-initio and the vacant positions may be filled as per rules/policy in vogue.

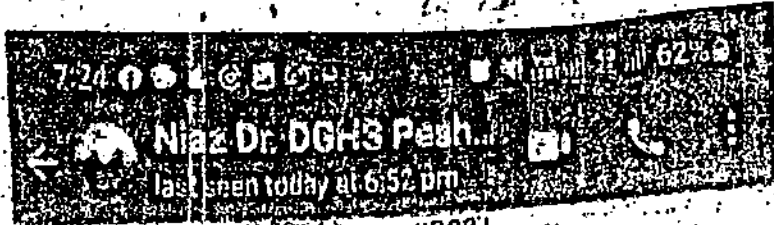

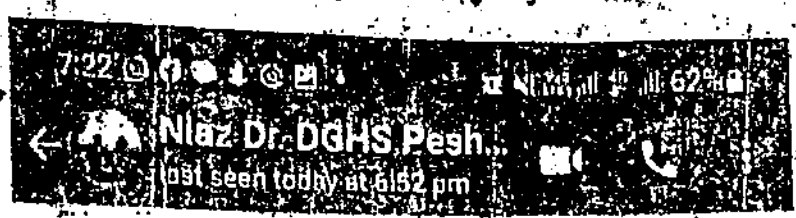

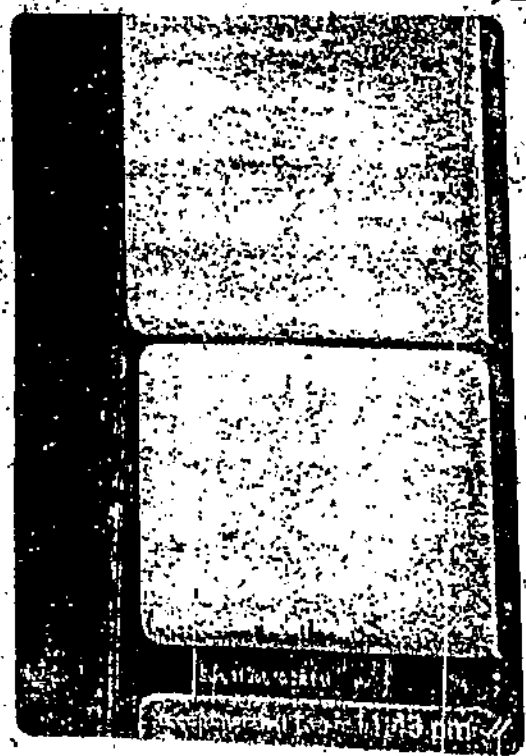

**INQUIRY REPORT REGARDING ILLEGAL APPOINTMENT AT DHO OFFICE  
BATTAGRAM**

In compliance to the DGMS Khyber Pakhtunkhwa office order bearing No. 6028/DGMS, dated 23/08/2021, the inquiry report regarding recruitment of various cadres of Technician in District Health Officer Battagram is submitted as under:

**BACK GROUND:-**

District Health Officer Battagram was called along with his relevant staff and all recruitment process record on 30/08/2021 at 9:00 AM in the office of Additional Director General Health (Hazara Division). The documents of recruitment process were checked by both the inquiry officers and the following points were noted:

- Relaxation on ban of recruitment was issued to DHO Battagram by SO (General) Government of Khyber Pakhtunkhwa Health Department vide No. SOG(HD/1-2IP&T/2020/2744 dated 29/04/2021 for the following categories.

**1. JPHC/EPI**

- 128 applicants were short listed for interview for JPHC/EPI, 10 candidates were selected among them (Annex-A)
- In the merit list of JPHC (EPI) the experience marks of Serial No. 2,3,4,5,6,8,9 & 10 was issued by MS DHO Hospital / DHO Battagram where all of them have worked voluntarily and not under proper notification. At Serial No. 5,8,9,11 experience certificate was issued before receiving of diploma while at Serial No. 2, experience certificate by authorized institute was not found.
- 4 marks of experience were given to S. No. 2,3,4,6,8 & 9 while 7 marks are given to S. No. 5,10 accordingly.
- S. No. 7 is failed in interview having 3 marks (passing marks is 3.2) while he was selected.

2. PHCT (Surgical)

- 24 candidates were short listed and called for interview.
- Among them 02 were selected at S. No. 1 & 2 (Annex-B).
- The experience certificate were issued to both candidates by MS DHQH Batagram while both were worked as voluntarily and experience certificate to S. No. 1, was issued before receiving of diploma.
- Both of them were given 4 marks for interview.
- At S. No. 6 marks of diploma was placed in the 2<sup>nd</sup> division column instead of 1<sup>st</sup> division column.
- At S.No. 24 needs to be placed at S. No. 18 according to marks.
- The experience certificates to all of the candidates were issued by MS DHQH Batagram where they worked voluntarily.

3. JCT (Radiology)

- The approval from the competent authority for filling of vacant positions of JCT (Radiology) was given for 4 seats while total 05 candidates were selected (Annex-C).
- 08 candidates were short listed among 05 were selected.
- At S. No. 2 experience marks 4 were given, certificate was issued by MS DHQH Batagram. He was marked failed in interview receiving 2 marks while he was selected.
- At S. No. 3, seven (07) marks given as experience by MS DHQH Batagram before receiving of diploma.
- S. No. 4&5 both were failed in interview receiving 2 marks (passing marks is 3.2), but both were selected.
- Among them 03 candidates were called for interview where diplomas of Radiology were not found with the applicants.

4. JCT (Pulmonology)

- 09 candidates were short listed among them 02 were selected (Annex-D).
- At S. No. 1 diploma was not present but he was granted 20 marks of diploma as 1<sup>st</sup> division. He has no experience but have granted 4 marks of experience and kept him on top of the selected candidates

Statement of Shah Faisal (Junior Clerk)

Anexure F

According to his statement, I have made merit list purely on the documents submitted to the office by candidates. Any discrepancy may be considered as clerical mistake as I have worked honestly and without any intention for favor my candidate illegal. The final merit list was handed over to me by selected committee and I have entered as it is duly signed from panel committee. The panel signed it after thoroughly examination. Nothing was added or subtracted by me from the said list (Annex-I)

Findings

- According to the statement of DHO and Junior Clerk (Batagram) advertisement was floated in daily Aji on 01/06/2021, but they handed over the photocopy of advertisement was on plain paper and not on proper newspaper page (Annex-J).
- The recruitment process was done without involving of recruitment testing agencies for BPS-12.
- Short listing committee was not notified for the above mentioned posts.
- List of short listed candidates was not displayed on notice board nor on Health Department web site.
- Minutes of short listing committee was also not available.
- Minutes of the selection committee is attached as Annex-K.
- In the Radiology sanctioned vacant posts were 4 but selected 5 candidates.
- In the vaccinator sanctioned vacant posts was 1 while 2 were selected.
- According to 2% quota they should select 1 candidate instead of 2 (total candidates were 49).
- Most of the candidates were marked failed in the interview but selected by the committee.
- Most of the candidates have marked unauthorized experience before the receiving of diploma.
- All most all the selected candidates having no proper experience certificate but they were selected on the basis of their experience marks.
- According to the DHO statement: there is clerical mistake and he feel sorry for the process and the mistake was done by his staff.
- According to Junior Clerk who prepared the whole process stated that it is clerical mistake and final merit was handed over by selection committee.

issued after verification of testimonials.

- At S. No. 1,2,3 all of them failed in interview receiving 3,2&1 marks respectively while S. No. 2,3 were selected.

#### 5. Vaccinator.

- 49 candidates were short listed for 01 sanctioned post among them 02 was selected (Annex-E).
- In short listed of 49 candidates, 02 disable quota candidates were selected which 4% disable quota and not 2% quota.
- In the S. No. 1, disable certificate it was mentioned that his right hand is handicap and he is able to work light duty/official work while he was selected as vaccinator for out- reach and fixed centre for vaccinator.
- At S. No. 2, 4 marks of experience were granted but having no experience after receiving of diploma. In his disability certificate it was mentioned that he is able only of official work only while he was selected as vaccinator for out-reach and fixed centre.

#### Statement of Dr. Waseem Ahmad (DHO Batagram)

According to his statement that I wrote a letter to Health Department for removal of ban on recruitment of the staff which was granted. I give advertisement through proper channel and wrote letter to DGHS for Departmental selection committee. The interview was conducted on 12/7/2021, minutes were written down.

I assigned Head Clerk Faisal for short listing of candidates and short listing of documents. He prepared list and asked DDHO Dr. Gul to kindly verify the list. Merit list was prepared and displayed on notice board. During the interview, two candidates got stay order from the court due to that the process of recruitment was stopped, I issued order for EPI Technician posts.

The higher authorities have issued a letter for cancellation of interview process so I followed the order and issued letter of cancellation of interview vide No. 1893-08 dated 28/08/2021 (Annex-F).

During the process of inquiry, I noted that there are many clerical mistakes in the merit list. I agree that, I did not do it willfully, I really on the staff who committed the mistakes.

**JUDGMENT**

**Rashida Bano, Member (J):** The instant service appeals have been instituted under section 4 of the Khyber Pakhtunkhwa Service Tribunal, Act 1974 with the prayer copied as below:

“That on acceptance of this appeal the impugned orders dated  
23.08.2021 and 27.08.2021 may kindly be set aside and the



respondents may kindly be directed to restore the appointment order dated 30.07.2021 of the appellant with all back benefits including seniority. Any other remedy which this August Tribunal deems fit that may also be awarded in favor of the appellant.”

2. Through this judgment we intend to dispose of instant service appeal as well as 6 connected service appeals which are:

1. Service Appeal No.77/2023
2. Service Appeal No.78/2023
3. Service Appeal No.79/2023
4. Service Appeal No.80/2023
5. Service Appeal No.81/2023
6. Service Appeal No.82/2023

In view of common questions of law and facts, the above captioned appeals are being disposed of by this order.

3. Brief facts leading to filing of the instant appeals are that the appellants were appointed against the posts of JCT (Radiology) and JCT (Pulmonology) vide orders dated 15.07.2021 and 30.07.2021. They were serving against their respective seats when in the meanwhile, vide office order dated 23.08.2021, their appointments were cancelled and an inquiry was ordered to be conducted in the matter. Resultantly, all the orders were cancelled vide impugned office order dated 27.08.2021. Feeling aggrieved from the said orders, they filed writ petition before the Peshawar High Court and the Peshawar High Court, vide order dated 15.09.2022 transmitted the writ petition to the respondents for treating the same as



departmental appeal. But the respondents did not respond to the departmental appeal, hence, the instant service appeals.

4. Respondents were put on notice who submitted written reply/comments on the appeal. We have heard learned counsel for the appellants and Mr. Asif Masood Ali Shah, Deputy District Attorney for the respondents and have gone through the record and the proceedings of the case in minute particulars.

5. Learned counsel for the appellants argued that the impugned orders dated 23.08.2021 and 27.08.2021 were against law, facts and norms of natural justice. He submitted that the respondents had violated Articles-4 & 25 of the Constitution of Islamic Republic of Pakistan, 1973. Further submitted that no inquiry had been conducted before passing of the impugned orders which was against law and rules. Lastly, he concluded that the action taken against the appellants was arbitrary and malafide, therefore, he requested for acceptance of the instant service appeals.

6. Conversely, learned Deputy District Attorney submitted that the respondents had treated appellants in accordance with law, rules and principles of natural justice. Further submitted that a fact finding inquiry had been conducted before passing of impugned orders; that the appellants were appointed without conducting of ETEA test. Further submitted that irregularities had been committed in the process of appointments of the appellants due to which their appointments were cancelled. Therefore, he requested for dismissal of the instant service appeals.



7. Perusal of record reveals that appellants applied for their respective posts in consequence of publication published in newspaper for the posts of JCT Radiology and JCT Pulmonology advertised by respondent No.3. Appellants were considered by the DPC duly constituted and attended by the respondent No.3 as Chairman, Dr. Ahmad Faisal representative of DGHS and Mr. Mustafa Khan representative of DC Battagram as members held on 14.07.2021 upon recommendation of DSC, appellants were appointed vide order dated 15.07.2021 and 30.07.2021 by respondent No.3.

8. Appellants assumed charge of their posts on 19.07.2021, 30.07.2021, 02.08.2021, 03.08.2021 and 06.08.2021 respectively and started performing official duties but appointment order was withdrawn by Director General Health vide order dated 23.08.2021 followed by order of respondent No.3 dated 27.08.2021 on the grounds of irregularities committed during appointing/recruitment process. Appellant approached worthy Peshawar High Court, Peshawar by filling writ petition bearing No.955/2021, which was considered as departmental appeals vide order dated 15.09.2022 by considering appellants as civil servants and send it to the respondent to decide it. The order of worthy Peshawar High Court is reproduced as under:

*"Since the matter squarely falls within the jurisdiction of service tribunal, as such, jurisdiction of this court is bar under Article 212 of The Constitution of Islamic Republic of*

*Pakistan."*



In view thereof copy of the memorandum of this writ petitions be transmitted to the respondents/department and be treated as departmental appeals for decision in accordance with law. On the completion of 90 days the petitioners would be at liberty to approach service tribunal subject to all just and legal exceptions. Respondents after receipt of order of Worthy Peshawar High Court alongwith writ petition did not decided the matter within 90 days. (41)


9. It is also pertinent to mention here that appointment orders were cancelled as per representative of respondent upon report of respondent No.3 who reported that local MPA Mr. Zubair forcefully snatched entire record of appointments/recruitments of appellants at gun point from him as he wants to get appoint his blue eyed who was not appointed. When respondent No.3 reported incident of snatching of record legal proceeding must be initiated against the said MPA but instead of doing so, appointment orders were concealed without providing opportunity to direct effectees i.e. present appellants which is against the settled norms and rules upon subject and is not sustainable in the eyes of law.


10. Moreover it is mentioned in cancellation order dated 27.08.2021 local in-charge are directed not to accept the arrival of any of appointee/candidate but present appellants submit their arrival reports and also assumed charge their posts. So, when appellants assumed charge then they became civil servants and they will have to be dealt with in

accordance of rules and law, otherwise too Worthy Peshawar High Court considered appellants as civil servant.

11. In the circumstance it would be appropriate to provide opportunity to the appellants to defend themselves as they were appointees of the process in which irregularities were allegedly committed. Hence, impugned orders are set-aside with direction to the respondents to associate appellants with the inquiry proceeding by providing opportunity of defense and hearing to them. Appellants who assumed charge of their respective posts are hereby reinstated into service for the purpose of inquiry. Respondent are further directed to conduct and conclude inquiry within sixty days after receipt of copy of this order. Costs shall follow the event. Consign.

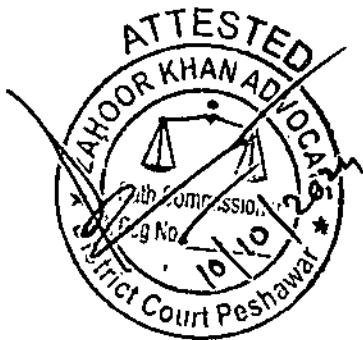
