2. That the appellant was suffering from sugar and heart problems wherein the appellant had to lose his one leg and due to that the appellant was assigned light duty. Copy of letter is annexure B.
 3. That the respondent department, upon the recommendations of the departmental promotion committee, promoted 222 sub inspectors to the post of Officiating Inspector BPS-16 vide the impugned order dated 02.11.2023 and omitted the name of appellant in the said promotion order. Copy is annexure C.
 4. That when the appellant got knowledge about the said order, the appellant preferred a departmental appeal against the said order before the respondent on 07.07.2024 but no order on the said appeal has yet been passed by the respondent department. Copy is annexure D.
 5. That now the appellant is constraint to approach this Honorable Tribunal on the following grounds inter alia;

GROUNDS:

- A. That the impugned order is against the law, facts of the case and against the norms of justice.
- B. That the appellant has been subjected to injustice and appellants have not been treated in accordance with law.
- C. That the respondents have not exercised the jurisdiction vested in them and have exercised the jurisdiction not so vested.
- D. That the appellant is qualified and suitable to be promoted to the post of Inspector BPS-16 and is quite senior in the list "F" but even then name of the appellant has been omitted in the impugned order which is against the law and justice.
- E. That many persons who were quite junior with respect to the appellant were promoted and the appellant was denied the said promotion without any plausible reason.
- F. That the appellant has performed his duties to the entire satisfaction of the respondent department and even is now performing his duties.
- G. That it is the basic responsibility of the respondents to treat the appellant according to law and to promote the appellant accordingly.
- H. That other grounds shall be advanced at the time of arguments with the permission of the Honorable Tribunal.
