PRAYER: ON ACCEPTANCE OF THE INSTANT SERVICE APPEAL, AGAINST THE IMPUGNED ORDER DATED 16/04/2024 PASSED BY RESPONDENT NO. 2 WHEREBY THE APPLICANT WAS AWARDED PUNISHMENT OF FORFEITURE OF TWO YEARS APPROVED SERVICE; AGAINST WHICH THE IMPUGNED ORDER DATED 22/08/2024 WAS PASSED BY RESPONDENT NO.1 IN DEPARTMENTAL APPEAL OF THE APPELLANT WHEREBY THE APPEAL OF THE APPELLANT WAS REJECTED. BOTH THE IMPUGNED ORDERS MAY GRACIOUSLY BE SET ASIDE AND MAY BE DECLARED ILLEGAL, UNLAWFUL, WITHOUT LAWFUL AUTHORITY, AGAINST THE LAW, RULES AND SETTLED PRINCIPLES; FURTHERMORE THE CONSEQUENTIAL SERVICE BACK BENEFITS OF APPELLANT MAY ALSO BE AWARDED TO APPELLANT, ANY OTHER RELIEF WHICH THIS HON'BLE TRIBUNAL MAY DEEM FIT AND <u>APPROPRIATE MAY ALSO BE GRANTED.</u>

Respectfully Sheweth,

The Appeallant very humbly submits as under:

- 1. That the Appellant has rendered more than 16 year service in the police department and is presently posted as SHO Police Station Saddar (Haripur). Appellant always performed his duties with devotion, dedication and honesty to the entire satisfaction of his superiors and never provided them a chance of reprimand.
- 2. That without conducting any departmental inquiry or issuing a charge sheet or providing a copy of inquiry report, if any, and without serving a show cause notice the District Police Officer Haripur vide this letter OB No. 275 dated 16-04-2024 has awarded the Appellant punishment of "Forfeiture of (02) two years approved service" and that too without taking into consideration the stance and the reasons advanced by the Appellant. (Copy of Impugned Order dated 16-04-2024 is attached as annexure "A")
- 3. That the allegations as incorporated in the punishment order are incorrect, baseless and Malafide against the facts and proof.
- 4. That Appellant remained posted as SHO Police Station Hattar (Haripur District) for a period of only three (3) months. During his period he carried out his duties efficiently, effectively and honestly. He left no stone unturned in discharge of his official duties.

- 5. That it is incorrect and baseless that Appellant has ever been non-serious towards his official duties like security arrangements of two Korean Engineers working in Volta Batteries Factory Hattar (Haripur).
- 6. That Appellant made all enthusiastic efforts to take every step for better security arrangement of these Korean Engineers. They are permanent employees of Volta Factory Hatter since 2011. There had been many SHOs posted in P.S. Hatter in the past in 12/13 years. However so far, as appellant's responsibility is concerned, Appellant during his position as SHO P.S. Hattar frequently visited and discussed the security matter with the management of Volta Factory and issued necessary advisory instructions about security measures. Even Appellant issued written advisory letters dated 01-02-2024 and 04-04-2024 with copies to DSP (CIRCLE) Khanpur and Reader to DPO Haripur where upon the Factory Administration wrote a reply letter dated 04-04-2024 addressing the same to DPO Haripur with copy to DSP (CIRCLE) Khanpur as well. Not only that, the Appellant even got registered an FIR dated 18-04-2024 against the admin manager of Volta Factory | Hattar in this respect (Copy correspondence is attached as annexures B to E whereas Copy of FIR is attached as annexure "F").
- 7. That not to speak of Volta Factory Hattar even the Appellant was well aware of his duties and responsibilities being posted as SHO P.S. Hattar, He visited almost all the factories situated in Hattar Industrial Estate Haripur and minutely checked there all kinds of security arrangement and issued them Advisory.

Letters strictly instructing them to improve their security in all respects as was necessary. Even FIRs dated 17-04-2024 and 18-04-2024 were registered against them. (Copies of Advisory Letters and FIRs dated 17-04-2024 and 18-04-2024 are attached as annexure "G & H").

- 8. That instead of taking into consideration the Appellant's above mention efforts and appreciating and encouraging, the DPO Haripur has tried to penalize and discourage his subordinate officer, Appellant, by awarding punishment of forfeiture of two years approved service which resulted into tremendous loss to Appellant in his service career.
- 9. That the Appellant file the departmental Appeal before Worthy Regional Police Officer Hazara Abbottabad on 13-05-2024. (Copy of Appeal is attached as Annexure "I").
- 10. That the Respondent No. 1 without adopting proper procedure as laid down by law passed the impugned order dated 22-08-2024 rejecting the Appeal of the Appellant on 22-08-2024. (Copies of Impugned order is attached as Annexure "I")
- 11. That feeling aggrieved from both the orders the instant service appeal is being filed before this Hon'ble Tribunal inter alia and amongst any other on the following grounds.

GROUNDS:

1. That the impugned orders passed by the Respondents dated 16-04-2024 and 22-08-2024

being illegal, unlawful, against the law, arbitrary, fanciful, excess of jurisdiction are liable to be set aside.

- 2. That the impugned orders passed by Respondents were not passed under the law, police rule, no show cause notice was issued to Appellant, no charge sheet and statement of allegation was issued to appellant. Hence the orders passed by the Respondents being illegal, unlawful are liable to be set aside.
- 3. That no inquiry what so ever was conducted against the Appellant and similarly neither any inquiry officer was appointed nor the so called allegations were proved against the Appellant, despite these glaring irregularities, the Appellant was awarded punishment for forfeiture of two years approved service. Hence the impugned orders are liable to be set aside furthermore the stance and reason advanced by the Appellant in his departmental Appeal was also not considered thus rejected by the appellate authority without recording justified reasons. Hence both the impugned orders are liable to be set aside.
- 4. That both the impugned orders are passed on personal grudge which amounts to victimization therefore are not sustainable in the eyes of law and liable to be set aside.
- 5. That no chance of personal hearing was given to the Appellant and there is nothing on record against the appellant. It is proved that the Appellant was not engage in gross misconduct under the KPK

Efficiency and Disciplinary Rules (E&D) 1975 (Amended 2014), Hence both the impugned orders are liable to be set aside.

6. That the Service Appeal is well within time.

PRAYER: ON ACCEPTANCE OF THE INSTANT SERVICE APPEAL, AGAINST THE IMPUGNED 16/04/2024 <u>PASSED</u> DATED ORDER_ RESPONDENT NO. 2 WHEREBY THE APPLICANT WAS AWARDED PUNISHMENT OF FORFEITURE OF TWO YEARS APPROVED SERVICE; AGAINST WHICH. THE **IMPUGNED** <u>ORDER</u> 22/08/2024 WAS PASSED BY RESPONDENT NO.1 IN DEPARTMENTAL APPEAL OF THE APPELLANT WHEREBY THE APPEAL OF THE APPELLANT <u>WAS REJECTED. BOTH THE IMPUGNED ORDERS</u> MAY GRACIOUSLY BE SET ASIDE AND MAY BE UNLAWFUL, WITHOUT DECLARED ILLEGAL. 

They proceed to Islamabad from work site on daily basis in an ordinary motorcar, which is clear violation of SOP of MoI and written instructions/directions conveyed to him time and again by the undersigned.

In this regard he has been directed to avoid movement of Chinese/Foreigners without bullet/bomb proof vehicle, but he did not bother to comply the SOPs and written/verbal instructions of the undersigned. His non-serious attitude may lead towards any untoward incident. This tantamounts to gross misconduct on his part in terms of the KPK Police Efficiency & Disciplinary Rules of 1975 (amended 2014)".

With most reverence the following few lines are submitted for your kind consideration and favorable orders:-

- That appellant has rendered more than 16 year service in the police department and is presently posted as SHO Police Station Saddar Haripur. Appellant always performed his duties with devotion, dedication and honesty to the entire satisfaction of his superiors and never provided them a chance of reprimand.
- 2. That without conducting any departmental inquiry issuing a charge sheet or providing a copy of inquiry report, if any, and without serving a show cause notice the District Police Officer Haripur vide his letter OB No. 275 dated 16-04-2024 has awarded the appellant punishment of "forfeiture of 02 (two) years approved service" and that too without taking into consideration the stance and reasons advanced by

the appellant. (Copy of punishment order dated 16-04-2024 is attached as "A").

3. That the allegations as incorporated in the punishment order are incorrect, baseless and frivolous one based on conjecture, surmises and malsfide against the facts and proof.

That appellant remained posted as SHO Police Station Hattar (District Haripur) for a period of only three (03) months. During the period he carried out his duties efficiently and effectively and honestly. He left no stone unturned in discharge of his official duties.

That it is incorrect and base that appellant has ever been non-serious towards his official duties like security arrangements of 02 Korean Engineers working in Volta Batteries Factory Hattart (Haripur).

Hattar, he visited almost all the factories situated in Hattar Industrial Estate Haripur and minutely checked their all kinds of security arrangement and issued them Advisory Letters strictly instructed them to improve their security in all respects as was necessary. Even FIR were got registered against them. (Copies of Advisory Letters and FIRs are attached as "F&G").

ORDER

This order will dispose of departmental appeal under Rule 11-A of Khyber Pakhtunkawa Police Rules, 1975 submitted by SI Imtiaz Khan No. 122/H of district Haripur against the order of punishment i.e. forfeiture of two year approved service awarded by DPO, Haripur vide OB No.275 dated 16-04-2024.

"Brief facts leading to the punishment are that the appellant while posted SHO PS Hattar, it comes to the notice of DPO, Haripur through reliable information/report that 02 Koreans engineers are working in Volta Batteries Hattar. They proceed to Islamabad from work site on daily basis in an ordinary motorcar, which is a clear violation of SOPs and written instructions/directions conveyed to him time and again. In this regards he has been directed to avoid the movement of foreigners without bullet/bomb proof vehicle, but he did not bother to comply the SOPs and written/verbal instructions. His non-scrious attitude may lead toward any untoward incident."

The appellant was issued show cause notice however, he failed to advance any cogent justification in his defense. Consequently, DPO Haripur awarded him minor punishment of forfeiture of two year approved service in summary proceedings. Hence, the appellant submitted this present appeal.

After receiving his appeal, comments of DPO, Haripur was sought and examined/perused. The undersigned called the appellant in Orderly Room and heard him in person and provided him reasonable opportunity to defend the charges leveled against him. However, he failed to advance any convincing justification in his defense. Therefore, in exercise of the powers conferred upon the undersigned under Rule 11-4 (a) of Khyber Pakhtunkawa Police Rules, 1975 the instant appeal is hereby rejected/filed with immediate effect.
