PRAYER:-

ON ACCEPTANCE OF THE INSTANT SERVICE APPEAL, THE IMPUGNED OFFICE ORDER NO. SO(S/M)E&SED/5-17/2024/PT/SS; DATED 28<sup>TH</sup> JUNE 2024, MAY KINDLY BE SET ASIDE AND THE DUTIES OF THE APPELLANT MAY KINDLY BE RESTORED, AS HE WAS PERFORMING HIS DUTIES / POSTING IN GHSS BARIKOT, DISTRICT SWAT.

ANY OTHER RELIEF WHICH IS JUST AND EFFICUOUS IN FAVOUR OF THE APPELLANT MAY ALSO BE GRANTED IN FAVOUR OF APPELLANT AGAINST THE RESPONDENTS.

Respectfully Sheweth:

1. That the appellant was appointed against PTC on dated. 04/09/2006 posted in GHPS Talang, Kota, Tehsil Barikot, District Swat and the appellant then promoted to the post of SST on 08/03/2012 in GMS at Charma, Tehsil Matta District Swat. (Copy of orders are attached as Ann: A).
2. That the appellant was promoted to the post of SS on dated. 25/05/2018 at GHSS Barikot, District Swat where the appellant was serving his duties efficiently, honestly and with keep zeal and interest. (Copy of posting order is attached as Ann: B).
3. That the appellant is the permanent resident of Kota, Tehsil Barikot, Districts Swat and was serving on the said post.

4. That the respondent No. 2 unwarranted, illegal, against principles of natural justice and violative Law and rules and the mutual order passed by the mutual order of transfer of the appellant vide Endst: No. SO(S/M)E&SED/5-17/2024/PT/SS; dated 28th June. Moreover, the respondent No. 2 transfer the respondent No. 3 on the posting of the appellant illegally and unlawfully. (Copy of the order is attached as Ann: C).
5. That the appellant filed a department appeal dated: 02/07/2024 for his transfer back to the GHSS Barikot, District Swat before the respondent No. 1, and stated that the appellant do not agree with the respondents in any mutual transfer order and not submitted or signed any mutual transfer, which was uphold against the appellant by not taking any action for the same. (Copy of department appeal / application is attached as Ann: D).
6. That the appellant being aggrieved from the said impugned office order files the instant appeal inter alia on the following grounds amongst others.

GROUNDS:

- a. That the appellant has not been treated according to law.
- b. That the transfer order No. SO(S/M)E&SED/5-17/2024/PT/SS; dated 28th June 2024 is tainted with malafidy.
- c. That the order has been passed by the respondent No. 2 in political influence, the said order is mutual order. The appellant do not agree with the respondents in any mutual transfer order and not submitted or signed any mutual transfer. Moreover, it is crystal clear that the said order is special order, not passed as a general order from respondent No. 2.



- d. That the appellant is the permanent resident of the locality and it is beneficiary for the appellant to serve in the GHSS, Barikot, District Swat.
- e. That the impugned order is against principles of natural justice.
- f. That some political involvement is there behind the said order.
- g. That any other ground not specifically raised shall be argued at the time of arguments with the leave of court.

It is, therefore, humbly prayed that on acceptance of this appeal, on acceptance of the instant service appeal, the impugned office order No. so(s/m)e&sed/5-17/2024/pt/ss; dated 28th June 2024, may kindly be set aside and the duties of the appellant may kindly be restored, as he was performing his duties / posting in GHSS Barikot, District Swat. Any other relief which is just and efficuous in favour of the appellant may also be granted in favour of appellant against the respondents.

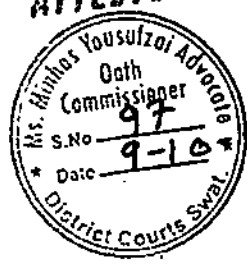


