Appeal under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974, whereby the appellant was deferred from promotion, against which the appellant filed departmental appeal vide dated 25.06.2024, which is not yet responded even after the laps of statutory period of 90 days.

Prayer in appeal:

On acceptance of this appeal the appellant may please be declared fit and eligible for promotion for the post of Superintendent of Police BPS-18, with necessary direction to promote the appellant from the date of deferment as the reasons for deferment cease to exist and the appellant may also be given due place of seniority along with his batch mates i.e. 05.09.2022 date of promotion with all consequential benefits, or any other remedy which is not specifically asked for may also be awarded in favor of the appellant.

Respectfully Submitted:

1. That initially the appellant was appointed on the post of Probationer Assistant Sub Inspector (PASI) through Public Service Commission Khyber Pakhtunkhwa Peshawar on 01.02.1995.
2. That since his appointment the appellant is performing his duties with great zeal and devotion to the entire satisfaction of his superiors without any complaint whatsoever regarding his performance till date.
↓
3. That due to his hard work and performance the appellant was promoted to the next higher scale after successfully completed/qualified his mandatory trainings.
4. That the appellant was lastly promoted to the post of Deputy Superintendent of Police (DSP BPS-17) vide order dated 07.11.2012.
5. That the appellant successfully completed the mandatory period/tenure in the rank of DSP BPS-17 and has also qualified the required Junior Command Course in the year 2017 due to which the appellant became eligible for promotion to the post of Superintendent of Police BPS-18.
6. That respondent department issued seniority list of the Deputy Superintendent of Police BPS-17 vide seniority dated 05.08.2022 in which the name of the appellant appeared at serial No 59. (*Copy of the seniority list dated 05.08.2022 is attached as annexure A*).
7. That a Departmental Selection board was held on 19.08.2022 for the promotion of DSP BPS-17 to the post of SP BPS-18, surprisingly the promotion of the appellant was deferred for the reason that
"The board deferred him from promotion to the rank of SP BPS-18 due to non-compliance of PER for the period 01.-1.2021 to 31.12.2021 and PER Quantification"
Other colleagues of the appellant was promoted to the post of SP BPS-18 vide order dated 05.09.2022.
(*Copy of the minutes of DSB held on 19.08.2022 and promotion order dated 05.09.2022 is attached as annexure B & C*).
8. That another Departmental Selection board was held on 17.10.2023 for the promotion of DSP BPS-17 to the post of SP

8. That another Departmental Selection board was held on 17.10.2023 for the promotion of DSP BPS-17 to the post of SP BPS-18, but astonishingly the promotion case of the appellant was again deferred for the reason that

"The board examined the case and deferred him for promotion to the rank of SP BPS-18 because he does not fulfill the prescribed criteria for promotion to the rank of SP as per rules/policy.

(Copy of the minutes of DSB held on 17.10.2023 is attached as annexure D).

9. That again the case of the appellant was deferred and junior colleagues of the appellant were promoted to the post of Superintendent of Police (SP BPs-18) vide promotion order dated 20.12.2023. *(Copy of the promotion order dated 20.12.2023 is attached as annexure E).*
10. That due to which the case of the appellant was deferred that remarks were expunge by the Chief Secretary Khyber Pakhtunkhwa under the Paragraph 6.6 of instruction on performance Evaluation Report 2006. *(Copy of the notification dated 07.06.2024 F).*
11. That the appellant filed departmental appeal vide dated 25.06.2024, before the competent authority which is not yet responded even after the laps of statutory period of 90days. *(Copy of the departmental appeal is attached as annexure G)*
12. That the appellant filed this service appeal on the following grounds inter alia:-

GROUNDS OF SERVICE APPEAL:

- A. That the appellant has not been treated in accordance with law and hence his rights secured and guaranteed under law and constitution are badly violated.
- B. That the appellant since his appointment as PASI in police department is performing his duties with great zeal and devotion and to the entire satisfaction of his superiors without any complaint whatsoever regarding His performance till date.
- C. That junior colleagues of the appellant were promoted to the post of Superintendent of Police (SP BPS-18) but the present

appellant was deferred twice which is illegal, unlawful and against the rules and policy.

- D. That the appellant was deferred on pretext on proforma of quantification as due to the adverse remarks in the annual PER, which was later on the appeal of the appellant expunged by the competent authority i.e chief secretary kpk.
- E. That according to the promotion policy, Deferment of Promotion, the civil Servant whose promotion has been deferred will be considered for promotion as soon as the reasons for deferment cease to exist, and the civil servant will be considered for promotion after determining his correct seniority over the erstwhile juniors.
- F. That the whole service career of the appellant has been put at stake as the long earned seniority maturing his right of promotion to the next scale has been blocked and was retired from service, requiring to consider him for promotion.
- G. That the conduct and attitude of the respondents as well as not promoting the petitioner despite of availability of post and senior most with good record and fulfilling all the required eligibility criteria, is against the spirit of Article 2-A, 4, 9 and 25 of the Constitution.
- H. That the state is bound to ensure the elimination of all forms of exploitation and the gradual fulfillment of the fundamental principles. It is also the duties of the state to remove disparity in the income and earning of individuals under Article 37 & 38 of the Constitution.
- I. That the Hon' able Supreme Court of Pakistan in case reported as 2010-SCMR-1301, has held that in matter of promotion, rules are to be followed and where the discretion of authority is involved, then that must be exercised with fairness. It is further pointed out in the said judgment that the Constitution is the supreme law and there is no room to allow the authority to make departure from law, rules and Article 4 and 25 of the constitution.
- J. That the august Supreme Court of Pakistan in case reported as 2013 §CMR 1752 (g) has held that the term "life" also includes reputation, status and all other ancillary privileges conferred on a citizen by law. Thus the decision of not promoting the petitioner without any just and fair reasons is violative to the Article 9 of the Constitution of Pakistan because the same affected the status and reputation of petitioner amongst the batch mates and other service fellows


K. That the appellant has not been treated as per notified gazetted rules by the respondents which deprived the appellant from his due right of seniority, promotion.

It is, therefore, humbly prayed that On acceptance of this appeal the appellant may please be declared fit and eligible for promotion for the post of Superintendent of Police BPS-18, with necessary direction to promote the appellant from the date of deferment as the reasons for deferment cease to exist and the appellant may also be given due place of seniority along with his batch mates i.e. 05.09.2022 date of promotion with all consequential benefits, or any other remedy which is not specifically asked for may also be awarded in favor of the appellant.

MINUTES OF DEPARTMENTAL SELECTION BOARD MEETING HELD ON 19.08.2022

Meeting of the Departmental Selection Board was held on 19.08.2022 at 15:00 hours in Conference Room-I at CPO under the Chairmanship of Mr. Munzamin Jaf Ansari, PSP (QPM, UNPM, NSWC) Provincial Police Officer, Khyber Pakhtunkhwa to discuss the cases of DSsP (BS-17) (Executive, Legal and Tele) for promotion to the rank of SsP (BS-18) on Regular Basis.

2. The following Officers attended the meeting:-

3. The meeting started with recitation from the Holy Quran. The AIG/Establishment apprised the Board that as per 40% quota of Provincial Police Officers in Grade 18 & above of senior Cadre, (46+) vacant posts of Ss.P (Provincial BS-18) existed which were required to be filled through promotion from amongst senior DSsP in the prescribed manner provided that 01 vacancy is reserved for SP/Tele.

4. The above 46 (forty six) vacancies will be filled by promotion from amongst 42-DSsP Executive and 04-Legal as per 9:1 ratio quota fixed vide Government of Khyber Pakhtunkhwa Notification No.SO (Police)3-8/2002, dated 13.10.2003.

5. The Board was apprised (briefed) about the promotion criteria required to be examined for promotion of DSsP BPS-17 to the rank of SsP (BPS-18), i.e. the North-West Frontier Province (Promotion of Superintendent of Police and Deputy Superintendent of Police) Rules 2007, amended Police Rules 19.48/2017 and Khyber Pakhtunkhwa Civil Servants Promotion Policy 2009.

6. The Secretary of the Board appraised the Committee of two Court cases regarding Out of Turn promotion and absorption of Police Officers/Officials:-

- i. The Honorable Supreme Court of Pakistan vide judgments SCMR2013-1752 and SCMR2017-206 titled Shahid Pervez VS Ijaz Ahmad and others, Intra Court appeal 2017/2018 dated 13.05.2018 and in Civil Petition No. 1996, 2026, 2431, 2437 to 2450, 2501 and 2502 of 2019 dated 20.06.2020 declared all the out of turn promotion including gallantry, incentive under Validation Act or Rules ab-initio void & null, unconstitutional, un-Islamic. The Board unanimously agreed that those DSsP who are declared under the category of "Out of Turn Promotion" as per reports of their concerned RPOs/CCP, will not be considered for promotion to the next higher rank until the decision of Provincial Cabinet Ministerial Sub-Committee and Supreme Court directions.

ii. Similarly, the Board unanimously agreed to not consider the cases of those DSSPs who are absorbed in Khyber Pakhtunkhwa Police from other Province units as per Criminal Review Petition No. 207/2016, Criminal Original Petition No. 627/2016, Criminal Original Petition No. 22/2017 and Criminal Original Petition No. 697/2017 in Criminal Original Petition No. 89 of 2011. The Honorable Supreme Court vide judgment in Criminal Review Petition No. 193/2013 reported in (SCMR 2015-156) declared that neither a person can be absorbed nor a civil servant or non civil servant or deputation could be allowed to travel horizontally outside his cadre to penetrate into a different cadre, service or post through an appointment by transfer.

A panel of senior DSSPs BS-17 (Executive and Legal) was put before the Departmental Selection Board (DSB) for consideration.

8. The Board thoroughly examined the cases and record of each officer in light of the promotion Rules & laid down criteria. After thorough discussions, the following recommendations as noted against each were made:-

Respected Sir,

I, the petitioner submit the following for kind perusal and consideration on the below mentioned facts and grounds.

FACTS:

- i. That the petitioner joined Khyber Pakhtunkhwa Police as Probationer Assistant Sub Inspector on 1st February 1995.
- ii. That the petitioner successfully qualified all mandatory courses, trainings provided under the Police Rules Chapter 13 and relevant standing orders, earned required Performance Evaluation Reports and promoted to the next senior ranks, lastly to the rank of DSP (BPS-17) on 07th November 2012.
- iii. That the petitioner successfully completed the mandatory period/tenure in the rank of DSP (BPS-17), qualified the requisite Junior Command Course in the year 2017 and thus became eligible for promotion to the rank of Superintendent of Police (BPS-18) with his batch mates under the relevant rules and policy in vogue.
- iv. That pursuant to the relevant rules, policy and to fill the vacancies in the rank SP-BPS-18, on 19-08-2022, Departmental Selection Board (DSB) meeting was held in CPO to recommend/consider eligible officers for promotion to the rank of SP (BPS-18).
- v. That as per seniority lists of DSsP (BPS-17), Junior Officers from the petitioner were recommended and notified for promotion to the rank of SsP (BPS-18), while the petitioner was not consider/recommended for the grounds mentioned in the minutes of the DSB meeting. The relevant decision of PSB is as under:

"The board deferred him from promotion to the rank of SP (BPS-18) due to non-compliance of PER for the period 01-01-2021 to 31-12-2021 and PER quantification"

(Copy of notification is Annexure A)

- vi. That on 17-10-2023, another meeting of DSB was held and the petitioner was again not recommended for promotion in the rank of SP (BPS-18). The relevant para of DSB decision is reproduced as:-

"His PERs quantifications is 48 while minimum required score is 50."

The board examined his case and deferred him for promotion to the rank of SP (BPS-18), hence does not fulfill the prescribed criteria for promotion to the rank of SP as per rules/policy"

- vii. That the petitioner is deprived from his legal and fundamental right on the reasons/grounds purely related to the department and beyond the competency/control of the petitioner. Hence, the petitioner being aggrieved from decision of the DSB, submits representation on the following grounds.

GROUND:


- a. That the decision of DSB vide its minutes dated 19-08-2022 & 17-10-2023 regarding deferment from promotion to the rank of SP (BPS-18), on the reasons of non-completion of PER for the period 01-01-2021 to 31-12-2021 and PER quantification is against the norms of rules and PER instructions/guidelines and violation of the fundamental/legal rights of the petitioner.
- b. That as per rules, completion of PER is sole responsibility of the offices of reporting officer/dealing hand and submission to concerned quarter on 15th of January, but they violated the rules/instructions of PER rules and due to this the petitioner career is damaged badly.
- c. That the petitioner can not be deprived from his fundamental/legal rights due to non-submission of PER within prescribed time. It is pertinent to mention that PER for the period 29-03-2021 was missing while in minutes of the board meeting period 01-01-2021 to 31-12-2021 was wrongly mentioned.
- d. That it is very amazing/unfortunate that after a lapse of two years the petitioner received adverse remarks of missing PER and other period vide RPO Kohat letter No. 15012/PA, dated 15-12-2023 (copy Annexure C).
- e. That feeling aggrieved the petitioner filed a representation before the Honorable Chief Secretary, Khyber Pakhtunkhwa against the impugned adverse remarks, the Chief Secretary is pleased to Expunged the adverse remarks vide notification No. SOS/1-15/PER/Salah-ud-Din/Provincial Police/BS-17/2024, dated 07-06-2024 (copy Annexure D).
