
1. Whereas, Mr. Saleem Khan, son of Noor Ali Lab Attendant at GHS Musa Kor Ambar District Mohmand was inducted against the Lab Attendant post in BPS- 2 vide order dated 25/02/2005 & upgraded to BPS-4 under the Upgradation Policy of the Provincial Government of Khyber Pakhtunkhwa with his adjustment at GHSS Ghallanai District Mohmand against the said post by the then competent authority
2. And whereas, as per mandatory provision of Section-8 of Civil Servant Act 1973 read with Rule – 17 of APT Rules, 1989, final seniority list was prepared and notified by the Respondent Department wherein, the appellant has been placed at Serial No. 148 in view of his service record in possession of the Respondent Department.
3. And whereas, the appellant has invoked the constitutional jurisdiction of the Honorable Khyber Pakhtunkhwa Service Tribunal under Section-4 of Khyber Pakhtunkhwa Service Tribunal Act 1974 read with Article 212 of the Constitution of 1973 in Service Appeal No. 407/2017 under Case Titled Saleem Khan Vs Govt of Khyber Pakhtunkhwa & others with the prayer for his promotion to the post Junior Clerk in BPS-11 under the reserved quota of 33% quota for promotion from the Class IVs/ Lab Attendant posts to the Junior Clerk post.
4. And whereas, the Respondent Department was put on Notice for submission of reply which was submitted accordingly by contesting the titled case & was finally decided vide order dated 18/10/2022 by the Honorable Service Tribunal with the direction to the Respondent Department that "Respondent shall consider the appellant for promotion to the concerned post in the forthcoming DPC in accordance with relevant Rules & Law." Wherein, the appellant has also filed an execution petition No. 45/ 2023 out of 407/ 2017 for implementation of the cited order which is still pending adjudication before the Honorable Service Tribunal.
5. And whereas, in compliance of the order dated 18/10/2022 of Honorable Service Tribunal in the titled appeal, a committee was constituted by the Respondent Department vide order dated 15/11/2023 for considering the case of the appellant for his promotion to the post of Junior Clerk in BPS-11 under the Policy by recording formal minutes of the DPC meeting held on 16/11/2023 in the office of the undersigned wherein, it was observed that there were total 30 sanctioned posts of Junior Clerks wherein, 12 posts are lying vacant with a share for promotion under 33% reserved quota is 10 where upon, 04 Class-IV/ Lab Attendant have been promoted and 06 posts of Junior Clerks are lying vacant for promotion of Class-IV/ Lab Attendant under the above cited quota for promotion of the said cadre in the Department.
6. And whereas, the committee, after, threadbare discussion by considering the relevant record, Law and Rules in vogue has finally concluded that the appellant is not entitled for the grant of promotion to the post of Junior Clerk in BPS-11 under the Rules and Policy in field in view of the reserved quota ibid by rejecting the candidature for promotion of the appellant against the Junior Clerk in BPS-11 post on the material ground of his low seniority position of 148 in the Final Seniority List of the Class-IV/Lab Attendants stood on 27/04/2023 by the committee
7. And whereas, in compliance of the order dated 18/10/2022 of the Honorable Service Tribunal rendered in the titled appeal, perusal of the relevant Law, Rules, Record and Policy in vogue and recommendations of the DPC meeting held on 16/11/2023, the undersigned in the capacity of being a competent authority in the titled case is pleased to reject the plea/ of the appellant regarding his promotion to the post of Junior Clerk BPS-11 on the ground of his low seniority position of 148 in the Final Seniority List as stood on 27/04/2023 in the interest of public service vide this office No 10176-83 dated 16/11/2023 & placed the same along with minutes of the DPC meeting before the honourable Tribunal on 27/11/2023 & the order sheet reproduced as "Representative of the respondents produced copy of minutes of DPC held on 16.11.2023"

according to which the petitioner did not fulfil the criteria for promotion to the post of J/C

8. And whereas, the case was heard in the court of Honourable Member Service Tribunal, Mr Salah Uddin on 22/2/2024 but on the objection of the counsel for the appellant, the case was sent to the honourable Chairman Service Tribunal on the same day. The Honourable Chairman ordered the u/signed to implement the judgement dated 18/10/2022 without providing any opportunity of hearing which is against the very soul of Article 10 A of the Constitution of Pakistan. Again, the u/signed was called telephonically to appear in his court on 23/2/2024. The u/signed appeared before the honourable Chairman on 23/2/2024 and he ordered to implement the judgement on old seniority list within fifteen days. The Director, Addl: Director & Deputy Director legal were also present in the Tribunal on 23/2/2024.
9. And whereas, in compliance of the order of the honourable chairman Tribunal on 22/2/2024 & 23/2/2024 to consider the appellant on combine (Male/Female) old seniority list of just 18 officials before bifurcation, the u/signed called DPC meeting at Directorate after consultation with the Addl: Director in his office on 23/2/2024 and letters were written to the Director E&SE KP Peshawar regarding DPC meeting scheduled to be held at Directorate on 1/3/2024 at 10 am and Mr. Saleem Khan Lab Attendant GHS Musa Kor regarding provision of his original documents along with service book up to 28/2/2024.
10. And whereas, the appellant failed to provide his original documents & service book till date. It is also pertinent to mention here that the appellant also refused to hand over his documents to the then committee of 2013 chaired by Mr. Sardar Hussain, presently serving as Principal GHS Ekka Ghund who handed over an attested document to this office on 29/2/2024 reflecting his refusal of provision of his documents, CNIC, Service book and taking typing test.
11. And whereas, an office copy of his Matric DMC which reflected that he got 325 out of 850 in his matric from BISE Peshawar in 3rd Division under Roll No 68642 in Session 1996 which was also commented in the Respondents Para wise reply No 3 of the facts submitted to the honourable Khyber Pakhtunkhwa Service Tribunal was owned by him and attested by the i/c HM of GHS Musa kor on 28/2/2024.
12. And whereas, the DPC committee meeting held on 1/3/2024 at Directorate of E&SE KP Peshawar, after examining his case, unanimously decided that Mr. Saleem Khan, the appellant filed his service appeal in the Khyber Pakhtunkhwa Service Tribunal vide Diary No 417 dated 25/4/2017 for promotion from class IV to Junior clerk in spite of the fact that he was not eligible for promotion from Class IV to Junior clerk as he had got 325/850 marks in the Matric from BISE Peshawar in 3rd Division, as per notification vide Govt. of Khyber Pakhtunkhwa Elementary & Secondary Department No. SO (PE)/4-10/SSRC/Ministerial Staff/2013 dated 28/1/2013. So his appeal may be regretted as he had no locus standi.

Now therefore, in compliance of the judgement dated 18/10/2022 of the Honorable Service Tribunal rendered in the titled appeal, perusal of the relevant Law, Rules, Record and Policy in vogue and recommendations of the DPC meeting held on 1/3/2024, the undersigned in the capacity of being a competent authority in the titled case is pleased to reject the plea/ of the appellant regarding his promotion to the post of Junior Clerk BPS-11 on the ground of his 3rd Division in SSC i.e. he got 325/850 marks with immediate effect and in the interest of public service.
