1. That the Appellant is not an aggrieved person within the meaning of Section 4 of the service tribunal Act, 1974.
2. That the Appellant has no cause of action / locus standi.
3. That the Appellant has not come to this honorable court with clean hands.
4. That the Appellant has filed this instant Service Appeal just to pressurize the respondents.
5. The present Service Appeal is liable to be dismissed for non-joinder/mis joinder of necessary parties.
6. That the instant Service Appeal is against the prevailing law and rules.
7. That the Appellant has filed this instant Service Appeal on malafide motives.
8. That the instant Appeal is **barred by law**.
9. That the instant Service Appeal is not maintainable in the present form, and above in the present circumstances of the issue.
10. That the Appellant has estopped by his own conduct by not joining his duty back after expiry of earned leave.
11. That the Appellant has concealed the material facts from this Honorable Tribunal.

FACTS

1. Pertains to personal record.

4. Correct to the extent of Submission application about the missing of service book, however it is worth to note the applicant is trying to divert

the attention of this Honorable Tribunal to an irrelevant issue which has no concern with the prayer of the instant Service Appeal. The Appellant has not been removed from Service on the basis of missing Service Book. He has been removed from service on the basis of absenteeism. Another very important point is that the Appellant stated that he has submitted application dated 18-12-2023 but on the other hand as per Travel History, the Appellant was not even in the country and was abroad in United Kingdom on that very date.

5. Correct.
6. Incorrect and denied. As stated in the foregoing Paras, the Appellant has not been removed from service on the basis of Service Book missing. He has been removed on the basis absenteeism as clear from the removal order annexed by the Appellant with the instant Service Appeal.
7. Incorrect and denied. The Appellant has not been removed on the basis of three days absenteeism. The Appellant has concealed material facts from this Honorable Tribunal. In fact, the Appellant was on earned leave w.e.f. 20-9-2023 to 18-12-2023 (90 days). After the expiry of leave, he should have reported back to him duty on 19-12-2023 but, he failed to do so. The Headmaster of the school submitted non arrival certificate dated 27-12-2023 wherein he stated that the Appellant has not joined his duty till date. These after a call notice dated 30-12-2023 was issued to him on his home address wherein he was directed to resume his duty within 15 days otherwise he will be dealt as per E&D rules 2011. But the Appellant did not resume his duty. Thus, a final notice mandatory under E&D rules, 2011 was published in two new papers i.e "the Dially Mashriq" and "Daily Chand" dated: 31-01-2024 wherein he was directed to resume his duty within 15 days but he still did not resume his duty. Thus he was removed from service vide order dated 15-02-2024. **(Headmaster report, call notice, Publications annexed as annexure A, B & C)**
8. Incorrect and denied. The Appellant is not punctual teacher. Travel History shows that he has gone abroad time and again. The present removal from service is also on the basis of absenteeism as stated in the foregoing paras.
9. Incorrect and denied. His application has not been converted from the mentioned dates (I,e 01-09-2023 to 31-08-2025) (730 days) to (20-09-2023 to 18-12-2023) (90 days). In fact, the Appellant submitted an application dated 21-09-2023 along with affidavit dated 07-09-2023 for three months leave for the purpose of construction of his house. He even submitted a sworn affidavit to the effect that he will not leave the country and will not go abroad. **(Application & Affidavit annexed as annexure D & E)**
10. Incorrect denied. The Appellant has received his service book himself and has properly signed in the relevant register dated 08.10.2022. **(Pages of relevant register annexed as annexure F)**

11. Correct to the extent of enquiry reports, the rest of the Para is incorrect and denied. It is further clarified that though the present issue has no concern with missing of Service Book, however the enquiry officer declared that the Appellant is still absent from duty and that he has received his Service Book from office of respondent No. 02.
12. Correct to the extent of submission of departmental appeal, however, it is worth to mention here that the office of respondent No.2 was asked by respondent No.1 for submission of detailed report. Before submission of report, the respondent No.2 sought Travel History in respect of the Appellant from director FIA Islamabad. According to the Travel History, the Appellant was in United Kingdom w.e.f 27-09-2023 to 01-03-2024 and even went again abroad on 14-03-2024. The Appellant on one hand submitted application for three months leave and also submitted sworn affidavit that he will not leave the country and on the other hand, he went abroad without taking any sanctioned leave Ex-Pakistan. The Appellant should have taken leave Ex-Pakistan when he was going abroad. It means that the Appellant has concealed his actual status from the respondent department as well as this Honorable Tribunal. His earned leave was sanctioned up to 18-12-2023 but he returned to Pakistan on 01-03-2024. It is also worth to note that even the Appellant went abroad in different intervals earlier without taking any leave Ex-Pakistan. Thus the appeal of the Appellant being devoid of any merit was not accepted. (Travel History annexed as annexure G)

Thus, the instant Service Appeal is bereft of any merit, hence, liable to be dismissed inter-alia following grounds.


GROUNDS


1. Incorrect and denied. The Appellant has rightly been removed from service.
2. Incorrect and denied. The Appellant is estopped by his own conduct by not joining his duty back.
3. Incorrect and denied. The detail reply has already been given in the foregoing paras.
4. Incorrect and denied. The removal from service order is in accordance with E&D rules, 2011.
5. The Appellant did not respond to the call notices and publications, therefore, as per rule (9) of E&D rules, 2011, major penalty of removal from service was imposed upon him, which is correct and in accordance with the rules.
6. Incorrect and denied. The detail reply has already been given in the foregoing paras.
7. Incorrect and denied. Respondent NO. 02 being the competent authority has issued the removal order.

8. Repetition of the above paras, hence no comments.
9. Repetition of the above paras, hence no comments.
10. Irrelevant, hence no comments.
11. Incorrect and denied. Procedure in case of willful absence is crystal clear as per rule (9) of E&D rules, 2011.
12. Repetition of the above paras, hence no comments.
13. Irrelevant, hence no comments.
14. That the respondents also seek permission to raise further ground be at the time of the arguments.

It is, therefore, very humbly prayed that the instant Service Appeal of the Appellant may be dismissed with cost in favor of the respondents.

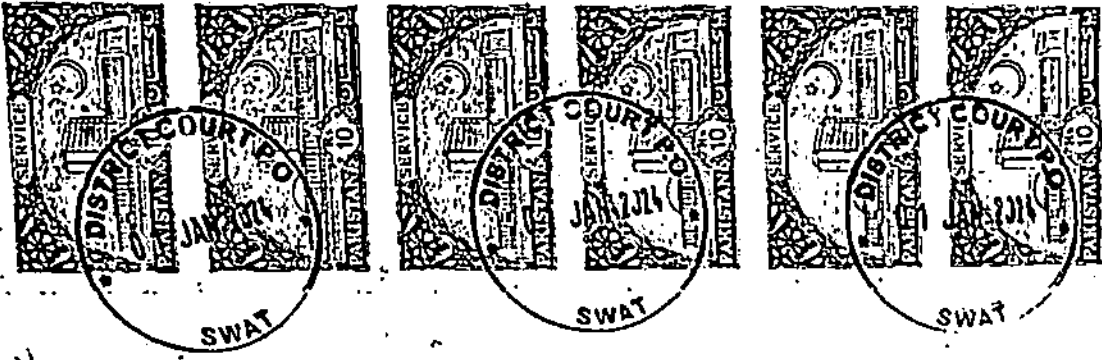

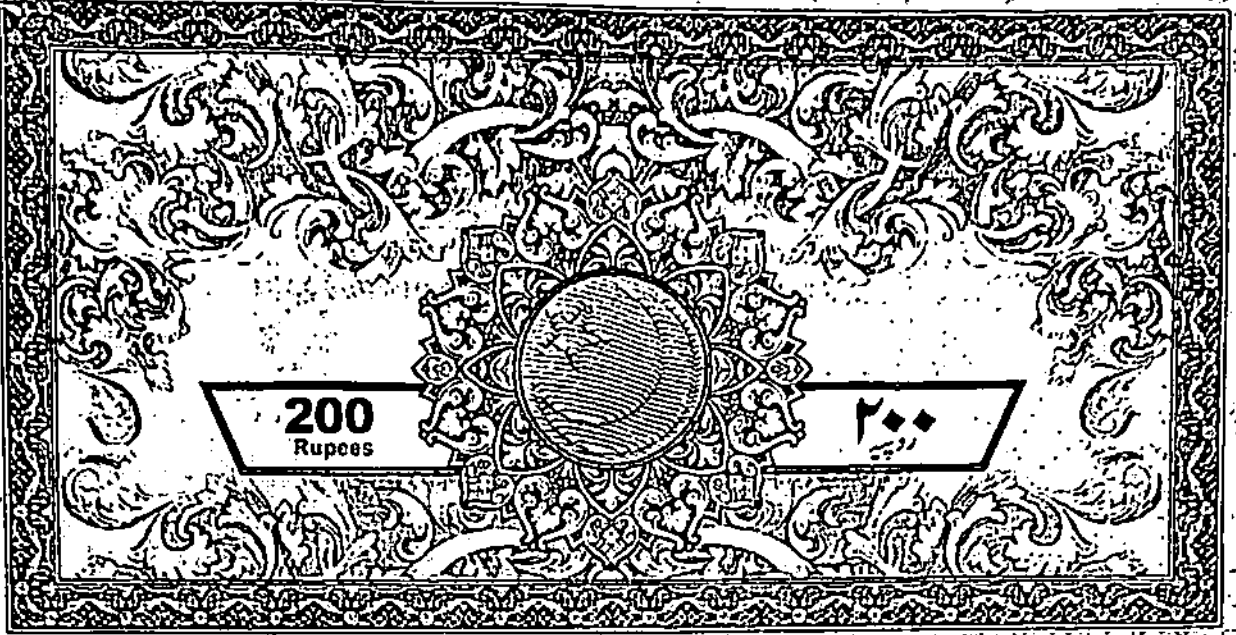
