PARA-WISE COMMENTS ON BEHALF OF THE RESPONDENTS.

PRELIMINARY OBJECTIONS:

CONTROVERSY:

From the very first days of his first appoitnment Mr. Mujeeb ur Rahman (Ex-Lab Attendant) has remained absent from duty frequently on one pretext or other. In addition to minor penalties, under the Section 4 (b)-iii of KP E&D Rules 2011, he was removed from service by the competent authority on dated 19-09-2018. The appellant challenged his removal from service through S.A No. 403/2019, decided on 25-03-2022; wherein the appeal was partially accepted and the case was remitted to the department for De Novo inquiry. In compliance of the judgement of the Honorable Service Tribunal the appellant was reinstated on 01-07-2022 for the purpose of de novo inquiry. After conducting the said de novo inquiry under Khyber Pakhtunkhwa E&D rules, the competent authority imposed upon him the major penalty of "Removal from Service" vide Endst No. 8457-63 dated Swabi the 23-09-2022.

- 1. That the serivce appeal is in violation of rule 23 of the Khyber Pakhtunkhwa Service Tribunal Act 1974.
- 2. That the service appeal is badly barred by time, hence not maintainable.

- 3. That the service appeal is wrong, baseless and not maintainable, it shows no strong cause to be taken for adjudication; therefore, the same service appeal is liable to be rejected/ dismissed.
- 4. That the service appeal is unjustifiable, baseless, false, frivolous and vexatious. Hence the same is liable to be dismissed with the order of special compensatory cost in favor of respondents.
- 5. That the appellant has not come to the Court/Tribunal with clean hands.
- 6. That the appellant has concealed the material facts from this Honorable Tribunal.
- 7. That the appeal is bad for misjoinder and non-joinder of the necessary party.
- 8. That the appellant has filed the instant appeal just to pressurize the respondents.
- 9. That the appellant has no cause of action to file the instant appeal.
- 10. That the appeal is not maintainable in the eye of law.
- 11. That the instant appeal is not maintainable in the present form and also in the present circumstances of the issue.
- 12. That the appellant has no locus standi to file appeal against the respondents.

FACTS:

- 1. Incorrect, hence denied. The appellant was appointed Lab Attendant at GHS Gulshan Abad Maneri Swabi on contract basis on 07-10-2006. But from the very first day of his appointment the appellant has been absent from duty frequently on one pretext or other, and thus was transferred from one station to another on administrative grounds. The appellant also did not comply with the orders of the DEO (M) Swabi to join his duty at GHSS Dobian that were issued in light of the judgement of the Honorable Peshawar High Court in WP No.2081-P/2018 (filed by the present appellant).
- 2. Incorrect, hence denied. In light of the judgement of the Honorable Peshawar High Court in WP No.2081-P/ 2018 filed by the appellant and as per his own request, the competent authority posted the appellant against his original cadre post i.e Lab Attendant at GHSS Dobian, but he did not comply with the orders and absented himself from duty.
- That in light of the judgement of the Honorable Service Tribunal in SA No. 403/2019, decided 25-03-2022 filed by the appellant, the DEO (M) Swabi re-instated the appellant into service for the purpose of de novo inquiry vide Endst No. 6213-16/ Dated Swabi the 01/07/2022.
- 4. That judgement of the Honorable Service Tribunal in SA No. 403/2019, decided 25-03-2022 has been implemented in true letter

and spirit by the DEO (M) Swabi by re-instating the appellant into service for the purpose of de novo inquiry vide Endst No. 6213-16/Dated Swabi the 01/07/2022.

- 5. Incorrect, hence denied. That the appellant is misguiding the Honorable Service Tribunal, because the DEO (M) Swabi (a) reinstated the appellant for the purpose of de novo inquiry; (Annex-A) (b) constituted Inquiry Committee (Annex-B); (C) issued show cause notice to the appellant for being absent (Annex-C); (d) properly charged the appellant with charge sheet (Annex-D); (e) proceeded against the appellant as per KP E&D Rules, 2011 by presenting statement of allegations to him (Annex-E); (f) Personally heard the appellant (Annex-F); and finally (g) removed him from service under Section 4 (1)(b) (iii) of the Khyber Pakhtunkhwa E&D Rules, 2011 (Annex-G). Besides, the appellant disobediently did not cooperate with the inquiry commission duly constituted by the DEO (M) Swabi in compliance with the orders of the Honourable Service Tribunal for the purpose of de novo inquiry. He even did not bother to answer within the specified time the questionnaire handed to him by the inquiry commission on dated 15-07-2022, and thus defaulted himself. The inquiry commission concluded that the appellant was illdisciplined and dis-interested in govt. service; hence, recommended the major penalty of removal from service under KP E&D Rules, 2011. Also, the appellant appeared before the DEO (M) Swabi for Personal Hearing on dated 16-9-2022 but failed to defend his case.
- 6. Incorrect, hence denied. In light of the judgement of the Honorable Peshawar High Court in WP No.2081-P/ 2018 filed by the appellant and as per his own request, the DEO (M) Swabi posted the appellant against his original cadre post i.e. Lab Attendant at GHSS Dobian but the appellant in defiance floated the orders of both the DEO (M) Swabi and the Honorable Peshawar High Court and did not join and wilfully absented himself from duty. The question of COC becomes irrelevant when the judgement of PHC has been implemented by the respondents.
- 7. That the appellant has no reasons/ grounds to file the instant service appeal, and that the service appeal is liable to be dismissed in favor of the respondents on the following grounds.

GROUNDS:

A. Incorrect, hence denied. The said order is legal, not void and is with lawful authority and tenable before the eyes of law.

- B. Incorrect, hence denied. The said order is not against any law and principles of natural justice. The appellant has been provided with several opportunities to defend himself, but he has badly failed in defending himself. Several warnings (verbal and written), show cause notices and notices in daily newspapers have been published to give him opportunity to defend himself but he failed. All the proceedings against him are according the rules and procedure in the field.
- C. Incorrect, hence denied. The DEO (M) Swabi formally constituted an inquiry commission dated 01-07-2022, which submitted its report on dated 11-08-2022 and recommended removal from service of the appellant (Annex- H). The appellant was poperly informed about the said de novo inquiry. He knew all about the inquiry and did appear before the inquiry commission on dated 15-07-2022 where he was given a questionnaire, which he, however, never returned (Annex-I).
- D. Incorrect, hence denied. The appellant was charged with minor penalties of transfer on administrative grounds and stoppage of two annual increments after following all the procedures as laid down in KP E&D Rules, 2011. As far the question of removal from service, the removal has been the result of a lengthy and lawful procedure under Section 4 (1)(b) (iii) of the Khyber Pakhtunkhwa E&D Rules, 2011. This is not a case of double jeopardi altogether.
- E. Incorrect, hence denied. As regards the allegations of marking false attendance, during the de novo inquiry the appellant was provided with a golden opportunity to prove his innocence, but he badly failed. The allegations have been proved to be correct.
- F. Incorrect, hence denied. In compliance of the orders of the Honorable Service Tribunal, the DEO (M) Swabi re-instated the appellant and formally constituted an inquiry commission dated 01-07-2022, and the appellant was poperly informed about the said de novo inquiry. He knew all the facts about the inquiry and did appear before the inquiry commission on dated 15-07-2022 where he was given a questionnaire, which he, however, never returned. The appellant has committed a serious breach of law by submitting false statement and misguding the Honorable Service Tribunal.

G. That the said impugned order is not illegal, void and without lawful authority. It is not violation of the principles of natural justice but is in accondance with law and rules of the Khyber Pakhtunkhwa E&D Rule, 2011.

Therefore, in view of the above made submissions, it is earnestly prayed that on acceptance of the instance reply to the titled sevice appeal, the appeal in hand may very graciously be dismissed by maintaining the order dated 23-09-2022 in favour of the Respondent Department in the interest of justice.

WHEREAS, disciplinary proceedings were initiated against Mr. Mujeeb ur Rahman, Lab Attendant Govt. Higher Secondary School Dobian, Swabi, under the Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011. The accused was served with charge sheet and statement of allegations.

AND WHEREAS, an enquiry committee, conducted the enquiry as per rules and submitted his report, thereafter the accused was served with final show cause notice and after receiving no reply to the same, the accused also opted for personal hearing. Accordingly he was personally heard on 16/09/2022, wherein he badly failed to defend his case.

findings going through WHEREAS after recommendations of the enquiry committee, materials on record, status of reply to the show cause and subsequent personal hearing, the accused found guilty of misconduct.

ENQUIRY REPORT

On

"Mr. Mujeeb ur Rahman Ex-Lab Attendant removal from service by the Competent authority and in service appeal No 403/2019 as it has been partially accepted that the appellant may be given appropriate opportunity of defense as required under KPK Govt Servant E&D rules 2011 While imposing major penalty i.e. removal from service."

Reference DEO (M) Swabi No 6213-16 Dated Swabi the 01/07/2022, a committee has been constituted on the above titled subject to enquire and probe the habitual absenteeism of Mr. Mujeeb ur Rahman S/O Nowsherwan Ex-Lab Attendant GHSS Doblan to submit report with clear cut recommendations,

Problem Preview:

Mr.Mujeeb Ur Rehman Ex-Lab Attendant remained absent from duty frequently on one pretext or the other during his service tenure. Enquiries have been conducted against him from time to time with minor penalties have been imposed on him under E&D rules ,2011 as necessary by the time.

Lastly, an enquiry dated 01/8/018 was conducted against him recommending his removal from service if he cannot defend himself in personal hearing.

The competent authority vide Endstt No. 8262-68/Absence/Removal from service /F.No.4187 dated Swabi the .19 /9/2018, the above mentioned lab Attendant was removed from service under Rule 4 (b)-III E&D rules ,2011

The employee challenged his removal through service appeal 403/2019 decided on 25-3-2022.

Wherein the appeal was partially accepted and the case was remitted to the department for De Novo enquiry as the appellant was not given appropriate opportunity of defense as is required under KPK Govt Servants (E&D) rules, 2011 while imposing

Major Penalty i.e., removal from service by the Competent authority. Consequently, this enquiry has been ordered to dig out facts.

The above said Lab Attendant was informed properly to appear before the enquiry committee to defend himself. Record perused and facts were recorded.

FACTS:

1. Mr. Mujeeb Ur Rahman Ex-Lab Attendant was appointed as lab Attendant at GHS Gulshan. Abad Maneri Payan (swabi) on Contract salary basis on 07-10-2006:He was transferred to E.D.O office. Due to un availability vacant post there, he was adjusted against Chawkidar post temporary on 01/10/2009, he was adjusted as Chowkidar at GHSS Mansabdar (Swabi) Due to un-availability of Chowkidar post there his ill-disciplined attitude and absence from duty, on the basis of enquiry, he was transferred again on administrative grounds.

2. Due to absence from duty, another enquiry was conducted consequent upon which his 215 days absence period was converted into leave pay, stoppage of 02 annual increments and transfer to any other school.

3. He was transferred to GPS Rafique Abad (Swabi) on disciplinary grounds on 31/5/2016 but could not perform duty there as usual. He pretended that his actual post lab attendant but he had been posted against Chowkidr post.

4: He filed W.P 2081-p/2018 in PHC Peshawar. During the course of time, he was transferred to GHSS Doblan (Swabi) against his original post of lab attendant vide Endstt: No12623-G/F.CIV/apptt:Dated swabi the 7/12/2007 as a redressal of his grievance but he failed to comply on the basis of this grievance redressal, he withdrew his W.P. on 10-7-2018.

5. An enquiry dated 01/8/2018 was conducted the recommendation of which was the person under enquiry (Mujeeb Ur Rahman) Seems extremely irrerponsible and not fit for govt job. He may be called for personal hearing by the DEO (M) Swabi and proceeded upon major penalty of removal from service if he cannot defend himself.

6. He was issued two absence notices in public dailies

A), In daily Mashriq Dated June 28,2018 and

B). In daily Express Dated 26 June,018 at S.No I.

 Vide Endstt .No 678/A Dated 13-12-017 absence notice was issued to attend the School positively.

Despite of all remedial actions taken in his favour, he failed to report for duty due un Known Reasons.

8. After fulfilling all the codal formalities under E&D rules, 2011 section 9, he was removed from service vide DEO (M) Endstt: No 8262-68/Absence/removal from service/F.No 4/87 Dated Swabi the 19-2-2018, dispatched through Registered letter No camp POP-822 Dated 22-9-2018 on his permanent residential address.

- 9. In service appeal No.463/2019 decided on 25-3-2022, the appeal was partially accepted and the case was remitted to the department for denovo enquiry as the appellant was not given appropriate opportunity of defense as is required under KPK Govt Servants (F&D) rules ,2011 while imposing Major Penalty i.e. removal from service by the competent authority.
- 10. The chairman enquiry committee himself contacted the employee to present before the enquiry committee at DEO(M) Swabi office, to record his version and defend himself. He received a questionnaire as annexed as A receiving signs exist and demanded time to respond. The committee waited almost 02 weeks for his reply but he did not bother to submit his reply.
- 11. The overall record of the employee is full of absence, enquiries, litigation and disputes.

Conclusion:

Record of the employee shows that:

- 1. The employee is non-serious disobedient, ill-disciplined and habitual violator of rules and
- 2. His service record is spotted with absenteeism, defiance and disputes.
- 3. He did not bother to present himself before the enquiry committee for recording his version in this particular case which shows his psyche.
- 4. The committee is unanimous to conclude that the employee has no interest in his case and his service record testifies that he cannot be retained in service as per KPK Govt. servant (E&D) rules,2011.

Recommendation:

The committee recommends that:

" Mr. Mujeeb ur Rahman Ex-Lab Attendant GHSS Dobian is ill-disciplined and dis-interested in Govt: Service. Hence, major Penalty under KPK Govt servants E&D rules 2011, shall be imposed on him under Rule 4b-iii .
