SERVICE APPEAL UNDER SECTION-4 OF KPK SERVICE TRIBUNAL ACT 1974 AGAINST ORDER DATED 23-07-2024 OF THE DISTRICT POLICE OFFICER HARIPUR WHEREBY APPELLANT HAS BEEN 'REDUCED IN RANK FROM ASSTT. SUB. INSPECTOR TO HEAD CONSTABLE AND ORDER DATED 30-09-2024 OF REGIONAL POLICE OFFICER HAZARA REGION ABBOTTABAD WHEREBY APPELLANTS DEPARTMENTAL APPEAL HAS BEEN REJECTED/FILED.

PRAYER: ON ACCEPTANCE OF INSTANT SERVICE APPEAL BOTH THE ORDERS DATED 23-07-2024 AND 30-09-2024 OF THE RESPONDENTS MAY GRACIOUSLY BE SET ASIDE AND APPELLANT BE REINSTATED IN HIS RANK OF ASSISTANT SUB. INSPECTOR FROM THE DATE OF HIS REDUCTION IN RANK WITH GRANT OF ALL CONSEQUENTIAL SERVICE BACK BENEFITS.

Respectfully Sheweth:

1. That appellant while posted as I/C Police Post Pind Muneem (Police Station Khanpur, District Haripur) was served upon with a Charge Sheet by the District Police Officer Haripur with the allegation that; "It has been reported by the SDPO Khanpur vide his office letter No.385/R dated 02-07-2024 that you detained a suspect namely Raja Intisham s/o Raja Khawaj Muhammad r/o Sanjiyala in Police Post Pind Muneem for interrogation. Due to your negligence, the aforementioned suspect escaped from the police custody, escaped accused was involved in Case FIR No.486 dated 10-06-2024 u/s 380/34 PPC PS Khanpur. This incident took place due to your extreme negligence and irresponsible attitude. Moreover, the court's Bailiff recovered a suspect namely Irfan s/o Sher Muhammad r/o Hattar, illegally detained by you, which had imprinted bad impacts on the reputation of police department. Your involvement in such like illegal acts & lethargic attitude in the discharge of official duties, amounts to gross misconduct on your part in terms of KPK Police Efficiency & Discipline Rules 1975 (amended-2014) hence charge-sheeted ". (Copy of charge sheet is attached as Annex-"A").

That the above mentioned Charge Sheet was replied in detail by the appellant explaining all facts and circumstances of the matter denying the allegations mentioned therein being incorrect, false and baseless. (Copy of reply to the Charge Sheet is attached as Annex-"B").

That so far as the first allegation with regard to escape of accused Intisham charged in No. FIR 486 dated 10-06-2024 u/s-380/34 PPC PS Khanpur is concerned in this respect it is submitted that on 29-06-2024 the appellant was on patrolling duty. Muharrir PP confined the accused Ihtisham in constable's room at first floor and tied him with a cot. Constable Awais No. 1196 was deployed on duty to guard the accused. At about 21:15 hours while appellant performing his patrolling duty near Mang University he was informed on his Cell No. 0316-2210011 by Suleman Moharrir of PP through mobile No.0311-9309508 that accused Raja Ihtisham had escaped from the custody of Constable Awais No.1196. Accused escape was immediately brought to the notice of SHO PS Khanpur by the appellant. Despite appellant's repeated requests the accused

Intisham's arrest in PP record was forbidden by SHO Khanpur at the hands of Moharrir PP. On the application of Farzan s/o Hadi Zaman an inquiry u/s-157(1) vide Daily Dairy No.21 dated 15-06-2024 was sent to PS Khanpur through Challan Dak dated 28-06-2024 which was received by Moharrir PS Khanpur whose signatures as a token of proof are available on Challan Dak. Appellant is innocent in this matter and there: is nothing wrong on his part. (Copy of Challan Dak dated 28-06-2024 is attached as Annex-C).

That so for as 2nd charge against appellant that the court's Bailiff recovered a suspect namely Irfan s/o Sher Muhammad r/o Hattar, illegally detained by him is concerned, in this respect it is stated that Irfan was an accused of one Arshad's complainant of Rani-Wah. On the information of complainant, appellant reached Khanpur Dam and arrested accused Muhammad Irfan and took him to PS Khanpur for the information of SHO and also recorded his arrest in the daily dairy No.37 dated 28-06-2024 of PS Khanpur. Whereupon, the SHO ordered further investigation of the accused. According to the instruction of SHO when appellant was bringing him to PP. Pind Muneem he received information through wireless from Control Room that German Delegation was about to reach and appellant was to perform duty with the said delegation. Appellant reached**PP Pind Muneem, dropped the suspect there and handed him over to Moharri PP and then proceeded to escort the German Delegation. When

appellant was on duty with Delegation he was informed by Moharrir PP that a Court Bailiff had reached PP Pind Muneem and was interrogating about his arrest. Appellant told the Moharrir to keep the Bailiff busy till he reaches there. Appellant after performing duty with the delegation reached PP and told the bailiff about arrest of suspect and he was given Daily Dairy No.37 dated 28-06-2024 wherein accused arrest was recorded and informed him that accused Irfan was arrested on the written complaint of one Arshad Mehmood. Bailiff being pfully satisfied went away. He reported the matter to the concerned Court with Diary No.37 dated 28-06-2024 whereupon the Court was also satisfied with the arrest of accused. On 28-06-2024, vide Challan Dak application of Arshad Mehmood (Complainant) was sent to PS Khanpur for registration of case through Muhammad Ali Constable No.924 which was received by Moharrir of PS and as a token of proof his signatures are affixed on Dak Challan. It is incorrect that suspect was arrested without any reason. Appellant is also innocent in this matter. Nothing is wrong on his part.

That in both the above mentioned cases appellant has discharged his duty with dexterity, care, caution and honesty. There is nothing wrong on his part. Appellant never remained lethargic, negligent and irresponsible towards his official duties. Hence the allegations are totally incorrect and baseless. That throughout his more than 24 years service appellant always performed his assigned duties with zeal, zest, devotion, dedication and honesty to the entire satisfaction of his officers and never provided a chance of reprimand. Appellant has meritorious service record at his credit.

not was departmental inquiry proper That conducted. Show Cause Notice was also not issued. Copy of inquiry report, if any, was never provided to appellant. No witness was examined against the appellant in his presence. Even the enquiry suffers with irregularity and illegality. Only on receiving reply to the Charge Sheet the DPO Haripur vide order 23-07-2024 straightaway awarded the dated appellant with punishment of "Reduction in Rank from ASI to HC" and that too without any reason and rhyme and without providing opportunity of personal hearing against the principle of natural justice. (Copy of punishment order dated 23-07-2024 as Annex-"D):

That appellant is totally innocent and has discharged his official duties with devotion and honesty yet he has been awarded punishment of "Reduction in Rank" without any cause or justification. There is nothing wrong on his part.

That appellant aggrieved of the order of District Police Officer, Haripur preferred a departmental appeal before the Regional officer, Hazara Region, Abbottabad which has been rejected/filed vide order dated 30-09-2024. (Copies of the Departmental appeal and its rejection order are attached herewith as Annexure-"E&F"). Hence instant service appeal on the following and other grounds:-

GROUNDS:-

- A) That both the orders dated 23-07-2024 and 30-09-2024 of the respondents are illegal, unlawful against the facts, departmental rules, regulations and principle of natural justice hence liable to be set aside.
- B) That proper inquiry was not conducted. No witness was produced before the inquiry officer to depose against appellant in his presence. Copy of inquiry report, if any, was not provided. Show Cause Notice was also not given. Even opportunity of personal hearing was not afforded. Nothing adverse could be brought on record against appellant. Appellant was condemned unheard in violation of rules, regulations and principle of natural justice.
 - C) That respondents have not treated the appellant in accordance with law, departmental rules, regulations and policy on the subject and have acted in violation of Article-4 of the constitution of Islamic Republic of Pakistan 1973 and unlawfully issued the impugned orders which are unjust, unfair hence not sustainable in the eyes of law.
 - D) That appellate authority has also failed to abide by the law and even he did not take into consideration the grounds adduced in the memo of appeal and has rejected the departmental appeal without any speaking order. Thus act of respondent is contrary to the law as laid down in the KPK

Police (E&D) Rules 1975 read with section 24-A of General Clauses Act 1897 and Article-10 of the Constitution of Islamic Republic of Pakistan 1973.

- E) That the allegations leveled against appellant are incorrect, false, fabricated and are the result of malafide. Appellant never involved himself in any such activity as alleged against him. He discharged his duties with dexterity, devotion and honesty. There is nothing wrong on his part.
- F) That instant service appeal is well within time and this honorable Service Tribunal has got every jurisdiction to entertain and adjudicate upon the lis.

PRAYER:

It is, therefore, humbly prayed that on acceptance of instant service appeal both the orders dated 23-07-2024 and 30-09-2024 of the respondents may graciously be set aside and appellant be re-instated in his rank of Assistant Sub Inspector from the date of his reduction in rank with grant of all consequential service back benefits. Any other relief which in the circumstances of the case this honorable Tribunal deems fit may also be granted.



Appellant reached PP Pind Muneem and dropped the suspect there and handed him over to Moharri PP and then proceeded to escort the Delegation. When appellant was on duty with Delegation he was informed by Moharrir PP

that Court Bailiff had reached PP Pind Muneem and was interrogating about arrested suspect. Appellant told the Moharrir to keep the Bailiff busy till he reaches there. Appellant after performing duty with the delegation`reached PP and told about the arrest of suspect and he was given Daily Dairy No.37 dated 28-06-2024 and informed him that suspect Irfan was arrested on the written complaint of one Arshad Mehmood. Baillif was fully satisfied and went away. He reported the matter to the Court with the Diary No.37 dated 28-06-2024 whereupon the Court was also satisfied with the arrest of suspect. On 28-06-2024, Arshad Mehmood's complaint application was sent to PS Khanpur for registration of case vide Challan Dak through Muhammad Ali Constable No.924 which was received by Moharrir PS and as a token of proof his signatures are available on Dak Challan. It is incorrect that suspect was arrested without any reason. Appellant is also innocent in this matter. Nothing is wrong on his part.

That in both the above mentioned cases appellant has discharged his duty with dexterity, care, caution and honesty. There is nothing wrong on his part. Appellant never remained lethargic towards his official duties. Hence the allegations are totally incorrect and baseless.

That Appellant throughout his more than 24 years service always performed his assigned duties with 'zeal, zest, devotion, dedication and honesty to the

entire satisfaction of his officers and never provided a chance of reprimand. Appellant has meritorious service record at his credit.

That proper departmental: inquiry was no conducted. Show Cause Notice was also not issued. Copy of inquiry report, if any, was never provided to appellant. No witness was examined against the appellant. Even the enquiry suffers from irregularity and illegality. Only on receiving reply to the Charge Sheet the DPO Haripur vide order dated 23-07-2024 straightaway. awarded the appellant with punishment of "Reduction in Rank from ASI to HC" and that too without any reason and rhyme and without providing opportunity of personal hearing against the principle of natural justice. (Copy of punishment order dated 23-07-2024 as "C").

That appellant is totally innocent and has discharged his official duties with devotion, dedication and honesty yet still he has been awarded punishment of "Reduction in Rank" without any cause or justification. There is nothing wrong on the part of appellant.

That if the appellant is provided with a chance of personal hearing, he will really prove himself as innocent by explaining all the facts and circumstances of the matter.

ORDER

This order will dispose of departmental appeal under Rule 11-A of Khyber Pakhtunkawa Police Rules, 1975 submitted by HC Shahzada Khan No. 201 of district Haripur against the order of punishment i.e. reduction in rank from ASI to HC awarded by DPO, Haripur vide OB No.541 dated 23-07-2024.

"Brief facts leading to the punishment are that the appellant while posted as I/C PP Pind Muneem PS Khanpur, it was reported by SDPO/Khanpur vide his office letter No. 385/R dated 02-07-2024, that he detained a suspect namely Raja Ehtisham s/o Raja khawaj Muhammad r/o Sanjiyala in Police Post Pind Muncem for interrogation, the aforementioned suspect escaped from the Police custody. He was involved in Case FIR No. 486 dated 10-06-2024 u/s 380/34- PPC Ps Khanpur. This incident took place due to extreme negligence and irresponsible attitude of delinquent official. Morcover, court's Bailiff recovered a suspect namely Irfan s/o Sher Muhammad r/o Hattar, illegally detained by delinquent official."

The appellant was issued charge sheet along with summary of allegations and DSP, Ghazi, Haripur was deputed to conduct departmental enquiry. The EO held the appellant responsible of misconduct. He was called in OR and heard in person. Consequently, DPO Haripur awarded him punishment of reduction in rank from ASI to HC. Hence, the appellant submitted this present appeal.

After receiving his appeal, comments of DPO Haripur were sought and examined/perused. The undersigned called the appellant in Orderly Room and heard him in person and provided him reasonable opportunity to defend the charges leveled against him. However, he failed to advance any convincing justification in his defense. Therefore, in exercise of the powers conferred upon the undersigned under Rule 11-4 (a) of Khyber Pakhtunkawa Police-Rules, 1975 the instant appeal is hereby rejected/filed with immediate effect.


