

**PRAYER:**

**On acceptance of this appeal the respondent No 2 may kindly be  
directed to promote the appellant from SPST BPS 14 to PET BPS -15  
from the date of issuance of notification Dated 23-05-2024.**

**Respectfully Sheweth:**

The appellant submits as under;

- 1) That the appellant was appointed for the post of BPS-12 (PST) in  
Government Primary school Boday Ghar vide Endst No 8464-  
70/PST/Appointment/ Adhoc /NTS dated 07-07-2014  
(Copy of appointment is annexed as annexure A )
- 2) That the appellant was promoted to the post of Senior Primary School  
Teachers (SPST) BPS-14 vide office order Endst: No: 9833-  
10095/promotion/PSHT/2024 dated 24-04-2024 in pursuance of notification  
No. SO(PE)4-5/SSRC/MEETING/2012/TEACHING CADRE DATED 13-11-2012.  
(Copy of promotion is annexed as annexure B )
- 3) That the appellant has since been serving as SPST BPS-14.
- 4) That the appellant being suitable and eligible was very impatiently  
waiting for promotion to the post of PET BPS-15 for long.

- 5) That appellant along with few others who had been eligible for promotion to PET were included in the Departmental promotion committee (DPC) Dated: 11-05-2024. **(Copy of DPC is annexed annexure C)**
- 6) That the appellant was waiting for the promotion to the post of PET since he was included in the DPC and being eligible but all of sudden the Department were illegally, unlawfully issued the impugned notification Endst: No 11408-12 / promotion / PET / 2024 dated 23-05-2024. **(Copy of impugned notification is annexed as annexure D)**
- 7) That despite having the required qualification and experience and being eligible for promotion, the appellant was discriminated by not considering him for promotion to the post of PET.
- 8) That the appellant was competent, eligible and deserving to be promoted to PET, otherwise not promoting is not only illegally, unlawfully but beyond reason and understanding.
- 9) That being morally and legally aggrieved the appellant has no other remedy but to prefer the departmental appeal No 419 dated: 06-06-2024 before the respondent No 2 and requested him for his promotion to the said post. **(Copy of departmental appeal is attached E)**
- 10) That ibid departmental appeal is still pending and the respondent No 2 has badly failed to take any action on it within the statutory period of 90 days.
- 11) That being morally and legally aggrieved from the action and inaction of the respondent No 2 the appellant has no other remedy but to prefer the instant appeal under Section 4 of Service Tribunal Act read with any other relevant provisions, before this honorable court inter alia the following grounds.

**GROUNDS:**

- i) **That** the appellant was serving as PST BPS 12 since 07-07-2014. He had completed his five year required service and was eligible/fit for promotion to the post of PET.
- ii) **That** the appellant also had the required academic qualification.
- iii) **That** other teacher who had same academic qualification as that of the applicant have already been promoted to the post of PET BPS15 vide notification Endst: 2210-14 dated 20-04-2019. **(Copy of notification is annexed as annexure F)**
- iv) **That** the ~~petitioner~~ <sup>Appellant</sup> was not promoted to Spst although the petitioner was eligible for promotion and the delay caused by the department could not be made a hurdle in promotion of petitioner to the post of PET.

(B)


- v) **That** the impugned action of respondent is against the law, facts, material available on record. Hence liable to be rectified.
- vi) **That** the article 4 of the constitution of Islamic Republic of Pakistan 1973, has clearly unequivocally stated that every individual is to be dealt in accordance with law, but in the instant case not only this principle but article 25 of the Constitution of Islamic Republic of Pakistan which guarantees equality has also been violated.
- vii) **That** the appellant is well qualified and fulfills the required qualification as well as criteria for promotion to the post of PET.
- viii) **That** the appellant has not been treated in accordance with law and rules on the subject noted above.
- ix) **That** other grounds not specifically raised will be argued with the prior permission of this Honorable Court at the time of arguments.

**Prayers;**

It is therefore very humbly prayed that On acceptance of this appeal the respondent No 2 may kindly be directed to promote the appellant from SPST BPS 14 to PET BPS -15 along with all the benefits from the date 23-05-2024

Any other relief not specifically prayed for but this august court deem proper may also be granted.

1. No TA/DA is allowed.
2. Charge reports should be submitted to all concerned.
3. Appointment is purely on temporary & ad hoc based for one year with effect from 1<sup>st</sup> 01.08.2014 to 31.07.2015.
4. He should not be handed over charge if he exceeds 38 (Thirty Eight) years or below 18 years of age.



5. Appointment is subject to the condition that the certificate/ documents must be verified from the concerned authorities, any one found producing bogus certificate will be reported to the Law enforcing agencies for further action.
  6. His services are liable to termination on one month's notice from either side. In case of resignation without notice his one month pay / allowances shall be forfeited to the Government.
  7. Pay will not be drawn until and unless a certificate issued by this office that his documents are verified.
  8. He should join his post within 30 days of the issuance of this notification. In case of failure to join the post within 30 days of the issuance of this Notification his appointment will be expired automatically and no subsequent appeal etc is entertained.
  9. Health & Age Certificate should be produced from the Medical Superintendent before taking over charge.
  10. He will be governed by such Rules and Regulation as may be issued from time to time by the Government.
  11. His services shall be terminated at any time, in case his performance is found unsatisfactory during his service period. In case of misconduct, he shall be proceeded under the framed rules & regulations announced time to time.

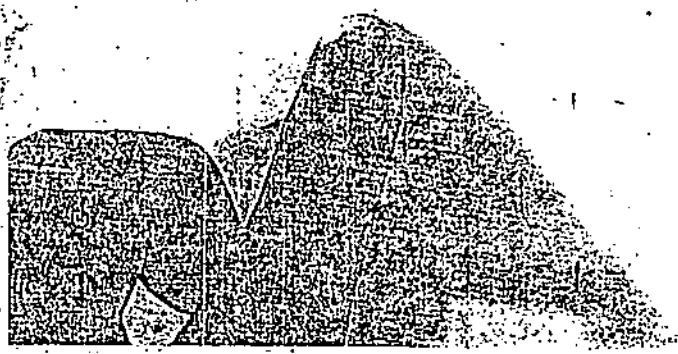

- 9) That being morally and legally aggrieved the appellant has no other remedy but to prefer the instant departmental appeal inter alia the following grounds.

**GROUNDS:**


- i) That the appellant was serving as PST BPS 12 since 07-07-2014. He had completed his five year required service and was eligible/fit for promotion to the post of PET.
- ii) That the appellant also had the required academic qualification.
- iii) That other teacher who had same academic qualification as that of the applicant have already been promoted to the post of PET BPS15 vide notification Endst: 2210-14 dated 20-04-2019.
- iv) That the petitioner was not promoted to Spst although the petitioner was eligible for promotion and the delay caused by the department could not be made a hurdle in promotion of petitioner to the post of PET.
- v) That the impugned action of respondent is against the law, facts, material available on record. Hence liable to be rectified.
- vi) That the article 4 of the constitution of Islamic Republic of Pakistan 1973, has clearly unequivocally stated that every individual is to be dealt in accordance with law, but in the instant case not only this principle but article 25 of the Constitution of Islamic Republic of Pakistan which guarantees equality has also been violated.
- vii) That the appellant is well qualified and fulfills the required qualification as well as criteria for promotion to the post of PET.


