APPEAL OF THE APPELLANT IN RESPECT
OF HIS SENIORITY W.E.F 18/04/2017 WAS
NOT RESPONDENT WITHIN THE
STATUTORY PERIOD OF 90 DAYS.**

PRAYER IN APPEAL:

On acceptance of this appeal:

- i. *The seniority of appellant may be considered w.e.f.
18/04/2017 along with those colleagues who were*

appointed through same advertisement, so that personal Grade-17 of appellant is also not effected in future.

- ii. The previous service of the appellant may be counted as a regular/pensionery service because the appellant was effected from the conduct of the department.
- iii. The appellant may be given all back/ consequential benefits from 18/04/2017.

Any other relief which has not been mentioned may also be granted in favour of appellant.

Respectfully Sheweth:

The appellant submits as under:

- 1. That respondent No. 2 has advertised post of SST on 30/08/2016 and closing date of submission of from was 30/09/2016. (Copy of advertisement is attached as annexure "A").
- 2. That appellant appeared in the test which was conducted on 04/12/2016. The respondent No. 2

issued appointment order of the candidates on 20/04/2017 which was endorsed by DEO Male Karak, but the appointment order of the appellant was differed due to Al-Khair Degree of B.Ed and reserved the post of SST (Bio & Chemistry) for the appellant till the verification of degree from HEC Islamabad.

3. That the degree of the appellant was sent to HEC Islamabad by the respondent No. 3 which was verified on 03/12/2018 by the HEC. It is necessary to mention that the appellant verified the degree from HEC in 2011. (Copy of the verification letter and B.Ed degree is attached as annexure "B").
4. That it is pertinent to mention here that Government of Khyber Pakhtunkhwa has passed Regulations Act 2017 in which all those candidates who were appointed on 18/04/2017 were regularized but the appellant who's appointment order was delayed due to verification of B.Ed degree was not regularized but later on 2021 the services of the appellant was regularized but not like those

who were appointed with same advertisement as that of appellant.

5. That appellant may be treated along with those who were appointed initially on 18/04/2017 and later on are regularized through Government of Khyber Pakhtunkhwa Regulations Act 2017 of Government of Khyber Pakhtunkhwa.
6. That appellant approach time and again for seniority w.e.f. 18/04/2017 and his previous service may be considered for regular service but his departmental appeal was not decided within the statutory period. (Copy of departmental appeal is attached as annexure "C").
7. That the appellant having no other adequate alternate remedy, but to approach this Hon'ble Tribunal for redressal of his grievances, on the following grounds:

GROUNDS:

- A. That the act and omission of the respondent not to regularized the services of the appellant from the

initial date of appointment was illegal against the principle of natural justice.

- B. That the appellant is entitled for seniority and other attached benefits w.e.f. 18/04/2017 but the respondents are delaying the case of appellant in one way or the other.
- C. That that blunder of the department did not suffer the appellant because appellant are similarly placed persons who are already appointed on 18/04/2017.
- D. That the appellant is highly discriminated which is the violation of Constitution of Islamic Republic of Pakistan, 1973.
- E. That appellant will take other grounds at the time of arguments with the prior permission of this Hon'ble Tribunal.

It is, therefore, most humbly prayed that on acceptance of this appeal:

- i. The seniority of appellant may be considered w.e.f. 18/04/2017 along with those colleagues who were appointed through same advertisement, so that

personal Grate-17 of appellant is also not effected in future.

- ii. The previous service of the appellant may be counted as a regular/pensionery service because the appellant was effected from the conduct of the department.
- iii. The appellant may be given all back/ consequential benefits from 18/04/2017.

Any other relief which has not been mentioned may also be granted in favour of appellant.





Dear respected sir!

1. That an advertisement for the post of SST (Bio-Chem) was advertised on 30th August 2016 and 30th September 2016 was fixed for submission of apply.
2. That test of SST (Bio-Chem) was conducted on 4th December 2016 and appointment orders were issued on adhoc basis by the Directorate of Elementary and Secondary Education Peshawar dated 18th April 2017 while the same order was endorsed by District Education Officer (M) Karak on 20 April 2017 while the appointment of appellant was deferred due to Al-Khair Degree of B.Ed and reserved the post of SST (Bio-Chem) to the appellant till verification of his degree from HEC Islamabad. *(Photocopy of appointment order dated 18th April 2017 is attached as marked A)*
3. That office of the DEO (M) Karak sent the B.Ed degree of appellant to HEC for verification and HEC verified the B.Ed degree of appellant Vide letter no A&A(Att Cell)3-1/2018/1613 dated December 3rd, 2018 the verified degree & the genuiness letter of B.Ed Degree from HEC was received to the office of DEO M Karak and then the office of DEO M Karak sent verified degree of appellant 1 to Directorate of Elementary and Secondary Education Peshawar *(photocopy of verification letter and B.Ed degree are attached as marked B & C)*
4. That in light of appointment and regularization act 2017 Khyber Pakhtunkhwa NO 1, 2018 read with section 1 sub section 2 of the act ibid and law Department Govt of KP advice bearing no ALD-III/Legis1(4) 2017/vol-19888-90 dated 20-03-2017. The office of director of Elementary and Secondary Education Peshawar regularized the services other teachers who were initially Appointed as adhoc basis on 18th April 2017 under the above mentioned act. *(Photocopy regularization order is attached as marked D)*

5. That after verification by HEC the appellant was appointed against the reserved post of SST Bio/Chem BPS - 16 vide appointment order dated 19th February 2019 on adhoc basis policy whereby the director of Elementary Secondary Education Department KP Peshawar was required under the ibid regularization Act to issue appointment of Appellant on regular / permanent basis not on Adhoc basis.
6. That all the sanctioned posts advertised by the directorate of Elementary Secondary Education Peshawar are regular posts as per laws, therefore, it was required to issue Regular and permanent order of appellant rather to issue on adhoc basis! order that the Seniority may not be affected of the appellant.
7. That the appellant has been discriminated as the appellant applied in the light of Advertisement dated 30th August 2016 for the post of SST Bio-Chem but only deferred for the verification of B.Ed degree from HEC while the Degree of B.Ed of appellant was already verified by HEC in 2011 and the services of other SST were regularized who were appointed on the same advertisement Dated 30th Aug 2016.
8. That the appellant is entitled to be given seniority with effect from 18th April 2017 As because the directorate of elementary and secondary education was required to issue conditional appointment order for appellant on the basis of advertisement Dated 30th Aug 2016.

Prayer

1. The seniority of appellant may be considered from the 18th April 2017.
2. The previous services may be considered as regular / i-e pension etc
3. An arrear may be granted w-e-f 18th April 2017 .
4. the seniority may be given / considered from 18th April 2017 so that personal grade 17 is also not affected in future.
