PARAWISE COMMENTS ON BEHALF OF RESPONDENTS NO. 1 to 3

Respectfully Sheweth:

Preliminary Objections.

- 1. That the appellant has got no cause of action and locus standi to file instant appeal.
- 2. That the appeal is bad due to misjoinder and nojoinder of necessary parties.
- 3. That the appeal is barred by law and & limitation.
- 4. That the appellant has not come to this Tribunal with clean hands.
- 5. That the instant appeal is not maintainable in its presents form.
- 6. That the appellant concealed the material facts from this Hon'ble Tribunal.
- 7. That the appellant has been estopped by his own conduct to file the appeal,

REPLY ON FACTS.

- 1. Para No. 01 of appeal pertains to service record, hence need no comments.
- 2. Para No. 02 of appeal is incorrect. Appellant while posted to Police Station Zaida, he along with other police party held nakabandi /snap checking. During such nakabandi he stopped one motor car wherein Fayaz & Nawaz Ali Shah r/o Zaida were boarded. During search of that car huge quantity of Charas from the possession of one namely Favaz were recovered but instead of taking legal action, he received illegal gratification of Rs 90000/- from him and set them free, on account of such mis-conduct, he was proceeded against departmentally. He was issued charge sheet/summary of allegations and proper departmental enquiry were initiated and SDPO Lahor was appointed as Enquiry Officer to conduct proper departmental enquiry in accordance with law/rules. The enquiry officer conducted proper departmental enquiry, recorded statements of all concerned and submitted his findings wherein appellant was found guilty for the mis-conduct. The respondent No. 1 perused the findings of the enquiry officer and by agreeing with the enquiry officer, appellant was served with Final Show Cause Notice and after providing opportunity of personal hearing, awarded Major punishment of reduction from rank of Sub Inspector to Assistant Sub Inspector in accordance with law/rules. (Copies of Charge Sheet/ Summary of allegations enquiry report, and Final Show Cause Notice and Order are attached as Annexure "A,B,C,D & E").
- 3. Para No. 03 to the extent of filing departmental appeal before appellate authority is correct however, the same was examined which was partially accepted wherein the major penalty of reduction in rank was modified into minor penalty of forfeiture of one year approved service vide order 155-57/ES dated 11.01.2024. (Copy of appellate order is attached as annexure "F").
- 4. Reply already given vide para above.
- Para No. 05 of appeal to the extent of filing revision petition is correct, however the same
 was rejected by the appellate authority being devoid of merit and groundless through
 speaking order where the petitioner/appellant was heard in person before passing final
 order (Copy of order No. S/1151-56 dated 17.05.2024 attached as annexure "G").



- 6. Reply, already given vide para above.
- 7. That appellant has got no cause of action, the orders of respondents are quite legal and in accordance with law/rules, hence—the present appeal is groundless and liable to be dismissed.

GROUNDS.

- A. Incorrect. The orders of respondents are quite legal in accordance with law and rules.
- B. Incorrect. The orders of respondents are legal and in accordance with law. Appellant is treated in accordance with law/ rules and no discrimination what so ever has been committed. The orders passed against the appellant are neither unconstitutional nor illegal rather the same are speaking in nature.
- C. Incorrect. The actions of respondents are strictly as per law /rules.
- D. Incorrect proper departmental enquiry was conducted and during enquiry appellant was provided an opportunity of cross-examination and personal hearing. After fulfilment of all codal formalities he was awarded punishment as per law/ rules.
- E. Incorrect. Proper Charge Sheet and Summary of allegations were issued and the appellant was provided opportunity of personal hearing during departmental proceedings. After proper enquiry proceedings in accordance with law/rules appellant was found guilty for the mis-conduct; hence, on receipt of recommendation of Enquiry Officer appellant was and punished as per law/ rule.
- F. Incorrect. Pertains to Service Record.
- H. That the respondents also seek permission to advance other grounds at the time of arguments.

Prayer.

Keeping in view the above narrated facts, it is humbly prayed that the instant appeal being devoid of merits may very kindly be dismissed with costs, please.

SUMMARY OF ALLEGATIONS

I, Najmul Hasnain Liaquat, District Police Officer, Swabi as competent authority am of the opinion that SI Gohar Ati has rendered himself liable to be proceeded against as he has committed the following acts/omission within the meaning of section 02 (iii) of KPK Police Rules-1975.

1. While posted at PS Zaida, he alongwith other Police party held nakabandi/snap checking at Kunda mor stopped one motor car, wherein Fayaz and Nawaz Ali Shah Rs/o Zaida were boarding. During search huge quantity of Charas was precovered from possession of Fayyaz. But instead of taking legal action, he received illegal gratification of Rs. 90,000/- from him and set them free.

Above commission/omission falls under the purview of in-efficiency and misconduct and is punishable under Rules 4 a & b of Police Rules 1975 amended 2014.

For the purpose of scrutinizing the conduct of the said official Mr. Land Wr. DSP Land is hereby deputed to conduct proper departmental enquiry against the aforesaid official, as contained in section 6 (I) (a) of the afore mentioned rules. The enquiry officer after completing all proceedings shall submit his verdict to this office within (7) days, SI Gohar Ali is directed to appear before the enquiry officer on the date, time and place fixed by the later (enquiry officer). statement of charge sheet is attached herewith.

BUMMARY OF THE ENGLISH IS

DEPARTMENTAL ENQUIRY OF SI GOHAR ALI POLICE LINES SWABI.

Reference attached:-

Allegations:-

It is alleged that SI Gohar Ali while posted at Police Station Zaida, he alongwith other Police party held Nakabandi/snap checking at Kunda Mor stopped one Motor Car, wherein Fayyaz and Nawaz Ali Shah r/o Zaida were boarding. During search huge quantity of Charas was recovered from possession of Fayyaz, but instead of taking legal action, he received illegal gratification of Rs.90,000/- from him and set them free.

The W/DPO Swabi entrusted the enquiry to the then SDPO Lahor. However, on his transfer the said enquiry was entrusted to me.

In order to probe into the matter the undersigned perused the entire record alongwith the statements of all concerned which are as under:-

STATMEMENT OF SI GOHAR ALI POLICE LINES SWABI.

He stated that the allegations leveled against him are false, baseless, against the rules and against the facts.

- In the charge sheet date of Nakabandi, time not mentioned nor clear about the registration the motor car.
- During Nakabandi he did not recover Charas from the possession of Fayaz and Nawaz Ali shah r/o Zaida nor he received illegal gratification from them.

He stated that on 22.02.2023 the persons namely Sabz Ali shah and Shah Khalid r/o Bunair submitted an application in Police Station Zaida against Younas s/o Asghar r/o Bunair regarding theft of amount Rs.2,25,000/- and one Mobile Phone from his vehicle and after the occurrence the said person (Younas) came to Swabi District and lived with Fayyaz and Nawaz Ali Shah in village Zaida Changaro Cham.

On 02.03.2023 he along with Police officials was on routine gusht. At the time Moharrir of Police Station Zaida informed him to bring Younas to Police Station Zaida regarding application of Sabz Ali Shah and Shah Khalid. On the said information he arrest Younas and brought him to Police Station Zaida. The persons Fayyaz and Nawaz Ali Shah also with him. After detail discussion the matter has been settled between the applicant and respondents in Police Station (Decision attached).

He did not recovered Charas from the vehicle of Fayyaz and Nawaz Ali Shah. If, they are found involved in such like practice legal action will be taken against them.

He further stated that he is a responsible Police Officer and serving in Police Department since 1991. During his service he always performed his official duty with efficient manor and high devotion. His detail statement is attached herewith for perusal.

STATMEMENT OF SI NAZIM KHAN SHO POLICE STATION ZAIDA.

He stated that during his period SI Gohar Khan performed his duty as Addl: SHO Police Station Zaida. During his period he (SI Gohar Khan) did not take action against narcotics. He brought the said information in the notice of SDPO Circle Swabi and also lodged reports in Daily Dairy. His statement is attached herewith for perusal.

STATMEMENT OF CONSTABLE SALEEM ULLAH NO.1380 PP

He stated that on 02.03.2023 he alongwith ISI Gohar Khan and other official (Masam Khan No.1354 & Liyaqat Jung No.578) hold nakabandi near graveyard Kunda Mor. Si Gohar Khan was busy in checking of different vehicles on the spot. During Nakabandi Si Gohar Khan recovered 03 packet Charas from Motor Car and told them wait for him in "Tall" and went in the said Motor Car. Si Gohar Khan came back after one hour and told him that he will give him Charas. Then they went to hotel (Hawaldar Hotel) for meal. His statement is attached herewith for perusal.

FINDINGS:-

- Statements of Fayyaz and Nawaz Ali Shah corroborated the version of allegations.
- He called the person namely Younas to Police Station Zaida who is the friend of Fayyaz and Nawaz Ali. But according to the record of register No 05 the said application was marked to ASI Safdar for taking action.
- SHO Police Station Zaida (SI Nazim Khan) also produce bad reputation of SI Gohar Khan in his statement.
- Constable Saleem Ullah No.1380 stated in his statement that the delinquent officer SI Gohar Khan "recovered 03 packet Charas from Motor Car.
- 5. The undersigned obtained CDR of SI Gohar Khan, Fayyaz and Nawaz Ali Shah and perused carefully which shows the location of SI Gohar khan near Kunda Government Hospital Kunda on 02.03.2023 at 22:30 PM; where according to him-he made Nakabandi. While the location of Nawaz Ali at the point was at 00:31 AM to 00:43 AM.
- 6. According to MHC PS Zaida the delinquent officer returned late to Police Station on the same night.
- 7. The undersigned perused his previous record/service roll. After perusal the undersigned noted his 08 good entries and 11 minor/bad entries.
- 8. A secret enquiry was also conducted in the said matter which corroborate the allegations leveled against him.

RECOMMENDATION:-

Keeping in view, the above fats, statements of Constable Saleem Ullah No.1380, Fayyaz and Nawaz Ali Shah the delinquent officer is recommend for suitable punishment if, agreed

This order is aimed to dispose-off the departmental proceedings conducted against SI Gohar Ali of this district Police, under the Khyber Pakhtunkhwa, Police Rules, 1975 (amendment 2014) vide this office No.25/CC/PA dated 07.03.2023 on the following allegations.

While posted at PS Zaida, he alongwith other Police party held nakabandi/snap checking at Kunda mor. During nakabandi he stopped one motor car, wherein Fayaz and Nawaz Ali Shah Rs/o Zaida were boarding. During search huge quantity of Charas was recovered from possession of Fayaz, but instead of taking legal action, he received illegal gratification of Rs.90,000/- from him and set them free.

He was issued charge sheet on the said allegations and enquiry gedings were entrusted to SDPO Lahor under Police Rules-1975 ammended-The Endumy Officer Conducted departmental enquiry, collected evidence, recorded statements of all concerned and submitted his finding, wherein the enquiry cofficer found the defaulter officer guilty for the mis-conduct and recommended him for suitable punishment. The undersigned thoroughly perused the findings of the Enquiry Officer and served him with Final Show Cause Notice. His reply to the Final Show Cause Notice was received, perused and he was heard in orderly room on 23.05.2023 but he could not advance any reason in self defence.

Keeping in view findings report of the Enquiry Officer and conduct of the defaulter officer, the undersigned came to the conclusion that the charges levelled against him have been proved beyond the shadow of doubt.

In view of situation painted above, in exercise of powers vested upon undersigned, I. Najmul Hasnain Liaquat, District Police Officer Swabi hereby, award SI Gohar Ali Major Punishment of "Reduction in rank from substantive rank of SI to ASI" with immediate effect and re-instate him from the date of his suspension.

ORDER.

Cohar Ali No. 292/MR of Swabi District Police against the order of the then District Police Officer, Swabi, whereby he was awarded Major punishment of reduction in rank from substantive rank of Sub Inspector to ASI vide OB: No. 676 dated 23.05.2023. The appellant was proceeded against departmentally on the allegations that he while posted of office Station Zaida held nakabandi/snap checking at Kunda Mor alongwith other and officials. During nakabandi, he stopped a motorcar wherein Fayaz and Nawaz Ali Theo Carda were boarded. During search huge quantity of charas was recovered that possession of Fayaz, but instead of taking legal action, he received illegal action of Rs. 90,000/- and set them free.

Proper departmental enquiry proceedings were initiated against him. He was issued Charge. Sheets alongwith Statement of Allegations and the then Subsistential Police Officer, (SDPO) Lahor, Swabi, was nominated as Enquiry Officer. The Officers after fulfilling all codal formalities submitted their findings wherein he appreciated the delinquent Officer for suitable punishment.

The then District Police Officer, Swabi thoroughly perused the findings of Swabi Police and served him with Final Show Cause Notice. His reply to the Final Swaw Cause Notice was received, perused and he was heard in Orderly Room on 2023, but he could not advance any reason in his self defense.

Excepting in view findings report of the enquiry Officer and conduct of the indicant Officer, the then District Police Officer, Swabi reached to the conclusion that in charges leveled against him have been proved beyond any shadow of doubt, hence, sounded him major punishment of reduction in rank from substantive rank of Subsepector to ASI vide OB: No. 676 dated 23.05.2023 by the then District Police Officer, exabi

Heeling aggrieved from the order of then District Police Officer, Swabi, the special preferred the instant appeal. He was summoned and heard in person in the Room held in this office on 19.10.2023.

from the perusal of the enquiry file it transpired that the enquiry accessings have not been conducted in a professional manner rather the same were in a naphazard manner without delving deep to ascertain the facts of the matter. The indian Officer was supposed to bring on record all the relevant materials so as in the guilt of the delinquent Officer but instead of doing so, he proceeded in a service and perfunctory manner. Hence, in order to prove the delinquent Officer as for guilty or innocent the relevant materials were not collected. Therefore, the matter remainding back by the undersigned vide this office order endorsement No. 7029-13 John 30.10.2023, the case in question to District Police Officer, Swabi for the Crick de novo enquiry through Superintendent of Police Investigation, Swabi.

in light of above, the Superintendent of Police Investigation, Swabi after the englectory enquiry submitted his report vide office letter No. 298/PA dated

Hence, the appellant was again summoned and heard in person in Orderly Reem held in this office on 03.01.2024.

In light of fresh report (De-novo enquiry) submitted by Superintendent of Folice Investigation, Swabi vide reference quoted above and poor financial back ground of the appellant, the undersigned is constrained to take a lenient view of the misconduct of appellant.

Recepting in view the above, I, Muhammad Suleman, PSP Regional Police Officer, Mardan, being the appellate authority, hereby modify major punishment of reduction in rank from substantive rank of Sub Inspector to ASI and convert the same into minor punishment of forfeiture of one year approved service. He is restored to his original rank of Sub Inspector from the date of reduction.

This order is hereby passed to dispose of Revision Petition under Rule 11-A of Khyber Pakhtuhkhwa Police Rule-1975 (amended 2014) submitted by SI Gohar Ali Shah No. 292/MR (hereinafter referred to as petitioner).

DPO/Swahi awarded the petitioner major punishment of reduction in rank from substantive rank of SI to ASI vide OB No. 676, dated 23.05.2023 on the allegations that he while posted to PS Zaida held nakabandi/snap checking at Kunda Mor alongwith other police officials. During nakabandi, he stopped a motorcar wherein Fayaz and Nawaz Ali Shah R/O Zaida were boarded. During search huge quantity of charas was recovered from possession of Fayaz, but instead of legal action, he received illegal gratification of Rs, 90,000/- PKR and set them free.
