Respectfully Sheweth:

**Respectfully Sheweth:**

1. That after getting through the ordeals and inquisition's of recruitment process and after being envisaged with competition examination carried through Provincial Public Service Commission, The appellant got recommended and thereafter appointed as Sub-Engineer's (BPS-11) in the Respondents Local Government & Rural Development Department Khyber Pakhtunkhwa, back in the year 2016 i.e. on 23-09-2016.
2. That since induction into service the appellant has left no stone unturned in the performing of his duties and furthering the common object of the Department with utmost devotion and dedication and because of the same there is no soot or sootage of any sort or any complaint , what so ever been lodged against any of the petitioners.
3. That the grievances the solace and redressal of whose, the appellant is seeking from this August Tribunal is the deprivation of the appellant of his due rights to the post of Assistant Engineer (BPS-17).
4. That before going to detailed out the facts and background of the instant lis, it would be appropriate to have a glimpse over the relevant Rules of the subject matter. The criteria for filling the post of Assistant Engineer (BPS-17) is given as under:

5. That now reverting back to the facts of the instant discourse. The appellant is Sub-Engineer (BPS-11) (later on upgraded to (BPS-12)) via Public Service Commission and are directly appointed as such and are thus initially appointed as Sub-Engineer. While at the same time Private Respondents were initially inducted into service as 'Work Monshi' (BPS-07).

It is pertinent to mention here, that Mr. Kitab Shah and Mr. Fazli Ahad were simply F.A passed and Mr. Shafiq-ur-Rehman was Matric(SSC) only and thus got inducted into service on 01-02-1193, 25-11-2005, and 03-05-2007 respectively. **(Copy of the Seniority List of the year 2021 showing the particulars is annexed as annexure "C")**

6. That no matter the promotion of the Private Respondents to the post of the Sub-Engineer (BPS-12) was illegal. But what happened later-on was such foul-some that finds no precedent in the history of this Department and all other Departments of Provincial Government in general.
7. That as submitted above, the criteria for filling the post of Assistant Engineer (BPS-17) is that 40% quota is reserved for Diploma holders Sub-Engineers with 5 year Experience and most have passed the Departmental "Grade-B" Examination, Now the dilemma is that one Shafiq-ur-Rehman who was just Matriculate (SSC),but is promoted as Assistant Engineer (BPS-17)which the other two are also dubious diplomas and none is eligible to have been promoted as Assistant Engineer.
8. That both the two Private Respondents brought their Diploma's allegedly issued in the year 2017 and 2018. But interestingly the same is not reflected in

the seniority list of 2021. Which suggest otherwise and raises questions upon the very credibility over the alleged Diploma's.

9. That when these Diplomas were procured by Private Respondents, the appellant instantly moved application against the same. In response to the application of the appellant verification of the diploma were sought from the concerned Board, who responded that the Diploma are obtained in Morning Session and that too of namely Kitab Shah and Fazle Ahad and not of Shafiq, so meaning thereby that he had no diploma up till that time. (Copies of application and verification record are annexed as annexure (D to F"))
10. That without seeking any study leave and without leaving office during class hours, how the Private Respondents acquired education in Morning Session and that too without any NOC? And the same question had been raised in "Mints of the Meeting", dated: ---11-2023, already annexed above.
11. That inspite of all this mess and anomalies, Departmental Promotion Committee (D.P.C) held its meeting on 30-01-2024 and recommended Private Respondents for promotion to the post of Assistant Engineer (BPS-17). Later on Notification dated: 05-03-2024 was issued where by the promotion order of the Private Respondents were notified and it was followed by Notification Dated 06-03-2024, whereby the posting orders of the private respondents were issued. It is pertinent to mention here that in the seniority list circulated in August 2024 the same Shafiq ur Rehman has been shown as just matriculate. (Copies of impugned Notification Dated: -05-03-2024, 06-03-2024. and Seniority List 2024 are annexed herewith as annexure "G, H & I" respectively)
12. That feeling aggrieved the Appellant moved repeated applications, but all badgers and inculcation's of the Appellant ended in fiasco and went futile. (Copy of Application is annexed as annexure "J").

13. That feeling highly aggrieved the appellant approaches this August Tribunal for striking down promotion order of the private Respondents and his due promotion, upon the following grounds, inter alia:

**Grounds:**

A. That it is a cherished principle of law that where a law requires a thing to be done in a particular manner, then the same is to be done in that manner and not otherwise.

B. That first of all the very promotion of the Private Respondents to the post of sub-engineers is illegal as without diploma they were promoted?

**Secondly** how, they been able to acquire Diploma and attended classes, when regularly performing duties and without any study leave and by receiving full salary as of normal during all that long period from 2013 to 2017 and 2018?

**Thirdly** there is no NOC or study leave application at all of any Private Respondents.

**Fourthly** even one Mr. Kitab Shah had been transferred to District Mohmand for two years during that interval then how he been able to regularly attend Office as well as attended classes of the Diploma?

**Fifthly** Mr. Shafiq-ur-Rehman is only SSC, then how he appeared in Departmental "Grade B" examination in 2021?

**Sixthly** the impugned seniority list (Annexure-K) was issued on 09-01-2024 and the Departmental Promotion Committee (D.P.C) held its meeting on 30-01-2024. Now without asking for submission of

objections/appeals/representation from petitioners and all other Sub-Engineers, the same highly disputed seniority list was taken into consideration and recommendation were made over the same, which is certainly illegal and void;

**Seventhly** how the private Respondents are promoted to the posts of Assistant Engineer and particularly Mr. Shafiq ur Rehman, who has no diploma at all, while the rest are having dubious diploma.

**Eighthly** vacant posts of the assistant engineer (BPS-17) are still there and only blue eyed are recommended and promoted at the cost of the appellant and the appellant are left without rim or reason.

- C. That neither the private respondents were eligible at all for promotion as sub-engineers, as only Matric and FA passed, nor as Assistant Engineers (BPS-17) as the very diplomas are highly doubtful and ambiguous and the same acts and omissions on part of the Respondents indispensably requires the indulgence of this August Tribunal in the matter on urgent basis, while one Shafiq ur Rehman has no diploma at all, but has been promoted as Assistant Engineer (BPS-17).
- D. That above all in the certificate issued by "Warsak Institute of Technology", it has been mentioned that Mr. Kitab Shah has acquired diploma in 2<sup>nd</sup> shift, which the board of technical education says that it was in morning session? So the very diploma is fake and concocted.
- E. That where the committee constituted for specific purpose of making inquiry into the matter, specifically asked for detail of study leave and N<sup>O</sup>C? Then when the same is not provided inspite of specifically been asked for, the DPC took its meeting and went out of its given mandate, as know scrutiny of documents was carried by DPC which is illegal and void.
- F. That above all there are still vacant post of assistant engineers (BPS\_17) lying vacant and the respondents inspite of the stark fact that they are bound to conduct DPC for filling up the same or should have filled the same via DPC of 30-01-2024 and thus exposes themselves to be brought to books of Law by this August court.
- G. That from all prospects the impugned DPC dated 30-01-2024 its mints, impugned recommendation for promotion, promotion orders of the private respondents and their posting as Assistant Engineer as well as placing them in the impugned Seniority List of 2024 Acts and omissions devoid any merit and Law and all are illegal and void altogether and are liable to be struck down.

H. That initially the Appellant has preferred Writ petition No 1819-P/2024 which was withdrawn to move the instant appeal before this Hon'ble Tribunal.

I. Any other ground will be raised at the time of arguments with prior permission of this Hon'ble Court.

*It is, therefore, most humbly prayed that on acceptance of this Service Appeal, the Hon'ble Tribunal may graciously*

- I. Struck down the impugned notification dated.05-03-2024;*
- II. Declare the promotions and posting orders of the private respondents as Assistant Engineer BPS-17 as illegal and void and to struck down the same;*
- III. Issue direction to the respondents to fill the vacant posts of assistant engineers BPS-17 lying vacant and are not being filled by respondents maliciously and to arranged a new and fresh DPC for the purpose in hands;*
- IV. Issue directions to the respondents to consider and promote the Appellant as the Assistant Engineers BPS-17 w.e.f 30-01-2024 i.e date of 1<sup>st</sup> DPC ,with all back benefits in terms of arrears and seniority*
- V. Any other relief deems fit and appropriate, not specifically asked for may also be granted in favor of the Appellant.*

- 1) That the petitioner is filling the accompanying service appeal, the contents of which may graciously be considered as integral part and parcel of the instant application.
- 2) That the Petitioner has got a good prima facie case, besides having balance of convenience tilt in his favor.
- 3) That Petitioner would suffer irreparable loss if the instant application is not allowed.

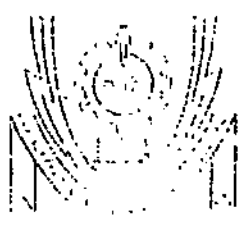



That have been enable to acquire the diplomas by ill means by managing the same thorough illegal means and now are posing themselves as diploma holder which all together fabricated ones that without seeking any study leave and NOC from **COMPETENT AUTHORITY** a big question mark arises upon their credibility and the credibility of their diplomas. Even if for the sack of arguments, the same diplomas are found to be having record, even then the same can never be termed as genuine. As how come one can get regular education while delivering services as regular employee of the government and that too without having any study leave are leave of any kind in his hands. Reference is invited to the subject cited above.

It is to inform you that the purpose of study leave is to provide an opportunity to the teachers to make them professional and skill in their school subjects whereas it has been observed that a number of cases during the year have been received where mostly teachers of all categories have got admission in irrelevant subjects or admission taken in those subjects which are not related to their present job/assignments. This sort of practice is contrary to the study leave rules/policy which is as under:-

- i) Study leave may be granted as additional leave to Government servants for the study of scientific, technical or similar discipline or in order to undertake special course of instructions.
- ii) Study leave should be granted with due regard to the exigencies of the public service.

The Competent Authority has taken a serious notice of the above said situation and has been pleased to direct as under:-

1. Departmental permission for taking admission should be given by the Competent Authority i.e. DPI (EE) upto BS-15 and from BS-16 to BS-18 DPI (SE) Punjab, Lahore prior to admission.
2. No Departmental permission for admission should be granted other than the subject for which he was recruited or in irrelevant subjects which are not related to their present job.
3. The admission in the campus constituted/established by the various Universities in various Cities as Distance Learning Centers may not be allowed.
4. Departmental permission in each case may invariably be sought well before the submission of the admission form to the University/ College otherwise study leave will not be sanctioned.
5. Prior to sanction of any kind of leave by the competent authority, the teacher will not be relieved from the station.
6. The concerned authorities should rout the cases through proper channel along with full justification/ recommendations.
7. Leave cases should reach the office of leave sanctioning authorities before commencement of leave.
8. In case of any violation of these instructions, the applicant /Officer forwarding the leave cases and relieving authority will be held personally responsible for the consequences.

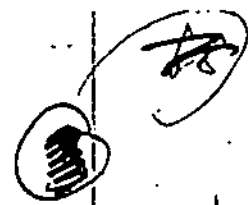

1. That the Petitioners are naturally born bonafide citizen of Islamic Republic of Pakistan and hails from respectable families across the Province Khyber Pakhtunkhwa.
2. That after getting through the ordeals and inquisition's of recruitment process and after being envisaged with competition examination carried through Provincial Public Service Commission, The petitioners got recommended and thereafter appointed as Sub-Engineer's (BPS-11) in the Respondents Local Government & Rural Development Department Khyber Pakhtunkhwa, back in the year 2016 i.e. on 23-09-2016.
3. That since induction into service yhe petitioners have lift no stone unturned in the performing their duties and furthering the common object of the Department with utmost devotion and dedication and because of the same there is no soot or sootage of any sort or any complaint , what so ever been lodged against any of the petitioners.
4. That the grievances the solace and redressal of whose, the petitioners are seeking from this August Court is the deprivation of the petitioners of their due rights to the post of Assistant Engineer (BPS-17).
5. That before going to detailed out the facts and background of the instant lis, it would be appropriate to have a glimpse over the relevant Rules of the subject matter. The criteria for filling the post of Assistant Engineer (BPS-17) is given as under:

6. That now reverting back to the facts of the instant discourse. The petitioner is Sub-Engineer (BPS-11) (later on upgraded to (BPS-12)) via Public Service Commission and are directly appointed as such and are thus initially appointed as Sub-Engineer. While at the same time Private Respondents were initially inducted into service as 'Work Monshi' (BPS-07).

It is pertinent to mention here, that Mr. Kitab Shah, and Mr. Fazli Ahad were simply F.A passed and Mr. Shafiq-ur-Rehman was Matric(SSC) only and thus got inducted into service on 01-02-1193, 25-11-2005, and 03-05-2007 respectively. (Copy of the Seniority List of the year 2021 showing the particulars is annexed as annexure "C")

7. That as Submitted earlier that two of the Private Respondents are only F.A and the one as Matric (SSC). But even then all three of them were promoted as Sub-Engineer, so how and under what mechanism. As for Non-Diploma holders Work Monshi, there is quota reserved up to 02% so it's almost impossible that all those three persons came through that narrowly laid down quota and that too on a single date i.e. 19-01-2016, so where is those people and Sub-Engineer's who came through rest of 98%? And even if one see the same seniority list the Sub-Engineer's listing at Serial No. 07 to 41 have been appointed on 08-06-2016 while from Serial No. 42 to 56 they have appointed on 16-09-2016. Meaning there by that as a whole 49 Sub-Engineer's have been appointed by way of initial appointment via 90% quota.

Now the question arises that how 04 Work Monshi (Non Diploma Holders) were elevated and promoted in total 53 posts of Sub-Engineer's and that too when one Shafiq-ur-Rehman had not even completed 10 years of services as well and when only there was 02% quota, so at the most only one person, namely Mr. Kitab Shah by way of seniority could be promoted? So the promotion of rest of the two Private Respondents namely Mr. Shafiq-ur-

Rehman and Mr. Fazle Ahad was illegal altogether. This was the first spate and slap against the rights of the petitioners.

8. That no matter the promotion of the Private Respondents to the post of the Sub-Engineer (BPS-12) was illegal. But what happened later-on was such foul-some that finds no precedent in the history of this Department and all other Department of Provincial Government in general.
9. That as submitted above, the criteria for filling the post of Assistant Engineer (BPS-17) is that 40% quota is reserved for Diploma holders Sub-Engineers with 5 year Experience and most have passed the Departmental "Grade-B" Examination; Now the bdiploa is that one Shafiq-ur-Rehman who was just Matriculate (SSC), brought an allege Diploma of Associate Engineering in the year 2023, while he allegedly passed the Departmental "Grade B" Examination in 2021? So its not appealable to any prudent mind that how a person was let to appear in examination when he was not eligible at all and that how that person was honored upon the basis of the same Examination?
10. That both the rest of the two Private Respondents brought their Diploma's allegedly issued in the year 2017 and 2018. But interestingly the same is not reflected in the seniority list of 2021. Which suggest otherwise and raises questions upon the very credibility over the alleged Diploma's.
11. That when these Diplomas were procured by Private Respondents, the petitioners instantly moved application against the same. In response to the application of the petitioners verification of the diploma were sought from the concerned Board, who responded that the Diploma are obtained in Morning Session. (Copies of application and verification record are annexed as annexure :D to F")
12. That without seeking any study leave and without leaving office during class hours, how the Private Respondents acquired education in Morning Session and that too without any NOC? And the same question had been raised in "Mints of the Meeting", dated: ---11-2023, already annexed above.

13. That in spite of all this mess and anomalies, Departmental Promotion Committee (D.P.C) held its meeting on 30-01-2024 and recommended Private Respondents for promotion to the post of Assistant Engineer (BPS-17). Later on Notification dated: 05-03-2024 was issued where by the promotion order of the Private Respondents were notified and it was followed by Notification Dated 06-03-2024, whereby the posting orders of the private respondents were issued. (Copies of impugned Mints of the Meeting Dated: 30-01-2024, Notification Dated: 05-03-2024 and 06-03-2024 are annexed herewith as annexure "G, H & I" respectively)

14. That feeling aggrieved the petitioners repeated application, but all badgers and inculcation's of the petitioners ended in fiasco and went futile. (Copy of Application is annexed as annexure "J")

15. That feeling highly aggrieved and having no other expeditious and adequate remedy available else-where the Petitioners approaches this August Court for recognition, acknowledgement and enforcement of their fundamental and vested rights, upon the following grounds, inter alia:

**Grounds:**

- A. That there exists no other expedient-cum-expeditious and adequate remedy available elsewhere, hence the instant petition under the extra ordinary jurisdiction of this August court.
- B. That the Petitioner is naturally born bonafide citizen of the Islamic Republic of Pakistan and are fully and equally, on equality basis, entitled to all basic and fundamental rights as enshrined in the fundamental law of the land, interpreted, guaranteed and enforced by the laws of the land and discrimination along with unfettered exercise of discretionary powers by an authority or office is always been deplored, deprecated and depreciated by Superior Courts of the land.

C. That it is a cherished principle of law that where a law requires a thing to be done in a particular manner, then the same is to be done in that manner and not otherwise.

D. That issue on odd in the instant case is not simply about seniority, promotion and related issues, but is about the void acts and omissions of the Respondents as in the former case, the same would have simply been about terms and conditions of services, where only the Hon'ble Khyber Pakhtunkhwa Service Tribunal has been mandated under Article-212 of the Constitution Of Islamic Republic of Pakistan 1973. But here the situation is totally different and the void actions and injustices done and carried by respondents can only be talked by this August Court under the mandate of powers vested in this Hon'ble Court in the form of issuing writ of Quo-warranto, Certiorari and Mandamus, hence the instant petition.

E. That first of all the very promotion of the Private Respondents to the post of sub-engineers is illegal as without diploma they were promoted?

Secondly how, they been able to acquire Diploma and attended classes, when regularly performing duties and without any study leave and by receiving full salary as of normal during all that long period from 2013 to 2017 and 2018?

Thirdly there is no NOC or study leave application at all of any Private Respondents.

Fourthly even one Mr. Kitab Shah had been transferred to District Mohmand for two years during that interval then how he been able to regularly attend Office as well as attended classes of the Diploma?

Fifthly Mr. Shafiq-ur-Rehman did his alleged Diploma in 2023, then how he approved in Departmental "Grade B" examination in 2021?

Sixthly the impugned seniority list (Annexure-K) was issued on 09-01-2024 and the Departmental Promotion Committee (D.P.C) held its meeting on 30-01-2024.

Now without asking for submission of objections/appeals/representation from petitioners and all other Sub-Engineers, the same highly disputed seniority list was taken into consideration and recommendation were made over the same, which is certainly illegal and void;

Seventhly vacant posts of the assistant engineer (BPS-17) are still there and only blue eyed are recommended and promoted at the cost of the petitioners and the petitioners are left without rim or reason.

- F. That neither the private respondents were eligible at all for promotion as sub-engineers as only Matric and FA passed, nor as assistant engineers (BPS-17) as the very diplomas are highly doubtful and ambiguous and the same acts and omissions on part of the Respondents indispensably requires the indulgence of this August Court in the matter on urgent basis.
- G. That above all in the certificate issued by "Warsak Institute of Technology", it has been mentioned that Mr. Kitab Shah has acquired diploma in 2<sup>nd</sup> shift, which the board of technical education says that it was in morning session? So the very diploma is fake and concocted.
- H. That where the committee constituted for specific purpose of making inquiry into the matter, specifically asked for detail of study leave and NOC? Then when the same is not provided inspite of specifically been asked for, the DPC took its meeting and went out of its given mandate as know scrutiny of documents was carried by DPC which is illegal and void.
- I. That above all there are still vacant post of assistant engineers (BPS\_17) lying vacant and the respondents inspite of the stark fact that they are bound to conduct DPC for filling up the same or should have filled the same via DPC of 30-01-2024 and thus exposes themselves to be brought to books of Law by this August court.
- J. That from all prospects the impugned DPC dated 30-01-2024 its mints, impugned recommendation for promotion, promotion orders of the private respondents and their posting as Assistant engineer as acts of acts and omissions devoid any merit and Law and all are illegal and void altogether and are liable to be struck down.

- V. *To issue directions to the respondents to acts according to law and not to do anything, which by law they are not supposed to do;*
- VI. *To issue direction to the respondents to fill the vacant posts of assistant engineers BPS-17 lying vacant and are not being filled by respondents maliciously and to arranged a new and fresh DPC for the purpose in hands;*



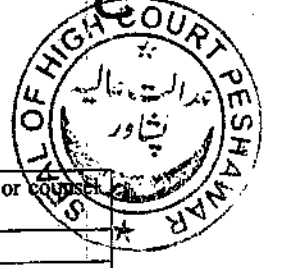
