That the appellant was promoted from Junior Scale Stenographer BPS-14 to the post of Senior Scale Stenographer BPS-16, in the office of the respondent No.3 on the recommendation of the Departmental Promotion Committee Meeting held on 10/7/2024. (Copy of the Office Order dated 11/7/2024 is attached as annexure A).
2. That thereafter the respondent No.4 filed a Departmental Appeal against the said promotion order of the appellant dated 11/7/2024 before the respondent No.2 on 25/7/2024, without arrange the appellant as a party in the said Departmental Appeal.(Copy of the departmental appeal dated 25/7/2024 is attached as annexure B).
3. That respondent No.2 sought comments from respondent No.3 vide Notice dated 24/7/2024.(Copy of the Notice dated 24/7/2024 is attached as annexure C).
4. That respondent No.3 submitted comments.(Copies of the comments along with annexure are attached as annexure D).
5. 
Para wise reply on behalf of respondent is as under:-

PRELIMINARY OBJECTION:-

1. That no fundamental rights of the appellant have been infringed.
2. That the appellant has got no cause of action that he has been included in the Seniority list of the Computer operators of BPS-16 of finance department Khyber Pakhtunkhwa vide seniority list stood on 24-05-2022 and 24-07-2024.
3. That the appellant has not come to this Honorable Court with clean hands
4. That the Appeal of the Appellant is not maintainable in the eye of law.
5. That the appellant has no locus standi to file the appeal in hand.

ON FACTS:


1. Correct to the extent that the appellant is serving in the office of Assistant Commissioner Adenzai but he is on the strength of District Finance Department under the Supervision of the respondent.
2. Correct.
- 3/5. Correct to the extent that in light of the policy one Junior Scale Stenographer was promoted to the scale of Senior Scale Stenographer. So far promotion of the present Senior Scale Stenographer BPS-16 is concerned, panel of candidates amongst the computer operators and Junior Scale Stenographer was prepared for scrutiny by the Departmental Promotion and Selection Committee in which the name of the appellant was included. The Departmental Promotion Committee has thoroughly scrutinized all the rules of promotion as well as seniority list of Computer operators as well as Junior Scale Stenographer working under the control of the respondent.

During Scrutiny it was noticed that the appellant Mr. Muhammad Farooq Shah was found included in two Seniority Lists i.e Seniority list of this office stood on 11-01-2024 while in the Seniority list of Finance Department stood on 24-05-2021 and 24-07-2024 (**Annex-A, B and C**) respectively. According to the Seniority list of this office stood on 11-01-2024 Mr. Farooq Shah is at serial No.01 while at the Seniority List of Finance Department he is at S.No.39 and 43 while another official namely Nawab Uddin computer operator Finance Department has been enlisted at S.No 10 and 13 of the Seniority List of the Finance Department who is most senior to the appellant. In this regard it is pertinent to mention here that the seniority list of this office stood on 11-01-2024 has been challenged one Mr. Farukh Zia vide application dated 10-06-2024 on the grounds that the computer operators including the appellant has been included in the seniority list of this office from Finance Department, which has been sent by the respondent vide letter No.7193/Estt dated 13-06-2024 (**Annex-D**) to the Worthy Commissioner Malakand Division for opinion. It was further discussed by the DPC members that the Govt has framed clear promotion rules vide notification No.SO(A)/3-7/88/FMIU/vol-I dated 30-03-2021(**Annex-E**) for computer operators enlisted in the seniority list of finance department and the present appellant has been included in the Seniority lists of Finance Department mentioned above. It was further observed that not only separate rules for promotion of computer operators working in finance department has been framed by the Govt but one Mr Nawab uddin was found senior from the appellant. Similarly one Farukh Zia has also challenged the status of the appellant being shown senior in the seniority list of the DC office which is also under consideration. Besides the above during scrutiny of the seniority lists of computer operators etc the next candidate Mr. Farukh Zia was found at S.No.529 of the list of Assistant stood on 31-12-2022 issued by the Board of Revenue, Govt of Khyber Pakhtunkhwa Peshawar (**Annex-F**). As on one hand the appellant has been enlisted in the seniority list of finance department for whom a separate promotion rules to the post of Assistant Director has been framed by the Govt, while on the other hand his seniority in this office has been challenged by the next candidate Mr. Farukh Zia.

As the seniority list of the Junior Scale Stenographer was found crystal clear by the DPC members and the Junior Scale Stenographer namely Salah Ud Din already working against the post of Senior scale Stenographer from the last more than eight years was recommended for promotion to the post of Senior Scale Stenographer by the DPC and the Respondent being Chairman of the DPC has promoted Mr. Salah Ud Din Junior Scale Stenographer vide impugned order on the basis of facts mentioned above.

6. Correct to the extent that the name of Farukh Zia Computer Operator was included at S.No.02 of the panel of computer operator as evident from the working paper but during scrutiny and detailed discussion it was noticed by the DPC members that one Farukh Zia Computer Operator filed writ petition in the Peshawar High Court bench Darul Qaza Swat with the request to include his name in the list of Assistant and accordingly the Honorable Court has considered his request and ordered for enlistment of his name in the seniority list of Assistants and in compliance the Board of Revenue has enlisted his name at S.No.529 of the seniority list mentioned above.
 7. Totally incorrect. The claim of the petitioner is totally baseless as explained at para 3/5 and based on malafide and presumption.
 - 8/9. Incorrect. The DPC members including the representative of Board of Revenue have unanimously decided to promote Mr. Salah Ud Din Junior Scale Stenographer BPS-14 to the post of Senior Scale Stenographer BPS-16, the note of Board of Revenue mentioned at S.No.IV of the minutes of the DPC has clearly shown that the seniority of Computer operators is disputed regarding which advice is awaited from Board of Revenue which support the promotion of Mr Salah uddin Junior Scale Stenographer **(copy of minutes attached Annex-G)**.
- As the seniority between the computer operators including the appellant was found disputed, similarly the seniority of next candidate Mr Farukh Zia was found not only disputed but his name was noticed enlisted in the seniority list of Assistants issued by the Board of Revenue and Mr, Jami Ur Rehman being disinterested in his promotion and have given written to Mr. Salah Ud Din in this regard (copy attached), therefore, the DPC members have unanimously recommended Mr. Salah Ud Din Junior Scale Stenographer to the post of Senior Scale Stenographer BPS-16.




It may mention for kind information that the Finance Department has framed separate rules in terms of service structure toward further promotion of computer operator in shape of Assistant Director (IT) BPS-17; hence it is presumed that the computer operator of Finance Department will be eligible for promotion to Assistant Director (IT) BPS-17. On the other hand the computer operators of District Revenue Administration are eligible to be promoted to the post of Senior Scale Stenographer. In the circumstances the petitioner/ appelland is not entitled for promotion of Senior Scale Stenograhper under the policy.

It is humbly prayed that on acceptance of the instant para wise reply, the appeal of the appelland may kindly be dismissed please.

Opening the discussion, the Chair Welcomed the participants and highlighted aims of meeting, followed by cross discussion on the subject matter as is below:



After promulgation of the above referred Notification, this is the first instance for promotion of the Computer Operator and Junior Scale Stenographer to the post of Senior Scale Stenographer, hence the committee thoroughly examined all angles and pointed out the following worth considerable points:

- i) There is no clear cut Rules in the Notification referred to select senior most from both the cadres in first instance. This is worth mentioning that the Computer Operators have been accommodated in the share of Stenographers, therefore, it would be appropriate option to avail the opportunity by Stenographer.
- ii) Promotion of Computer Operator (BPS-16) to Senior Scale Stenographer (BPS-16) is just to change cadre/nomenclature of the probable candidate. On the other hand, promotion of the Junior Scale Stenographer (BPS-14) carries meaningful results.

- iii) The seniority list of Computer Operator is disputed while seniority list of the Junior Scale Stenographer is crystal clear. So far delaying/deferring of the DPC till the final outcome of final seniority lists of the Computer Operators, forum agreed upon that since finalization/clearance of the disputed seniority list will take indefinite period of time due to which the probable Junior Scale Stenographer who is on verge of retirement will suffered tremendously.
- iv) The representative of Board of Revenue Khyber Pakhtunkhwa suggested that due to seniority dispute between the Computer Operators that advise obtained from the Board of Revenue as the same has already been sent to Commissioner, Malakand Division for clarification but the reply is awaited.
- v) The setting Junior Scale Stenographer has served against the same post for more than 08 years.

Recommendations:

In view of the situation explained above, the forum unanimously decided to promote Mr. Salahud Din, Junior Scale Stenographer (BPS-14) to the post of Senior Scale Stenographer (BPS-16) however agreed upon that during the next DPC for promotion to the Senior Scale Stenographer be the Computer Operator will avail the opportunities as per the 50/50 share/quota of the Computer Operator and Junior Scale Stenographer.

The meeting ended with the vote of thanks from the chair.

This is an appeal filed by the appellant Muhammad Farooq Shah Computer Operator office of the Deputy Commissioner, District Dir Lower against his order dated 11.07.2024, whereby on recommendation of Departmental Promotion Committee meeting held on 10.07.2024 Mr. Salah uddin Stenographer has promoted to the post of Senior Scale Stenographer. Aggrieved from this, the appellant preferred the instant appeal.

The appellant as well as departmental representative was present. They submitted written reply and Para-wise comments offered by the Deputy Commissioner Dir Lower along with record was perused. From perusal of the record and written statements of the parties, this court reached to the conclusion that two Junior Scale Stenographers have already availed their quota as per rules, whereas in the recent DPC the due share of Computer Operator was not considered for promotion and instead Junior Scale Stenographer was promoted again, which is in sheer violation of rules.

An advice from Board of Revenue, Revenue & Estate Department, Peshawar also awaited regarding seniority of Computer Operators. Hence, DPC dated 10.07.2024 is declared as null and void to the extent of promotion of 50% quota of computer operator where a Junior Scale Stenographer Mr. Salah Uddin has been promoted. Deputy Commissioner, Dir Lower is directed to conduct fresh DPC after getting advice from the Board of Revenue, Revenue & Estate Department, Peshawar.
