**Service Appeal u/s 4 of Khyber Pakhtunkhwa Service Tribunal Act, 1974 against the order dated 28-06-2024 whereby the appellant was transferred to G.G.H.S Shabqadar, Charsadda from G.G.H.S Jogiwara Peshawar.**

**Respectfully Sheweth:**

1. That the appellant is a Master's degree holder in the subject of Economics. She was initially appointed as a Subject Specialist in Economics at G.G.H.S.S Hatyan, Mardan, on a contract basis and was subsequently regularized.  
**(Copy of the initial appointment letter of the appellant is annexed as "Annex-A.")**

2. That the appellant was transferred to G.G.H.S.S Lady Griffith, Peshawar, vide order dated 21-03-2014, and she duly assumed charge of her position.

3. That the appellant was promoted from BPS-17 to BPS-18 vide notification dated 19/02/2024, and was transferred and posted as Principal (BPS-18) at G.G.H.S.S Junglekhel, District Kohat, against a vacant post.....

**(Copy of the promotion order is annexed as "Annex-B.")**

4. That, despite the promotion, the Principal at G.G.H.S.S Junglekhel refused to vacate the post, and as a result, a corrigendum was issued on 21/03/2024, transferring the appellant to G.G.H.S.S Jogiwara, Peshawar, as Senior Subject Specialist (Economics) BPS-18, subject to the condition that she would assume charge after the incumbent vacated the post. The appellant finally assumed charge at G.G.H.S.S Jogiwara on 08/06/2024.

**(Copies of the corrigendum and the certificate of charge transfer are annexed as "Annex-C" and "Annex-D.")**

5. That, astonishingly, within 20 days of taking charge at G.G.H.S.S Jogiwara, the respondents issued a transfer order on 28/06/2024, transferring the appellant from G.G.H.S.S Jogiwara to G.G.H.S.S Shabqadar, Charsadda.

**(Copy of the transfer notification dated 28/06/2024 is annexed as "Annex-E.")**

6. That the appellant immediately filed a representation/departmental appeal against the impugned transfer order with Respondent No. 2, but no action has been taken by the competent authority to date.

**(Copy of the departmental appeal is annexed as "Annex-F.")**

7. That being aggrieved by the impugned transfer order dated 28/06/2024, the appellant respectfully submits this appeal before this Honorable Tribunal, challenging the order on the following grounds:

**G R O U N D S :**

a. **Because** the Appellant is an aggrieved person within the meaning of Article 212 of the constitution of the Islamic Republic of Pakistan 1973 in respect of her terms and conditions of service, and is by the transfer and Posting policy of the Government of Khyber Pakhtunkhwa. The transfer of the appellant is without any shade of a doubt premature and in absolute disdain and disregard of the tenure for serving in the Provincial Civil Service. The posting policy lay as under:

Government servants including District Govt. employees feeling aggrieved due to the orders of posting/transfer authorities may seek remedy from the next higher authority / the appointing authority as the case may be through an appeal to be submitted within seven days of the receipt of such orders. **Such appeal shall be disposed of within fifteen days.** The option of appeal against posting/ transfer orders could be exercised only in the following cases.

i) Pre-mature posting/transfer or posting transfer in violation of the provisions of this policy.

A. **Because** the Fundamental Rights of the Appellant has been violated in relation to Article 4, 8, 9, 18 & 25 of the Constitution of the Islamic Republic of Pakistan, 1973. This Honorable forum being the custodian of the Rights of citizens of Pakistan as enshrined in the law of the land made in

furtherance of the rights and the protections afforded by the Constitution of Islamic Republic of Pakistan, 1973, is why the Appellant seek the redressal of her grievances.

- B. **Because** the decision of transfer taken on the basis of nepotism and political approach are all based in a nullity in the eyes of the law as it goes in direct negation of the provisions of law. Furthermore, when the base is wrong and rooted in a nullity any superstructure built on the base is wrong. The principle laid down through PLD 1958 SC 104 has been reiterated in PLD 2022 SC 119, 2021 SCMR 637, PLD 2007 SCMR 1835, which essentially forms part of our jurisprudence.
- C. **Because** the transfer of the appellant within 20 days of her assuming the post at G.G.H.S.S Jogiwara is arbitrary and without any valid reason. The frequent transfers of the appellant demonstrate a violation of her right to a stable and conducive working environment, contrary to the government's transfer policies and service regulations.
- D. **Because** the appellant has been subjected to multiple transfers within a short period of time, which is contrary to established principles of transfer and posting, as per service rules. Such frequent transfers are detrimental to her professional stability and career growth. The absence of any administrative reasons for the transfer points toward malafide intention and abuse of discretionary powers by the respondents.
- E. **Because** the impugned transfer order reflects malafide intent and an abuse of administrative authority. The appellant was just recently transferred to G.G.H.S.S Jogiwara after a corrigendum, and within 20 days, she was transferred again without any valid reason. The arbitrary use of discretionary powers is clearly evident and appears to be

punitive in nature.

**F. Because** the appellant, being a Senior Subject Specialist in Economics (BPS-18), has a right to professional stability and a conducive working environment for her career growth. The frequent and unjustified transfers disrupt her ability to effectively perform her duties, causing unnecessary professional and personal hardship. The transfer also affects the students and institution, as the appellant was settling into her role.

**G. Because** The Rules designate certain posts as 'tenure posts' (rule 22 read with Schedule IV of the Rules) and prescribe a period of three years for an incumbent to serve on such posts. Such prescribed tenure may therefore be categorized as the ideal duration for which a civil servant should serve at a particular post. The post of the appellant is a tenure post, yet she has been transferred from her posting before the tenure was complete. Thus, the appellant having not been allowed to complete her normal tenure and the appellant was transferred three times prematurely on the basis of political approach and thus the order impugned dated 28-06-2024 is violation of transfer posting policy of the Government and the judgments of the apex court reported in PLD 1995 SC Page No 530 and PLD 2013 Supreme Court Page No. 195.

**H. Because** recently the august Supreme Court of Pakistan has in its Judgment reported in 2013 PLD SC 195, decided a point of law and while committing upon the transfer and posting and other related matters of service held as under:-

**Appointments, Removals and Promotions:-**

Appointments, removals and promotions must be made in accordance with the law and the rules made there under; where no such law or rule exists and the matter has been left to discretion, such discretion must be exercised in a

structured; transparent and reasonable manner and in the public interest.

**Tenure, posting and transfer:** When the ordinary tenure for a posting has been specified in the law or rules made there under; such tenure must be respected and cannot be varied, except for compelling reasons, which should be recorded in writing and are judicially reviewable.

**Illegal Orders:** Civil servants owe their first and foremost allegiance to the law and the Constitution. They are not bound to obey orders from superiors which are illegal or are not in accordance with accepted practices and rule, based norms; instead, in such situations, they must record their opinion and; if necessary, dissent.

**O.S.D Officers** should not be posted as OSD except for compelling reasons, which must be recorded in writing and are judicially reviewable.

- a. As opposed to the above requirement of reasons to be recorded in writing, no such reason has been given in the transfer orders, which makes the same judicially reviewable and bound to be recalled.

I. **Because** Section 10 of the Khyber Pakhtunkhwa Civil Servants Act states as follows:

1. "Every civil servant shall be liable to serve anywhere within or outside the Province in any post under the Federal Government, or any Provincial Government or local authority, or a corporation or body set up or established by any such Government;
2. Provided that nothing contained in this section shall apply to a civil servant recruited specifically to serve in a particular area or region;

3. Provided further that where a civil servant is required to serve in a post outside his/her service or cadre, his/her terms and conditions of service as to his/her pay shall not be less favorable than those to which he would have been entitled if he had been so required to serve."
- b. The previously mentioned section does not empower the Government to cut short the normal tenure of a posted/transferred civil servant, and particularly without assigning any reason. In the case of Mahmood Akhtar Naqvi (Anita Turab case) (above) this Court held: "16. In the Hajj Corruption Case, the court reiterated its earlier ruling in Zahid Akhtar v. Government of Punjab (PLD 1995 SC 530), where it had been held that
1. "the normal period of posting of a Government servant at a station, according to Rule 21 of the Rules of Business is three years, which has to be followed in the ordinary circumstances, unless for reasons or exigencies of service a transfer before expiry of the said period becomes necessary in the opinion of the competent authority." Furthermore, with regard to transfers of civil servants, the Court has stated that transfers by political figures, which are not legally sustainable. Farrukhgulzar v. Secretary Local Government and Rural Development Department, Lahore and 2 others (1998 SCMR 2222). These are principles of law

enunciated by the court and are to be followed in terms of Article 189 of the Constitution. We, however, repeatedly come across violations of such principles. This unnecessarily leads to litigation which, in turn, clogs Courts and Service Tribunals."

- J. **Because** the appellant ran from pillar to post to get justice but all in vain as the appellant has no political connections and thus she has been subjected to victimization and nepotism by the respondents.
- K. **Because** the impugned transfer order dated 28-06-2024 is a flagrant violation of the transfer & posting policy of the Provincial Govt is illegal and also based on Malafide intentions hence liable to be set aside.

- L. **Because** the appellant seeks leave of this Honourable Tribunal to raise further points at the time of arguments, with the kind permission of this Honourable Tribunal.

**It is, therefore, most humbly prayed that on acceptance of this appeal the impugn transfer order dated 28-06-2024 issued by the respondents may kindly be declared as illegal, unlawful, without lawful authority, void ab initio and of no legal effect and the same may kindly be set aside and respondents may kindly be directed not to transfer the appellant from G.G.H.S.S Jogiwara to G.G.H.S.S Shabqadar.**

**Any other relief deems fit appropriate in the circumstances may also be granted.**



**Subject: POSTING /TRANSFER POLICY OF THE PROVINCIAL GOVERNMENT.**

I am directed to refer to the subject noted above and to say that in supersession of all policy instructions issued in this behalf, the competent authority has approved the following posting Transfer Policy.

- i. All the postings /transfers shall be strictly in public interest and shall not be abused misused to victimize the Government servants.
- ii. All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting /transfer authorities for seeking posting /transfers of their choice and against the public interest.
- iii. All contract Government employees, appointed against specific posts, cannot be posted against another post.
- iv. The normal tenure of posting shall be three years subject to the condition that for the officers /officials posted in unattractive areas, the tenure shall be two years and for hard areas the tenure shall be one year. The unattractive and hard areas will be notified by the Government.
- v. Months of March and July are fixed for posting /transfer of the officers /officials excluding the officers in B-19 and above in the Province. Posting /transfer in Education and Health Departments shall be made in March while the remaining Departments shall make posting /transfers in July. There shall be a ban on posting/transfers throughout the year excluding the aforesaid two months. However, there shall be no restriction in cases where posting /transfer of Government employees become inevitable in other months due to promotion /retirement /creation of new posts/return from long leave/involvement in

disciplinary proceedings and adjustment of surplus staff for which specific relaxation shall be obtained from the Chief Minister.

vi. While making postings transfers from settled areas to FATA and vice versa specific approval of the Governor, NWFP needs to be obtained.

vii. Officers may be posted on executive /administrative posts in the Districts of their domicile except District Coordination Officers (D.C.Os) and Superintendent of Police (SP). Similarly Deputy Superintendent of Police (DSP) shall not be posted at a place where the Police Station (Thana) of his area /resident is situated.

viii. No postings /transfers of the officers/officials on detailment basis shall be made.

ix. Regarding the posting of husband /wife, both in Provincial services, efforts where possible would be made to post such persons at one station and this will be subject to the public interest.

x. All the posting /transferring authorities may facilitate the postings /transfers of the unmarried female Government Servants at the station of the residence of their parents.

xi. Officers /officials except DCOs and SPs who are due to retire within one year may be posted on their option, on posts in the Districts of their domicile and be allowed to serve their till the retirement.

xii. In terms of Rules-17 (1) and (2) read Schedule-III of the Government of NWFP Rules of Business 1985, transfer of officers shown in column 1 of the following table shall be made by the authorities shown against.

xiii. While considering postings /transfers proposals all the concerned authorities shall keep in mind the following:

- a. To ensure the posting of proper persons on proper posts., the annual confidential reports, past and present record of service, performance on post held presently and in the past and general reputation with focus on the integrity of the concerned officers/officials be considered.
- b. Tenure on present post shall also be taken into consideration and the posting transfers shall be in the best public interest.

ix) Government servants including District Govt. employees feeling aggrieved due to the orders of posting/transfers authorities may seek remedy from the next higher authority/the appointing authority) as the case may be through an appeal to be submitted within seven days of the receipt of such orders. Such appeal shall be disposed of within fifteen days. The option of appeal against posting /transfer orders could be exercised only in the following cases:-

- i) pre-mature posting/transfer or posting/transfer in violation of the provisions of this policy.
- ii) Serious and grave personal (humanitarian) grounds.

To streamline the postings /transfers in the District Government and to remove any irritant/confusions in this regard the provision of Rule 25 of the North- West Frontier Province District Government Rules of Business 2001 read with schedule -IV thereof is referred. As per schedule -IV the posting/transferring authorities for the officers /officials against each are as under :-
