PRELIMINARY OBJECTIONS.

- 1. That the appellant has got no cause of action/locus standi.
- 2. That the Appellant has concealed material facts from this Hon'ble Tribunal.
- 3. That the appellant has been estopped by his own conduct to file the instant appeal before this Hon'ble Tribunal.
- 4. That the instant appeal is badly time barred.
- 5. That the instant appeal is not maintainable in its present form.
- 6. That the instant appeal is bad for mis-joinder and non-joinder of the necessary and proper parties.
- 7. That the appellant has not come with clean hands to this worthy Tribunal.
- 8. That the appellant does not come in the definition of Aggrieved Person.
- 9. That the instant appeal barred by law.

ON FACTS.

- 1. That Para No.1 is correct to the extent that appellant was appointed by the Respondent Department as Sweeper while rest of the Para pertains to record.
- 2. That in reply to Para No. 02, it is submitted that appellant was charged in F.I.R No.873 dated 11-11-2021 under Section-324/337-F-VI PPC Police Station Mathra Peshawar.

That in light of aforesaid F.I.R, the Respondent Department vide Endst No. 80-83 dated 04-03-2022, suspended the appellant from service till the final decision of the Court.

(Copy of Suspension order is attached as Annex-A)

3. That in reply to Para No. 03 & 04, it is submitted that the Hon'ble Court of Additional Sessions Judge Peshawar convicted the appellant for 07 years rigorous imprisonment in F.I.R No. 873 dated 11-11-2021 under Section-324/337-F-VI PPC. Howover, the Hon'ble Peshawar High Court Peshawar reduced the aforesaid sentence to 04 years rigorous imprisonment and reduced the fine from 10 lacs to 05 lacs.

Therefore, on conviction of the appellant, the Respondent Department under the Khyber Pakhtunkhwa Removal From Service (Special Powers) Ordinance, 2000 vide Endst No. 10995-11001 dated 13-06-2024, removed the appellant from service.

5. That in reply to Para No. 05 it is submitted that the appellant had no casue of action/locus standi therefore, his Departmental Appeal was rejected.

6. That in reply to Para No. 06 it is submitted that the appellant has no casue of action/locus standi to file the instant appeal before this worthy Tribunal.

Grounds:

- A. That Ground-A is incorrect, misleading and against the facts. The detail reply has been given in the above Para of facts.
- B. That Ground- B is incorrect, misleading and against the fact. The Respondent Department has acted according to law, rules and policy in the best interest of public.
- C. That Ground- C is incorrect, misleading and against the fact. The Respondent Department has acted according to law, rules and policy in the best interest of public.

It is therefore; very humble prayed that on acceptance of this reply, the instant appeal may very kindly be dismissed with cost.
