

PARAWISE REPLY BY RESPONDENT NO.02

Respectfully Sheweth,
Preliminary Objections.

1. That the appeal is badly barred by Law & limitation.
2. That the appellant has got no cause of action and locus standi to file the present appeal.
3. That the appeal is bad due to mis-joinder and non-joinder of necessary parties.
4. That the appellant has not come to the Honorable Tribunal with clean hands.
5. That the instant appeal is not maintainable in its present form.
6. That the appellant has concealed the material facts from this Hon'ble Tribunal.

FACTS:

As per report received from RPO/ Malakand vide his office Letter No. 12012/WPC dated 07.10.2024 (**Annexure-R**), the factual position of the case is as under;

- I. Pertains to record.
- II. Pertains to record.
- III. Pertains to record.
- IV. Correct to the extent regarding the representations of some of PASIs of 2010 batch, the Committee was constituted by the Region Office Malakand to look into List-E seniority of PASIs and ASIs as per Police Rules. Upon recommendation/ decision of Committee, PASIs of batch 2010 were confirmed as ASIs from the date of their initial appointment while they were placed at List-E after completion of their probation period as per Police Rules.
- V. Pertains to record, hence, needs no comments.
- VI. Pertains to the record of this Hon'ble Tribunal, hence, needs no comments.
- VII. Para to the extent of utter surprise of the appellant is totally ill-based rather a whimsical one as the appellant had just in his mind regarding his seniority while totally ignorant regarding the relevant rules. Moreover, in order to streamline the issue of seniority list of DSPs, Inspectors and Sub-Inspectors on promotion List-F and to mention the same in light of direction issued vide letter No.CPO/CPB/63 (**Annexed-A**) and No.CPO/CPB/64 dated 13/02/2023 (**Annexed-B**), so, as to resolve the issue once for all. As most of the Police Officers had/have approached this Honorable Tribunal in terms of their

grievances regarding seniority and such litigation was increasing day by day. Hence, in pursuance of said directions, information received from all RPOs and CCPO, seniority list "F" was prepared in light of Police Rules 1934 Chapter 12 Rule 2 sub rule 3 which is re-produced as under:-

"All appointments of enrolled police officers are on probation according to the rules in this Chapter applicable to each rank."

Seniority, in the case of upper subordinates, will be reckoned in the first instance from date of first appointment, officers promoted from a lower rank being considered senior to persons appointed direct on the same date, and the seniority of officers appointed direct on the same date being reckoned according to age. Seniority shall, however be finally settled by dates of confirmation, the seniority inter se of several officers confirmed on the same date being that allotted to them on first appointment. Provided that any officer whose promotion or confirmation is delayed by reason of his being on deputation outside his range or district shall, on being promoted or confirmed, regular, the seniority which he originally held vis-a-vis any officers promoted or confirmed before him during his deputation.

The seniority of lower subordinate shall be reckoned from dates of appointment, subject to the conditions of rule 12.24 and provided that a promoted officer shall rank senior to an officer appointed direct to the same rank on the same date".

Therefore in light of seniority list "E" provided by all RPOs/CCPO a combine seniority of Sub Inspectors was issued vide letter No.32/E-II/CPO/F list/seniority dated 24/01/2024 (Annexed-C) according to which the seniority was maintained to resolve the issue once for all.

- VIII. Already explained above at Para No. 07 of Facts.
- IX. Incorrect. The appellant has got no cause of action seniority of appellant has rightly been fixed with his colleagues strictly in accordance with law.
- X. That CPO, Peshawar again issued revised seniority of Sub Inspectors on list "F" of Khyber Pakhtunkhwa vide CPO, Peshawar Endst: No.32/E-II /CPO/F list/seniority dated 24/01/2024 on the basis of 13.18 of Police Rules 1934 and consequently, as per recommendation DPC meeting held on 25/01/2024 at CPO, Peshawar confirmed Sub Inspector of Khyber Pakhtunkhwa on list "F" were promoted to the rank of Offg. Inspectors (BPS-16) with immediate effect vide Notification No.48/CPO/E-II/Promotion, dated 25/01/2024 (Annexed-D).
- XI. That initially in order to create a parity between the dates of confirmation of ASIs appointed direct (PASIs) and those of the ASIs promoted from ranks (Ranker ASIs), a Letter was issued vide No.CPO/CPB/317, dated 18-12-2022 (ANNEX-E), however, that was accordingly withdrawn being against the letter and spirit of Police Rules 12-8, 19-25(5) of Police Rules, 1934, in case of PASIs and against the Police Rules 13-18 of the Police Rules, 1934 in case of the ASIs promoted from ranks (Ranker ASIs). The following was laid down in the said letter, "a. All PASIs in on successful completion of 03 years period shall be brought on promotion list "E" from the date of appointment. b. All ASIs promoted from lower rank shall be brought on promotion list

"E" after successful completion of 02 years' probation period date of officiating promotion". Therefore, in order to follow the true spirit of Police Rules 12-8 and 19-25(5) of Police Rules, 1934, all Regional Police Officers were directed to register that the date of appointment and the date of confirmation of an ASIs appointed direct (PASIs) are not the same, as has been misconceived by many, but are different from each other: date of confirmation falls after three years of the date of appointment in case of an ASIs appointed direct (PASIs) and the same (date of confirmation) falls after two years in case of an ASIs promoted from ranks (Ranker ASI) according to Police Rules 12.8 and 13.8 of the Police Rules 1934 respectively. Furthermore, the relevant authorities were also directed to withdraw changes brought in List-E in compliance with Letter No.CPO/CPB/317 dated 08.12.2022 and revise the List-E of respective regions and substitute all those date of confirmation of all ASIs appointed direct (PASIs) which were fixed retrospectively from the date of their appointment with those falling after the termination of the period of their probation for three years. Furthermore, The two rules (12-8 and 19-25(5) of the Police Rules, 1934) clearly state that PASIs (ASIs appointed direct) shall be on probation for a period of three years after their appointment as such and that they may be confirmed in their appointments (appointments of being as ASI) on the termination of the prescribed period of probation of three years with immediate effect not with retrospective effect, i.e., from the date of their appointment by the Range Deputy Inspector General of Police on the report of their respective District Police Officer provided they have completed the period of their probation of three years successfully in terms of the condition laid down in the Police Rule 19-25(5) of Police Rules, 1934. Moreover, under Paragraph IV of the Promotion Policy provided in ESTA CODE Establishment Code Khyber Pakhtunkhwa (Revised Edition) 2011, "Promotion will always be notified with immediate effect." Drawing analogy from this rule, all PASIs might be so confirmed on conclusion of probationary period of three years with immediate effect (the date on which order of their confirmation is issued). The Supreme Court of Pakistan underlined the difference between the date of appointment and date of confirmation in Mushtaq Waraich Vs IG Punjab (PLD 1985 SC 159) in a recent Judgment vide SCMR 2023 584, the Apex Court has held that "reliance on Qayyum Nawaz [a Judgment of the Apex Court, report as 1999 SCMR 1594] that there is no difference between that date of appointment and date of confirmation under the Police Rules is absolutely misconceived and strongly dispelled". The Apex Court has further explained Police Rule 12-3(3) of Police Rules, 1934 and declared that the final seniority of Officers will be reckoned from the date of confirmation of the officer not from the date of appointment. The Honorable Court further held that "the practice of ante-dated confirmation and promotions have been

put down in Raza Sardar Kazmi" (a Judgment of the Punjab Service Tribunal dated 15-08-2006, passed in Appeal No. 239/2006 and upheld by the Supreme Court vide Order dated 29-01-2008, passed in Civil Appeal No. 2017 to 2031 of 2006 and other connected matters). Therefore, PASIs on completion of three years' probation period shall not brought on promotion List-E from date of appointment. Their name is brought on the promotion List-E in the manner provided in Police Rules 13-10 and 13-11 of the Police Rules, 1934 not from the date of appointment but from the date of confirmation which, essentially, is a date different from their dates of appointment and compulsorily falls on the termination of the period of their probation for three years under Police Rules 12-8 and 19-25(5) of Police Rules, 1934.


XII. Being member of discipline Force, there is special rules in shape of Police Rules, 1934, the Khyber Pakhtunkhwa Police Act, 2017 and Standing Orders which deal with promotion from one rank to the next higher rank and confirmation in the substantive rank after fulfilling requisite criteria/mandatory periods for the subject purpose, therefore, the instant appeal may kindly dismissed on the following grounds amongst the others;

GROUNDS

- a. Incorrect. Being member of disciplined force, there is special rules in shape of Police Rules, 1934, the Khyber Pakhtunkhwa Police Act, 2017 and Standing Orders which deal with promotion from one rank to the next higher rank and confirmation in the substantive rank after fulfilling requisite criteria/mandatory periods for the subject purpose.
- b. That being member of discipline force, promotion and confirmation in respective ranks are being carried out in light of Police Rules, 1934, The Khyber Pakhtunkhwa Police Act, 2017 and Standing Orders..
- c. Incorrect. That the appellant has been dealt in accordance with Police Rules/Police Act KP Police 2017.
- d. Incorrect. That the appellant has been treated in accordance with law/rules.
- e. Incorrect. That no right of the appellant has been violated by the answering respondents.

PRAYER:

Keeping in views the above facts and circumstances, it is humbly prayed that the appeal of appellant being devoid of legal Force may kindly be dismissed with costs.



Mode of bringing names of Assistant Sub-Inspectors (ASIs- both PASIs and Ranker ASIs) on promotion list E, confirmed in the manner provided above, is given in PR 13.10 and 13.11 of the Police Rules, 1934. Therefore, their names may be brought on the Promotion List E in the manner provided in the said two rules.

7. Keeping in view the above, this office letter No. CPO/CPB/317 dated 08.12.2022, that intended to create a parity between the dates of confirmation of ASIs appointed direct (PASIs) and those of the ASIs promoted from ranks (Ranker ASIs), is hereby withdrawn being against the letter and spirit of PR 12.8, 19.25 (5) Police Rules, 1934, in case of PASIs and against the PR 13.18 of the Police Rules, 1934 in case of the ASIs promoted from ranks (Ranker ASIs). The following was laid down in the said letter:

- a. All PASIs on successful completion of 03 years' probation period shall be brought on promotion list "E" from date of appointment.
- b. All ASIs promoted from lower rank shall be brought on promotion list "E" after successful completion of 02 years' probation period from date of officiating promotion."

8. You are, therefore, requested to:

- (a) register that the Date of Promotion and Date of Confirmation of a Ranker ASI are Not the Same, as has been misconceived by many, but are different from each other. Date of confirmation falls after two years of the date of promotion in case of Ranker ASI according to PR 12.8, and 13.8 of the Police Rules, 1934 respectively.

(b) Withdraw all changes brought in the List E in compliance with this office letter No. CPO/CPB/317 dated 08.12.2022 and Revise the List E of your Range to substitute all those dates of confirmation of all Assistant Sub-Inspectors appointed by way of

Subject: LEGAL ADVICE ON THE QUESTION OF DATE OF CONFIRMATION OF PASI'S APPOINTED DIRECT

Memo:

Reference your office letter No. 29504/E dated 13.12.2022, wherein a legal advice was sought on the following law point:-

- 1) Whether all PASIs on completion of 03 years' probation period shall be brought on promotion list "E" from date of appointment or not?
2. As per PR 12.8 of the Police Rules 1930, Assistant Sub-Inspectors appointed direct (Commonly known as PASIs) "will be considered to be on probation for three years" and that, under PR 19.25(5), "on the termination of the prescribed period of probation the Superintendent shall submit to the Deputy Inspector-General for final orders the full report required by Form 19.25(5) on the probationer's working and general conduct, with a recommendation as to whether he should or should not be confirmed in his appointment."
3. Both rules are hereby reproduced as a ready reference:

PR 12.8 Probationary nature of appointments. - (1) Inspectors, Sergeants, Sub-Inspectors and Assistant Sub-Inspectors who are directly appointed will be considered to be on probation for three years and are liable to be discharged at any time during or on the expiry of the period of their probation if they fail to pass the prescribed examinations including the riding test, or are guilty of grave misconduct or are deemed, for sufficient reason, to be unsuitable for service in the police. A probationary inspector shall be discharged by the Inspector-General and all other Upper Subordinates by Range Deputy Inspector-General and Assistant Inspector-General, Government Railway Police, Assistant Inspector-General, Provincial Additional Police (designated as Commandant Provincial Additional Police). No appeal lies against an order of discharge. (2) The pay admissible to a probationary Inspector, Sergeant, Sub-Inspector or Assistant Sub-Inspector is shown in Appendix 10.64, Table A.

PR 19.25 Training of upper subordinates (1) "Inspectors, sub-inspectors, and Assistant Sub-Inspectors, who are directly appointed, shall be deputed to the Police Training School to undergo the course of training laid down for such officers in the Police Training School Manual and are liable to discharge if they fail to pass the prescribed examinations or are badly reported on."

(5) "On the termination of the prescribed period of probation the Superintendent shall submit to the Deputy Inspector-General for final orders the full report required by Form 19.25(5) on the probationer's working and general conduct, with a

recommendation as to whether he should or should not be confirmed in his appointment. In the case of Inspectors such reports shall be forwarded to the Inspector-General."

4. The two rules (12.8 and 19.25(5) of the Police Rules, 1934) clearly state that PASIs (ASIs appointed direct) shall be on probation for a period of three years after their appointment as such and that they may be confirmed in their appointments (appointment of being an ASI), on the termination of the prescribed period of probation for three years with immediate effect NOT with retrospective effect i.e. from the date of their appointment by the Range Deputy Inspector General of Police on the report of their respective District Police Officers provided they have completed the period of their probation of three years successfully in terms of the conditions laid down in the PR 19.25 (5) of the Police Rules, 1934.

5. Moreover, under paragraph VI of the Promotion Policy, provided in ESTA CODE Establishment Code Khyber Pakhtunkhwa (Revised Edition) 2011, "promotion will always be notified with immediate effect." Drawing analogy from this rule, all PASIs might be so confirmed on conclusion of probationary period of three years with immediate effect (the date on which order of their confirmation is issued).

6. The Supreme Court of Pakistan underlined the difference between the date of appointment and date of confirmation in Mushtaq Wazir Vs IG Punjab (PLD 1985 SC 159). Their names may be brought on the Promotion List E in the manner provided in PR 13.10 and 13.11 of the Police Rules, 1934 NOT from the date of appointment but from the date of confirmation which, essentially, is a date different from their dates of appointment and compulsorily falls on the termination of the period of their probation for three years under PR 12.8 and 19.25(5) of the Police Rules, 1934.

8. Keeping in view the above, this office letter No. CPO/CPB/D/17 dated 08.12.2022, that intended to create a parity between the dates of confirmation of ASIs appointed direct (PASIs) and those of the ASIs promoted from ranks (Ranker ASIs), is hereby withdrawn being against the letter and spirit of PR 12.8 (19.25(5)) of Police Rules, 1934, in case of PASIs and against the PR 13.10 of the Police Rules, 1934 in case of the ASIs promoted from ranks (Ranker ASIs). The following was laid down in the said letter:

"a. All PASIs on successful completion of 03 years' probation period shall NOT be brought on promotion list "E" from date of appointment.

b. All ASIs promoted from lower rank shall be brought on promotion list "E" from date of confirmation after successful completion of 03 years' probation period from date of confirmation.

Appling the above in view, you are, therefore, requested to:

register that the Date of Appointment and Date of Confirmation of an Assistant Sub-Inspectors appointed direct (PASIs) are Not the Same, as has been misconceived by many, but are different from each other. Date of confirmation falls after three years of the date of appointment in case of an Assistant Sub-Inspectors appointed direct (PASIs) and the same (date of confirmation) falls after two years in case of an Assistant Sub-Inspector promoted from ranks (Ranker ASI) according to PR 12.8. and 13.8 of the Police Rules, 1934 respectively.

- Withdraw all changes brought in the list E in compliance with this office letter No CPO/C PB/317 dated 08.12.2022 and Revise the List E of your Range and substitute all those dates of confirmation of all Assistant Sub-Inspectors appointed direct (PASIs) which were fixed retrospectively from the date of their appointment with those falling after the termination of the period of their probation for three years in the light of observations noted at paragraphs No. 2, 3, 4, 5, 6, 7, and 8 above.
- (c) ensure that ASIs appointed direct (PASIs) shall NOT be confirmed from the Date of their appointment but might be so confirmed "On the termination of the prescribed period of probation" of three years, with immediate effect (the date on which order of their confirmation was issued).
- (d) Send compliance report by 23.02.2023.

In pursuance of judgment dated 24.04.2019 of Hon'ble Peshawar High Court, Peshawar while disposing of Writ Petition No. 3720-P/ 2018 titled Qazi Muhammad Arif Vs Govt. of Khyber Pakhtunkhwa followed by Khyber Pakhtunkhwa Service Tribunal, Peshawar judgment dated 30.11.2021 in Service Appeal No. 12438/2020 titled Furqan Javed SI Vs Govt. of Khyber Pakhtunkhwa etc wherein the Police Department was directed to bring the petitioners PASIs on seniority list "E" from the date confirmation of their appointments as per the spirit of Police Rules, 1934 (amended 2017):

The Constitution of Islamic Republic of Pakistan dictates equal treatment and prohibits discrimination in its Articles 4 & 25. Furthermore, the Hon'ble Supreme Court of Pakistan has held in several reported judgments that if a competent court of law decide a point of law or fact and if such decision cover not only the case of those litigating before the Court but some other also, then under the dictate of justice, the benefit of that judgment should not be restricted to those who had litigated, rather shall be equally extended to those who had not indulge in the litigation.

Foregoing in view the Competent Authority has directed to follow the following instructions in order to bring parity in promotion to list "E":

- ✓ DISCRETE*
- a) All PASIs on successful completion of 03 years probation period shall be brought on promotion list 'E' from the date of appointment.
- b) All ASIs promoted from lower rank shall be brought on promotion list "E" after successful completion of two years probation period from the date of officiating promotion.
