ON ACCEPTANCE OF INSTANT APPEAL, (1)THIS HON'BLE TRIBUNAL MAY VERY GRACIOUSLY BE PLEASED. ТО DECLARE THE D.P.C **ORDER** NOTIFICATION BEARING NO. 4269-70/EC, dated Bannu the 08/12/2023 AS ILLEGAL, AGAINST THE FACTS, INEFFECTIVE UPON THE RIGHTS OF **APPELLANT AND BASED ON MALAFIDE INTENTION.** 

(2) THE RESPONDENT NO.2 MAY KINDLY BE DIRECTED TO PROMOTE THE APPELLANT TO THE POST OF ASI FROM THE DATE OF THE D.P.C WITH RETROSPECTIVE EFFECT AND BACK BENEFITS.

The Appellant humbly submits as under:-

1. That the appellant was appointed as a Constable on dated 20.03.1994 and have performed his duties to the entire satisfaction of the High Ups according to the law and Rules. (Copy of service card of the appellant is mark A and CNIC is mark B)

That the Appellant in 2022 selected for elite Course
 ASI and the same was passed by the Appellant.

3. That it is pertinent to mention here that the appellant was selected for lower Course in 2008 and for inter course in 2016, which was passed by the Appellant with an Honors, the Appellant was placed in D list for further promotion to the post of ASI, in the result of the said Course. That the Appellant during his entire service as an IHC performed his duty with zeal and zest without any complaint, had arrested different type of offenders.

That the Appellant was summoned vide Memo.101 dated 7/12/2023 with the direction to appear before the DPC on dated 08/12/2023 along with other nominated employees. Therefore in the compliance of the direction the Appellant appeared before the forum of DPC, the Appellant was declared as promoted soon after DPC but later on, the name of the Appellant had been illegal and unlawfully had been expunged from notification which is against the merit and law.(Copy of Memo/ D.P.C is mark C, while Order/Notification is mark D)

That on the inquiring the matter by the Appellant one or other pretext, the Authorities told to Appellant that during the pendency of the services of the Appellant along other 14 employees were awarded major punishment in Arbitrarily and same was decreased to censure by the then R.P.O Abdul Ghafoor Afridi

That the members of DPC even not bother to record well and any sound reason of the deprivation of the Appellant and others which is against the principles of justice and fair play.

That it is astonishing that in the DPC notification 4269-70/EC, dated Bannu the 08/12/2023, all those who were awarded punishment and then it was converted into censure e.g in the same impugned notification Mr. Mati Ullah IHC At S.NO.81 has been promoted to the post of ASI and other were also promoted to different ranks despite of the so called major punishments.

That the depriving of appellant from promotion is against law, illegal, discriminatory, on political ground and is based upon mala fide and ill-will.

That appellant being dissatisfied from the impugned notification forwarded representation appeal bearing Dairy No. $\frac{11.7}{5.6.6.6}$  instituted on 23/12/2023 before the learned respondent No.1 but the said appeal of the appellant is still pending for adjudication since from institution and no response uptill now has been made.(Copy of the representation appeal is mark **E**).

That as per law when the department is not heard and disposed of the appeal within three months after the institution of the appeal, the appellant is legally entitled to file an appeal before your honour.

12. That as such the appellant feeling himself aggrieved from the act of the respondent No.1 coupled with illegal. unjust and discriminatory impugned DPC

order of the respondent No.2, approaches to this honorable court on the following grounds inter alia;

### **GROUNDS:-**

- A. That the impugned D.P.C order is unlawful, illegal, unjust, discriminatory and against the principle of natural justice and is based upon ill will and mala fide intention of the respondent No.2, is not sustainable in the eyes of law, therefore, the same may kindly be declared as null and void, void abi initio, of no legal effect and be set aside.
- B. That the impugned DPC order is against the laws, rules specially police rules 2014 and fundamental rights which are enshrined in the constitution of the Pakistan.
- C. That the impugned D.P.C Notification/Order of the Respondent No.2 is based on non-reading, misreading, erroneous interpretation and failure to exercise the jurisdiction vested in it, hence the same is liable to be canceled.
- D. That the impugned D.P.C Notification/Order fails to consider the general doctrine that in case of clash between two documents of record, the earlier shall prevail. Therefore, the order made by the respondent No.2 may kindly be considered incorrect and maybe kindly ought to be brought in line with
  Natural justice system.
- E. That the impugned D.P.C Notification/Order has been issued in hasty and slipshod manner without considering the rules related to promotion and, thus, the general principle of law of "justice

hurried is justice buried" was defeated. It is, therefore, safe to conclude that respondent No.2 has exercised its discretion perversely, improperly and with material irregularities, which leaves the order nullity in the eyes of law and liable to be set aside.

- F. That the respondent No.2 has not promoted the appellant without assigning any cogent reason, such conduct of the respondent No.2 is against the law, equity and good conscious and impugned D.P.C Notification/Order is liable to be set aside.
- G. That the appellant has been subjected to injustice and the case of the appellant has not been dealt with under the principle of fair play.
- H. That the appellant has not been provided equal treatment when there is no express exhibition against him under the law and has not been given equal protection of law, which is discriminatory and against the principle enshrined in article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- That the Appellant would suffer, and is continuously suffering a lot, if the impugned D.P.C Notification/Order is not set aside, and the relief sought is not awarded to the Appellant.
- J. That the learned counsel for the appellant may kindly be allowed to raise additional grounds at the time of hearing of this appeal.

Therefore, it is most humbly prayed that on acceptance of this appeal the order/notification <u>NO. 4269-70/EC, dated</u>

**Bannu the 08/12/2023** issued by the respondent No.2 may kindly be declared as illegal, void ab initio, null and void, of no legal effect and be set aside and the respondents may kindly be directed to promote to the appellant to the Rank of ASI forthwith and any other relief which this honorable court deems appropriate may also be granted to the appellant.
