the corrigendum order dated 10.03.2022 was challenged by the appellants through departmental appeals but the same were not responded, hence, the instant service appeals.

03. On receipt of the appeals and their admission to full hearing, the respondents were summoned who put appearance and contested the appeals by filing replies. The defense setup was a total denial of the claim of the appellants.

04. We have heard learned counsel for the appellants and learned District Attorney for respondents.

05. The learned counsel for the appellants reiterated the facts and grounds detailed in the memo and grounds of the appeals while the learned District Attorney District Attorney controverted the same by supporting the impugned order(s).

06. In the present cases, the appellants assert that they were promoted to the position of Office Assistants (BPS-16) on regular basis, as per the promotion order dated March 4, 2021. However, they contend that the subsequent corrigendum, issued on March 10, 2022, retroactively altered the nature of their promotion from regular to acting charge basis. The appellants further argue that their efforts to challenge this corrigendum through departmental appeals went unanswered, prompting them to file the current service appeals. regarding the legitimacy of the corrigendum and the procedural fairness of the appellants' promotion process.

07. Admittedly, the appellants were promoted on regular basis vide order dated 04.03.2021 on the recommendation of the Departmental Promotion Committee. The promotion order was partially modified vide corrigendum order dated 10.032022 and regular promotion was said to be read as acting charge basis instead of regular promotion. The DPC while making recommendation for promotions found as under:

"The meeting commenced with the recitation from the Holy Quran. Thereafter, the chair welcomed the participants. Deputy Secretary Judicial, Home & Tribal Affairs Department apprised the committee that there are (17) vacant posts (15 clear+02 resultant) of Assistant (BS-16) falling under the promotion quota in the Directorate of Prosecution and District Prosecution offices. He added that according to Khyber Pakhtunkhwa, Prosecution Service Rules, 2010 as amended in 2019, the method of promotion of the Assistant (BS-16) has been prescribed as below:

- *i)* 25% by initial recruitment.
- *ii)* 75% by promotion on the basis of seniority-cumfitness from amongst the Senior Clerk with at least five years' service as Senior Clerk and Junior Clerk.

Therefore, 17 Senior Clerks (BS-14) are required to be promoted as Assistant (BS-16). Keeping in view vacant posts and provision of the Rules ibid, the committee considered the panel of Senior Clerks (BS-14) as per notified seniority list and recommended the following Senior Clerks for promotion to the post of Assistant (BS-16) at Serial No.1 to 19 on regular basis, however, the official reflected at Serial No.5 has to be superseded on his own request while the official reflected at Serial No.16 has not been considered as he opted to be promoted to the post of Assistant Accountant (BS-16) "

08. The record is silent, so are the comments of the respondents, as to what had prompted issuance of corrigendum a year after the regular promotion, promotion order whereby promotion of the appellants on regular basis was said to have been made on acting charge basis. The only contention of the respondents in their reply is that the regular promotion was made inadvertently.

09. Therefore, while disposing the appeals we direct that the respondents shall consider the fact whether the promotion of the appellants made on regular basis on 04.03.2021 was against the clear vacancies or not. If that was against clear vacancies, then the respondents shall make appropriate order accordingly and if there
