APPEAL UNDER SECTION 4 OF THE SERVICE TRIBUNAL ACT, 1974 AGAINST THE ORAL REFUSAL OF RESPONDENTS OF NOT DECIDING THE DEPARTMENTAL APPEAL FILED ON 09.05.2024 THROU 3H PROPER CHANNEL AND TO PROMOTE THE APPELLANT TO THE POST OF ADMINISTRATIVE OFFICER/SUPERINTENDENT (BPS- 17) FROM THE DATE WHEN RESPONDENTS NO.4 to 11 WHO WERE JUNIORS FROM APPELLANT WERE PROMOTED AND TO INCLUDE THE NAME OF APPELENT IN THE SENIORITY LIST OF ASSISTANT SINCE 2003.

Prayer:

On acceptance of this appeal, the respondents may kindly be directed to prepare the seniority list of the employees as required by law and further may kindly be directed to include the name of appellant in the seniority list of Assistant since 2003 and also may kindly be granted promotion and seniority to next higher scale under the law.

Respectfully Sheweth;

Appellant humbly submits as under:

1) That appellant joined the respondent department as Naib Qasid on Leave Vacancy and later on was appointed as Junior Clerk on 08.07.1987 and was regularized on 03.05.1989.

(Photocopy of appointment order letter is Annexure "A", while regularization order is Annexure "B").

2) That on 25.03.1997 appellant was promoted to the post of Senior Clerk and then again promoted to the post of Assistant on 16.05.2001.

(Copies of promotion orders & Minutes of the Meeting are Annexure "C, D & E").

- 3) That in the year <u>2003</u> Director Public Relation post was merged in Directorate, while others like P.R.O to Governor stenographer, Assistant and Senior Clerks etc were not included in the seniority list
- 4) That on 20.11.2011, the post of Jaffer Khan, stenographer (BPS-12) of Directorate of Information was upgraded to BPS-15 and was included in the seniority list. Similarly, Anwar Khan, stenographer of P.R.O Office was appointed in the Directorate and his name was also included in the seniority list. of DGIPRs, KP, Peshawar.

- 5) That the post of Senior Clerk (O/O PRO to Governor) from which the appellant was promoted to the post of Assistant, Mr. Said-ul-Abrar who was working as Senior Clerk was transferred from Information Directorate to the P.R.O. Office on 18.03.2015 on appellant vacant post and later on he was promoted to post of Assistant on 21/7/2017 in DGIPRs, Khyber Pakhtunkhwa.
- 6) That similarly Mr. Ahmad Ali Shah Junior Clerk, DGIPRs, Khyber Pakhtunkhwa was promoted as Senior Clerk and transferred/posted of Said-ul-Abrar place in the O/O PRO to Governor, Khyber Pakhtunkhwa Names of the both officials were also included in Seniority List of Assistant (BPS-16) in the DGIPRs, Khyber Pakhtunkhwa except the name of appellant.
- 7) That only the post of Assistant on which appellant is working has not been included in the seniority list.
- 8) That appellant vide Office Letter No. PSG/PRO/50 dated 07.03.2012 again through Letter No. PRO/GH/874dated 25.03.2016, Letter No. PS/GH/1056 dated 09.05.2018, Letter No.PS/GH/L064 dated 22.03.2020, Letter No. PRO/GH/1385 dated 29.09.2020 and Letter No.PSG/GH 1536 dated 20.07.0222 along with enclosures was continuously writing for inclusion of the name of petitioner in the seniority list but in vain.

(Copies of letters are Annexure "F.G.H,I, J, K & L")

9) That finally on 09.05.2024 again through proper channel a request for inclusion the name of appellant in the seniority list of Assistant (BPS- 16) was written

(Copy of letters are Annexure " M")

10).That on the other hand posts Respondents 4 to 11 who were junior from the appellant have been promoted and now has been shown senior from the appellant.

11). That statutory period of 03 months have been passed, but up till now neither the respondents have included the name of the appellant in the seniority list since 2003 nor the appeal has been decided.

12). That aggrieved with appellant has come before this Hon'ble Tribunal in Appeal for a direction to respondents to include the name of appellant in the seniority list of Assistant (BPS-16), since 2003 and to further promote the appellant on the post of Superintendent (BPS-17) and include the name of appellant in the seniority list of Assistant since 2003 and correct seniority list of Assistants, according to law on the following grounds amongst the other:

- a) That the oral refusal of not deciding the appeal of the appellant is against the law and facts, hence untenable in the eyes of law.
- b) That the respondents failed to appreciate the fact that respondents are bound to maintain seniority list of the staff so that every employee is promoted to higher post on the basis of seniority-cum-fitness.
- c) That by merging of DPR & Information Directorates since 2003. The names of officers and other officials are included in the seniority lists but not including the name of appellant in the seniority list of Assistant, respondents are exercising the powers not vested to them under the law.
- d) That by not including the name of the appellant in seniority list of Assistant since 2003, appellant is being condemned unheard and is being deprived of his vested right of promotion/ seniority under the law.
- e) That the respondents by their own choice are including the names in the seniority list which is against law, because the seniority list is prepared and maintained according to law in every office by promoting the employee on higher post on the basis of seniority-cumfitness.
- f) That the decision of not including the name of appellant in the seniority list maintained by the respondents, is perversant and against the settled principle of law and justice.
- g) That by not including the name of Appellant in the seniority list of Assistant Since 2003. Respondents are violating the terms and condition of service laws.
- h) That by not including the Name of Appellant in the seniority list of Assistant since 2003. Respondents are violating the fundamental rights of the Appellant granted by the constitution.

It is, therefore, requested that on acceptance of this appeal the respondents may kindly be directed to prepare the seniority list of the employees as required by law and further may kindly be directed to include the name of appellant: in the seniority list of Assistant since 2003 and also may kindly be directed to promote the Appellant to next higher scale under the law and also grant seniority to the Appellant when Respondents 4 to 11 junior from appellant were promoted.
