

ORDER

Syed Mansoor Ali Shah, J.- After arguing the matter at some length, learned counsel for the petitioners has agreed to the following arrangement:-

It is submitted that the respondents were appointed as Probationary Assistant Sub-Inspectors in the police department through the regular procedure by going through KP Public Service Commission while the petitioners before us were appointed through special mechanism by creation of supernumerary posts. The petitioners agree and admit that they are not senior to the respondents. The only grievance that is

being agitated by the petitioners is regarding their status within the police service. Learned counsel for the petitioners submits that the impugned judgment set asides the confirmation order dated 13.11.2020 of the petitioners, as a result they have been made probationers again. Their only grievance is to clarify their status in the police service. This is a factual issue and can best be resolved by referring the matter to the police department. Without upsetting the impugned judgment, let the matter be placed before the Inspector General of Police, KPK for clarification regarding the status of the petitioners. Let the petitioners approach the concerned officer within a month from today who shall pass a speaking order in this regard after hearing the petitioners.

2. In light of the above, these petitions stand disposed of.
