**SERVICE APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL, 1974 AGAINST THE IMPUGNED FINAL SENIORITY LIST DATED 10/05/2024 WHEREBY JUNIORS TO THE APPELLANT I.E. DIRECT/OPEN MERIT RECRUITEES HAVE BEEN RANKED SENIOR TO THE APPELLANT AND AGAINST THE ORDER DATED 13/06/2024 WHEREBY PRIVATE RESPONDENTS BOUGHT ON THE LIST "F" AND WERE PROMOTED TO THE RANK OF SUB INSPECTOR (BPS-14), IGNORING THE APPELLANT AND AGAINST THE APPELLATE ORDER DATED 25/06/2024 WHEREBY THE APPEAL OF THE APPELLANT HS BEEN REJECTED ON NO GOOD GROUNDS.**

**Prayer:-**

That on acceptance of the instant service appeal, the impugned seniority list dated 10/05/2024 may very kindly be modified/rectified to the extent of appellant by placing the name of the appellant above the names of private respondents in light of Rules-17(2) of the APT Rules 1989 and Rule 12.2 of the Police Rules, 1934. That the subsequent impugned promotion order dated 13/06/2024 may also be set aside and the respondents may kindly be directed to consider the appellant for promotion to the rank of Sub Inspector (BPS-14) w.e.f. 13/06/2024 with all back benefits including seniority and the impugned appellate order dated 25/06/2024 may also be set aside being not tenable in the eyes of law. Any other remedy which this august Tribunal deem fit may also be awarded in favour of the appellant.

**R/SHEWETH:**

**ON FACTS:**

1. That the appellant the appellant while serving in the respondent department with all zeal and zest, applied for the post of Probational Assistant Sub Inspector (Traffic Warden) in the in Service Quota advertised by the KP Public Service Commission

vide advertisement dated 18/09/2017. Copy of the advertisement is attached as annexure.....**A**

2. That the KP Public Service Commission issued merit list for the direct quota candidates as well as in service quota employees/candidates, wherein name of the appellant was enlisted at Serial No 6 of the merit list prepared for in service employees. Copy of the merit list is attached as annexure.....**B**
3. That in light of the merit list issued by the KP Public Service Commission, the respondents issued appointment order of direct recruitees as well as in service employees against the post of PASI (Traffic Wardens) vide different orders of even dated 14/05/2019. Copies of appointment orders are attached as annexure.....**C**
4. That in light of the appointment order and merit list, the respondent issued the joint seniority list of PASIs i.e. direct recruitees and in service employees, wherein name of the appellant was enlisted at serial No 1 of the ibid seniority list. Copy of seniority list is attached as annexure.....**D**
5. That vide circular dated 02/04/2024 the respondents issued joint seniority list of PASIs as per merit and age-wise wherein name of the appellant was properly enlisted at Serial No 6. Copy of the merit list is attached as annexure.....**E**
6. That astonishingly vide impugned seniority list dated 10/05/2024 the respondents issued joint final seniority list of PASIs Traffic Wardens, wherein name of the appellant has illegally and unlawfully been enlisted at serial No 73 instead of serial No 6. Copy of the impugned seniority list is attached as annexure.....**F**
7. That feeling aggrieved the appellant filed departmental appeal on 17/05/2024, which was forwarded by the Chief Traffic Officer to the respondent No 2 vide dated 17/05/2024. Copies of departmental appeal and forwarding letter are attached as annexure.....**G&H**

8. That on the basis of above mentioned impugned seniority list, juniors to the appellant were allowed for mandatory Elite Course while the appellant was ignored and resultantly vide impugned minutes dated 13/06/2024 the private respondents were recommended to the rank of Sub Inspector (BPS-14) while the appellant was ignored/deferred for promotion. Copy of the minutes are attached as annexure.....I
9. That vide appellate order dated 25/06/2024 the departmental appeal of the appellant was regretted by the appellate authority on no good grounds, hence the instant appeal on the following grounds amongst other. Copy of the appellate order is attached as annexure.....J

**Grounds:**

- A. That the Impugned seniority list dated 10/05/2024, minutes dated 13/06/2024 & appellate order dated 25/06/2024 are against the law, facts, norms of natural justice and material on the record, hence not tenable and liable to be set aside
- B. That the respondents have not treated appellant in accordance with law, rules and policy on subject and acted in violation of Article 04 & 25 of the Constitution of Islamic Republic of Pakistan 1973, which act is unjust, unfair and hence not sustainable in the eye of law.
- C. That the impugned seniority list dated 10/05/2024, minutes dated 13/06/2024 & appellate order 25/06/2024 are violative of the Rule 17 (2) of the APT Rules, 1989, Rule 12.2 of Police Rules, 1934 and Police Act, 2017, therefore, not tenable and liable to be set aside. Copies of rules and act are attached as annexure.....K
- D. That the action and inaction of the respondents are discriminatory and is violative of Article 4, 25 & 27 of the Constitution of Islamic Republic of Pakistan, 1973, therefore, not tenable and liable to be set aside on this score alone.
- E. That the action and inaction of the respondents is violative of Article 38-E of the Constitution of Islamic Republic of Pakistan,

1973 as well as Section 8, 9 of Civil Servant Act as well as Rule 7 and 17 of the APT Rules, 1989.

- F. That the action and inaction of the respondents are based on malafide and arbitrary intentions, hence not tenable and liable to be set aside.
- G. That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal may kindly be accepted as prayed for.

**Psychological Test:-**

Candidates, both general and in Service, who qualify written examination, shall be called by the Public Service Commission for Psychological test to be conducted by Psychologist of Khyber Pakhtunkhwa Public Service Commission. The result of this test shall be a guide for the interview panel whether a candidate is suitable for the police job or otherwise.

- 8 -

Viva Voce Examination:-

Psychological test shall be followed by viva voce exam to be conducted by the Public Service Commission. The candidate shall appear before the interview panel at the time of viva voce examination. Failure in or absence from viva voce shall mean that the candidate has failed to qualify the examination for the post of Assistant Sub-Inspector.

Final merit list shall be prepared by the Khyber Pakhtunkhwa Public Service Commission on the basis of marks obtained in written test & viva voce. If the total marks of any of the two candidates are equal, the candidate having higher marks in viva voce test shall be placed higher on merit and, in case, where the marks obtained in viva voce are also equal, the candidate older in age shall be placed higher on merit list.

Candidates recommended by the PSC for appointment as ASI Traffic Warden shall undergo medical examination to be conducted by Director Health Services Government of Khyber Pakhtunkhwa.

Issuance of appointment order shall be subject to background clearance reports from intelligence agencies.

GENERAL CONDITIONS

- i) Age shall be reckoned on 01-01-2018. All the candidates are required to be academically qualified in all respects by 17-10-2017. Candidates not in possession of the required qualification by the last date for receipt of application shall not be considered. 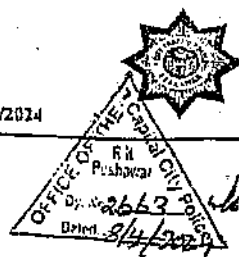

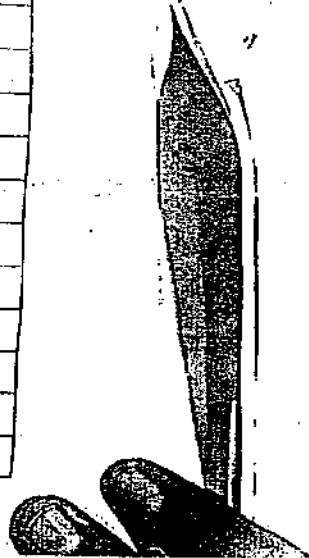

2. That the Capital City Police Officer, Peshawar has sought opinion from AIG Establishment vide letter No. 14558/EC-1 dated 17.08.2022 (Annexure "B") that seniority list received from KP Public Service Commission is not clear that either in-service quota candidates will be reckoned senior than general quota or otherwise as both the seniorities positions started with one (01).
