ORDER

As per consolidated judgment dated 29.08.2023 of Hon'ble Peshawar High Court in Writ Petition No. 1587-P/2022 titled Shah Mumtaz etc Vs Govt of Khyber Pakhtunkhwa (on out of Turn demotion cases) wherein beneficiaries of out of turn promotions (on Gallantry basis) was dismissed by the Hon'ble Peshawar High Court, Peshawar in the following terms:-

Para 44(II). "Promotions/ upgradations made on account of gallantry acts are hit by the judgments of the Hon'ble Apex Court, as such, all such upgradations/ promotions made on account of gallantry acts or allegedly as they stood fast in the performance of duties during the waves of terrorism are not protected and are hit by the judgment of the Apex Court, therefore, all such writ petitions are dismissed in the light of Para 25 of this judgments."

2. Previously, as per directions of the Hon'ble Supreme Court of Pakistan dated 26.01.2023 in *Suo Moto Contempt proceedings* vide Crl.O. Petition No. 38/2021 in CP No. 381-P/2020 and in pursuance of Judgments passed by Hon'ble Supreme Court of Pakistan in 2013 SCMR 1752, Civil Review Petition No. 193/2003 reported in 2015 SCMR 456, 2016 SCMR 1254, 2017 SCMR 206, 2018 SCMR 1218 and consolidated Judgment dated 30.06.2020 in Civil Petitions No. 1996, 2026, 2431, 2437 to 2450, 2501 and 2502 of 2019 on issues of Out of Turn Promotions, all Unit Heads, Regional Police Officers and District Police Officers of Khyber Pakhtunkhwa Police were directed vide this office Letter No. CPO/CPB/75, dated 14.02.2023, to ensure compliance of above mentioned Orders in letter and spirit. Accordingly, all Out of Turn Promotions granted to Police personnel either on gallantry basis or otherwise belonging to different Units, Regions & Districts were withdrawn by the concerned authorities and consequently their seniorities were re-fixed along with their original Batchmates who were promoted during their intervening period by maintaining original inter-se-seniority. Accordingly, the out of turn promotions on the basis of gallantry acts of Police officers were withdrawn and their inter-se-seniorities were fixed along with their original batchmates vide their respective demotion orders. Some of the Police officers through aforementioned Writ Petitions challenged their demotion orders in Hon'ble Peshawar High Court, Peshawar and got interim relief in their favor. In consequence of interim relief granted by Peshawar High Court, their demotion orders were held in abeyance by the department through temporary/interim orders. Now, Hon'ble Peshawar High Court, Peshawar has declared in unequivocal terms that promotions/upgradations made on account of gallantry acts are hit by the Apex Court judgments.

3. Therefore, as per Hon'ble Peshawar High Court, Peshawar aforementioned judgment, the cases of out of turn promotions on account of gallantry basis were re-examined as during the intervening period from issuance of demotion orders till date, the batchmates of some of demoted Police officers with whom their seniorities were fixed through demotion Orders got promoted to higher ranks. Therefore, the orders of the such Police officers by which their demotion orders were held in abeyance, are hereby withdrawn and their respective demotion orders previously issued are being amended by fixing their seniorities among the same batchmates who got promoted to higher ranks during intervening period through this Order.

4. Mr Muhammad Ismail Shah DSP was demoted to the rank of Inspector vide order No. CPO/E-U 580/Legal dated 15.03.2023.

5. Through demotion Order bearing No.CPO/E-I/580/Legal dated 15.03.2023 his seniority was fixed above the name of Inspector Islah Ud Din No. P/375. However, during intervening period Inspector Islah


Ud Din No. P/375 got promoted as DSP vide Notification No. CPO/E-/Promotion/3054 dated 27.11.2023. Therefore, through this Order, the demotion Order issued vide No. CPO/E-1530/Less dated 16.08.2013 w.r. to the seniority of Muhammad Ismail Shah is hereby amended by re-fixing his seniority below the rank of DSP Islah Ud Din recently promoted w.e. from 27.11.2023. His promotion as DSP shall be treated w.e. from 27.11.2023 and his further progression in career/promotion to next rank will be subject to the following Criteria:-

- Seniority
 - Five years Service as DSP as per Standing Order No. 03/2022
 - Junior Command Course (JCC) as per 19.48 Amendment Police Rules.
 - Medical Fitness.
 - No Departmental Enquiry.
 - Minimum 50 PERs Quantification.
- This Order is issued in the above terms.


