PARA WISE COMMENTS ON BEHALF OF RESPONDENTS.

Respectfully Sheweth:

PRELIMINARY OBJECTIONS.

- 1) That the service appeal is not maintainable in its present form.
- 2) That the appellant has not come to this honourable Service Tribunal with clean hands.
- 3) That the present Service appeal is badly barred by law and limitation.
- 4) That this honorable Service Tribunal has got no jurisdiction to entertain the present , service appeal.
- 5) That the appellant has suppressed the material facts from this honorable service tribunal.
- 6) That the appeal is bad due to mis-joinder and non-joinder of necessary parties.

ON FACTS:

- 1. Incorrect, the appellant was recruited in police department as constable on 24.04.2009. During service appellant proved himself an inefficient official. There are certain bad entries in his service record. (Copies of bad entries enclosed as annexure "A").
- 2. Incorrect, appellant during service absented himself from lawful duty with effect from 04.01.2021 to 12.01.2021 and also remained absent from time to time total 57 Days without any prior leave of the competent authority. On account of which he was proceeded against departmentally in accordance with rules.
- 3. Incorrect, the appellant absented himself from lawful duty with effect from 04.01.2021 to 12.01.2021 and also remained absent from time to time total 57 days within the meaning of misconduct under Rules 4 of Police (efficiency & disciplined) Rules, 1975. Mr. Muhammad Zaman Khan DSP/ HQrs: was appointed as enquiry officer to conduct preliminary enquiry. The enquiry officer scrutinized the available record, recorded statements of concerned and heard the appellant in person. After fulfilling all codal and legal formalities, the enquiry officer concluded the enquiry and held the appellant guilty of gross misconduct. The enquiry officer submitted his finding report wherein he recommended the appellant for appropriate punishment. On receipt of enquiry finding, the competent authority dismissed the appellant from service vide order No. 573/EB dated 02.06.2021. The appellant filed department appeal before the appellate authority, which was partially allowed by taking lenient view and the appellant was re-instated into service. However punishment of dismissal was converted into stoppage of one annual increment without cumulative effect, while the period of absence spent

- out of service was treated as leave without pay. (Copy of enquiry report, dismissal order and order on departmental appeal enclosed as annexure B-C-D).
- 4. Incorrect, the appellant filed review petition before the revisional authority and the appellate board in its meeting held on 27.10.2022 called the petitioner and he was head in person. The appellant contended that he belongs to a poor family. The board converted the punishment of stoppage of one annual increment without cumulative effect into "Censure". Moreover the appellant is not entitled for the salary for period of absence on the principal of "no work no pay". As the appellant was not in active service during the intervening period, therefore the appellate authority passed the order rightly in accordance with principle of natural justice. (Copy of order enclosed as "E").
- 5. That appellant has got no cause of action to file the instant appeal and the instant appeal being devoid of merit is liable to be dismissed on the following grounds.

GROUNDS

- A) Incorrect, the order of respondent are in accordance with law, facts and based on justice. As already discussed in preceding paras, that the appellant remained out of service during the intervening period and the principle of "no work no pay" was applied to the case of present appellant.
- B) Incorrect, the appellant was properly associated with the enquiry proceedings and his statement including others have been recorded properly and he was dismissed from service however on partial acceptance of his appeal/ revision his punishment was modified. (Copies of statement of appellant and other enclosed as F-G-H-v).
- C) Incorrect, the order of re-instatement passed by the appellate authority is justifiable and in accordance with law and no violation has been committed by the respondents.
- D) Reply already given in para above.
- E) Incorrect, as already discussed in preceding paras, that the appellant was habitual absentee and remained absent for 56 days without leave of the authority. The allegations of absence were proved during enquiry here keeping in view his conduct, he was awarded punishment as per law/rules.
- F) Incorrect, the appellant committed gross misconduct during service and he was responsible for his conduct, neither the department. Moreover each and every case, has its own facts and circumstances.
- Incorrect, the appellant was not restrained from performing his duty; rather absented himself from duties deliberately without seeking any leave or permission from his authority.
- H) Incorrect, the interpretation of the judgment of honorable Supreme Court is very much clear

because the appellant being member of disciplined force absented himself from duty without leave or permission from his seniors. Moreover he is habitual absentee as evident from finding report conducted by the enquiry officer. As appellant has not performed any duty here not entitled for any monitory benefits or the principle of "no work no pay"

- Incorrect, the appellant was remained out of service during the intervening period and principle a "no work no pay" is applicable to the case of appellant. The appellant deliberately absented himself from duty and he is not entitled for salaries of the period which he spent out of service.
- J) The respondents also seek permission of this honorable Service Tribunal to adduce additional grounds at the time of arguments/ hearing.

The Enquiry Officer during the course of enquiry recorded the statements of all concerned as well as the official concerned. The Enquiry Officer in his finding report recommended him for suitable punishment. He was called in orderly room for personal hearing and found him unsatisfactory. Full opportunity was given to him to explain his position, but he failed to produce any cogent reason in his self defense. Therefore, the District Police Officer, Dir Lower in exercise of power vested under (E&D) Rules with amended 2014 awarded him a major punishment of dismissal from service with immediate effect and the period of absence with effect from 04/01/2021 to 102/01/2021 is treated leave without pay vide OB No. 573, dated 02/06/2021
