1. The newly appointed candidates are allowed to takeover their charge if their schools are closed for winter vacation, but they will get their pay from the date of re-opening of schools.
2. The appointments are made under all services conditions laid down by the Government from time to time.
3. In case any candidate wishes to leave/resign the post he will have to submit one month's prior notice or in lieu forfeit one month's pay and allowances to the Government.
4. The appointments are purely on temporary basis and subject to the termination at any time without assigning any reason or prior notice.
5. No TA/D etc. is allowed being first appointment.
6. No joining time is allowed except what is absolutely necessary for transit.
7. Charge reports (induplicate) should be submitted to all concerned.
8. Age and Health certificate from the Medical Supdt. concerned must be produced within 7 days of reporting arrival for duty as required under the rules.
9. They should not be ~~appointed~~ charge if their ages exceed 25 years and below 13 years.
10. Candidate who fails to takeover charge within 15 days of the issue of this order shall automatically lose his right of appointment against RC post.
