Preliminary Objections

- 1. That the appellant has no Locus Standi and cause of action to file instant appeal.
- 2. That the appeal is incompetent and not maintainable in its present form.
- 3. That the appellant is estopped by his conduct to file the titled Service Appeal.
- 4. That the appellant have concealed material true facts from this honorable Tribunal.
- 5. That the appeal is barred by law as well by limitation.
- 6. That the appellant has not come to this honorable Tribunal with clean hands.

PARAWISE REPLY/COMMENTS ON FACTS:

1. Para No 1 pertains to record, needs no comments.



- 2. Para under reply is correct to the extent of the 25th Constitutional amendment and merger of FATA into Khyber Pakhtunkhwa, however the rules annexed by the appellant is with respect to the absorption of the members of Khassadar and the Levy Force.
- 3. Para under reply is correct to the extent that the replying respondent was initially absorbed in Police Department as Constable vide Notification No SO (Police) HD/SMY 2019 Merged Area/273-83 and the appellant was absorbed as Head Constable vide Notification of even date, however since the replying respondent was promoted as Naib Subedar and he also drew his salaries as Naib Subedar, thus he after due process of law was absorbed as ASI as per rules on the subject. Pertinent to mention that upon joint application of some Head Constables, including the appellant inquiry was conducted, wherein all the concerned with relevant record was examined and it was found that since the replying respondent was promoted as Naib Subedar, thus was rightly promoted as ASI, and the application was filed accordingly which order has never been questioned. (Copies of documents are enclosed as Annexure A).
- 4. Reply pertains to record hence needs no comments.
- 5. In reply to para 5 it is stated that the same is not relevant to the replying respondent.
- 6. Detailed reply has been given to Para No 3, however it is further added that the appellant has not challenged the Notification dated 30-11-2020 whereby the replying respondent was absorbed as ASI.
- 7. Para under reply pertains to record however as per reply of official respondents, no appeal has been filed by the appellant, thus the appeal is not tenable and liable to be dismissed on this score alone,



as according to the rules on the subject, every Civil Servant has to file separate departmental appeal is legal, however after the issuance of Orders dated 24-04-2024 and Order dated 30-04-2024, the service appeal is not tenable and liable to be dismissed.

8. Para No 8 is incorrect and appeal of the appellant is liable to be dismissed on the following grounds:

REPLY TO GROUNDS:

- A. Para under reply incorrect as the impugned Order is in accordance with law, rules and principles of natural justice and no right of the appellant has been violated hence he has got no cause of action.
- B. Para under reply is incorrect, as the replying respondent was serving as Naib Subedar hence rightly absorbed as ASI in Police department while the appellant is serving as Head Constable hence cannot challenge the order of the replying respondent.
- C. Para under reply is incorrect, since the appellant has been treated in accordance with law and rules, hence appeal is not tenable, further the appellant has prayed for his promotion as ASI which is governed by Police Rules, while the replying respondent was absorbed as ASI.
- D. Para under reply is incorrect, detailed reply has been given in above paras.
- E. Para under reply incorrect, detailed reply has been given in above paras.
- F. Para under reply incorrect, as the appellant was serving as Havaldar while respondent No 4 was serving as Naib Subedar hence both were absorbed in Police department as per their ranks.



- G. Para under reply incorrect, as no rights of the appellant have been violated therefore the appeal is liable to be dismissed.
 - H. The replying respondent also seek leave of this honorable Tribunal to raise additional points at the time of hearing of titled appeal.

It is therefore prayed that appeal of the appellant may kindly be dismissed with heavy costs.
