Respectfully Sheweth

- 1. In this regard, it is clarified that C&W Department scheduled a Departmental Promotion Committee meeting on 01.09.2015 to discuss the promotion of Diploma Holder Sub Engineers, including the promotion case of petitioner. After threadbare discussion, the DPC deferred the promotion of the petitioner for the reason that his ACRs for the periods of 1980, 1983, 1991 to 1994, 1997 to 2000 & 04.07.2001 to 31.12.2001 were not countersigned (Annex-I). The aggrieved Sub Engineer filed service appeal before the Khyber Pakhtunkhwa Service Tribunal for consideration his proforma promotion to the post of Assistant Engineer w.e.f 13.10.2015. The Service Tribunal accepted his appeal on 18.04.2024.
- 2. Incorrect, as per procedure, the Judgment of the Khyber Pakhtunkhwa Service Tribunal dated 18.04.2024 forwarded to Law department with the request to place the same before the Scrutiny Committee of Law Department as to whether the case is fit for filing of CPLA in the Supreme Court of Pakistan against the said judgment dated 18.04.2024. After threadbare discussion, it was decided with consensus by the Scrutiny Committee that the subject case is fit for filing of Appeal / CPLA before the Supreme Court of Pakistan on the main ground that Para-VI and VII of the promotion policy of Khyber Pakhtunkhwa does not support the proforma promotion. (Annex-II). Accordingly, the Department filed CPLA / Appeal before the Supreme Court of Pakistan with the prayer that on acceptance of this petition, leave to appeal against the impugned judgment and order of the Khyber Pakhtunkhwa Services Tribunal Peshawar dated 18.04.2024 passed in service appeal No.7505/2021 may graciously be granted.
- 3. Incorrect, since the petitioner case is not covered under the rules, he has not been deprived of any fundamental or constitutional # rights.

4. Incorrect, as explained in Para-3 above, the answering respondents have not violated any right of the appellant nor caused any malafide or discrimination in fact the Department followed rules / policy strictly in the cases of promotion/proforma promotion of Officers/Officials of the Department.



l am directed to refer to Govt. of Khyber Pakhtunkhwa Communication & Works Department letter No.SO(Lit)/C&W/3-464/2022, dated: 27.06.2024 on the subject noted above and to state that a meeting of the Scrutiny Committee has been held on 03-07-2024 under the Chairmanship of Secretary Law Department in order to determine the fitness of the subject case for filing of Appeal/CPLA before the Supreme Court of Pakistan.

That the appellant filed the subject service appeal with the prayer that the order dated 15-02-2018 may be set-aside and the appellant may be granted proforma promotion as Assistant Engineer/SDO.(BPS-17) w.c.f 13-10-2015 with all back benefits. The Khyber Pakhtunkhwa Service Tribunal vide order dated 18-04-2024 accepted the subject service appeal as prayed for.

After a threadbare discussion on the subject case particularly hearing the stance of Administrative Department, it was decided with consensus by the Scrutiny Committee that the subject case is a Fit case for tiling of Appeal/CPLA before the Supreme Court of Pakistan on the following main grounds amongst others:-

That Para-VI and VII of the Promotion Policy of Khyber Pakhtunkhwa does not support the proforma promotion.
