APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 THE **EFFECT THAT** DECLARATION TO ADVERSE REMARKS IN THE ACRS FOR THE PERIOD FROM 01.01.2022 TO 08.06.2022 ARE TO BE EXPUNGED FROM THE SAID ACR BECAUSE AS PER WITHOUT ACR COLUMN OF **PART-II** NEGATING **SPECIFICALLY** ACHIEVEMENTS/ASSIGNED DUTIES AWARDING OF ADVERSE REMARKS ARE NULLITY IN LAW. THE APPELLANT HAS SERVED FROM DAWN TO DUSK IN THE RESPONDENTS' DEPARTMENT AND DURING THE SAID PERIOD, HE HAS NOT BEEN COUNSELED VERBALLY OR THROUGH ANY LETTER. IN SUCH A SITUATION, ADVERSE REMARKS ARE PERVERSE, PUNGENT AND BASED ON MALAFIDE INTENTIONS AND THE SAME ARE LIABLE TO BE EXPUNGED.

JUDGMENT

KALIM ARSHAD KHAN CHAIRMAN: The appellant's case in brief, as per averments of the appeal, is that adverse remarks were communicated to him which were recorded in his Performance Evaluation Report (PER) for the period from 01.01.2022 to 08.06.2022 and communicated to him vide letter dated 20.02.2023.

- 2. Feeling aggrieved, he filed departmental appeal for expunction of the impugned adverse remarks but his appeal was not responded, hence, the present service appeal.
- 3. On receipt of the appeal and its admission to full hearing, the respondents were summoned, who put appearance and contested the appeal by filing written reply raising therein numerous legal and factual objections. The defense setup was a total denial of the claim of the appellant.
- 4. We have heard learned counsel for the appellant and learned Additional Advocate General for the respondents.
- 5. The Learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned Additional Advocate General controverted the same by supporting the impugned order(s).
- 6. Perusal of record shows that appellant was serving as Junior Clerk in the Prisons Department in Haripur. The disputed remarks in the PER for the period from 01.01.2022 to 08.06.2022 vide order dated 20.02.2023 as under:

- 7. We have given due consideration to the adverse observations in the light of relevant instructions and we find that some of them do not appear to have been strictly observed. It is provided in the Guidelines that reporting officer is expected to counsel the officer being reported upon about his weak points and advise him how to improve and that adverse remarks should ordinarily be recorded when the officer fails to improve despite counseling. In the present case, however, there is nothing to show that such proper counseling was ever administered to the appellant. In view of the importance of this instruction, the Reporting Officer, or the Countersigning Officer should not only impart appropriate advice but also keep a record of such an advice having been duly administered.
- 8. For the reasons mentioned above, we are of the opinion that the adverse remarks in this case have been recorded in disregard of the relevant instructions. Therefore, on acceptance of this appeal, the adverse remarks recorded in the PER for the period from 01.01.2022 to 08.06.2022 are expunged. Costs shall follow the event. Consign.
