Appeal under section 4 of The service Tribunal Act,1974 against the order of the Respondent No.3, vide order dated 29/07/2024 No 11250/G/P.F, whereby the Appellant's appointment order was <sup>Removed by</sup> ~~withdrawn~~ and major punishment was imposed on appellant despite the fact that the Bed is not the requisite qualification for appointment as DM (Drawing Master) and appellant has also submitted written applications but was ignored as a result of disciplinary proceedings.

**Prayer in Appeal:-**

That the appellant may please be restored to the position prior to 29/07/2024 with back service benefits and seniority may please be ordered in accordance with the order as placed prior to 29//07/2024 and Pay may kindly be ordered to be released immediately and order of respondent no 3 dated 29/07/2024 Endst: No 11250/G may please be declared null and void and without lawful authority.

**Respectfully Sir,**

Appellant submits as under

1. That the Respondents have advertised different cadre post of teaching through advertisement no . (Copy of advertisement attached as annex "A")
2. That the appellant has applied for the post of DM and was appointed through appointment order Endst no 6949/G/DM ETEA2021-22 dated 05/09/2022. (Copy of appointment order attached as annex "B")
3. That the respondent no 3 has also issued appointment orders regarding DM where in last appointed candidate having score 138.36 while score of appellant is 138.74 so is discriminated. (Copy of other appointments orders of DM attached as annex "C")
4. That Appellant was aggrieved from the order of respondent no 3 moved appeal before director education vide dairy no 2046 dated 01/08/2024 which is yet to be decided by the respondent no 2. Copy of departmental appeal attached as annex "D"
5. That the appellant is highly qualified having M.Phil in agronomy from university of agriculture Peshawar. (Qualification / documents attached as annex "E")
6. That the appellant applied through ETEA for the said mentioned post and scored 77 marks in ETEA result.
7. That when appellant perused the provisional merit list of DEO office then appellant filed an application before the DEO concern for correction in score of the appellant on 25/05/2024. (Copy of application for correction to DEO attached as annex "F")
8. That after appointment the service of appellant was regularized vide notification Endst no 10346/G dated 06/12/2022. (Copy of regularization notification attached as annex "G")
9. That the appellant has performed his duties efficiently from the date of taking over the charge on 07/10/2022 till withdrawal by respondent no 3. (Copy of duty performance certificate is attached as annex "H")

10. That the appellant, along with many others, were given NOC for admission in B.Ed and now the appellant has completed the B.Ed from Mardan College of health & physical education Mardan. (Copy of B.Ed from AWKUM in progress is attached as annex "I").

11. That the respondent no 3 issued show cause to appellant which was properly and through proper channel replied by the appellant, the reply of the appellant was ignored and major penalty of removal from service was imposed on appellant which is wrong and illegal. (Copy of show cause and reply attached as annex "J")

12. That the respondent no 3 has imposed major penalty by ~~withdrawal~~<sup>Removal</sup> of appointment order of appellant without any lawful reason. Copy of ~~withdrawal~~<sup>Removal</sup> order attached as annex "K"

13. That the impugned order of respondent no 3 is illegal, unjustified and against the principles of natural justice. Hence, the same is liable to be set-aside on the following amongst many other grounds:-

GROUND

- A. That the impugned order is against the law, facts and circumstances of the case. Hence, the respondents have acted beyond their authority, by imposing major penalties.
- B. That the impugned order is against the principle of law and there is no provision in the Esta Code to withdraw a valid order.
- C. That no charge sheet, statement of allegations, enquiry have been issued to appellant while passing the impugned order, so is not sustainable in the eye of law.
- D. That the appellant have been condemned unheard which is against law.
- E. That the whole of the proceedings were carried-out in utter disregard to the relevant rules.
- F. That Appellant seeks leave of this Honorable Tribunal to claim further grounds also.





TERMS AND CONDITIONS

- 1) Their services shall be governed by the Khyber Pakhtunkhwa Civil Servant Act, 1973, the Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturers, Instructors and Doctors) Regularity Act, 2011, and such rules and regulation as may be issued from time to time by the Government.
- 2) Their services will be considered regular and they shall be eligible for pension/deduction of GP Fund in terms of Khyber Pakhtunkhwa Civil Servant Act, 1973, as amended in 2013, however, the teachers appointed on or after 07-06-2022 shall be dealt with section (2) (2) of the Khyber Pakhtunkhwa (Amendment) Act, 2022.
- 3) Their services are liable to termination on one-month notice from either side. In case of resignation without notice their one month Pay/Allowances shall be forfeited to the Govt.
- 4) They shall possess the same qualification and experience required for the subject post on regular basis as specified in Section (3) (a) of the Act.
- 5) Their regularization shall not affect the service promotion quota of all service cadres as specified in Section (3) (c) of the Act
- 6) They shall be entitled for seniority and pay from the date of initial appointment on adhoc/contract basis as specified in Section (3) (d) of the Act.
- 7) They shall perform duty for at least three (03) years from the date of taking over charge where they were appointed/posted initially.
- 8) The regularization shall not be in favor of those teachers who have not taken over charge or remained absent from duty or resigned from service.
- 9) The teachers, regularized through this notification, shall be confirmed after successful completion of in-service mandatory training as specified in their Service Rules notified vide notification No. SO (PE)4-5/SSRC/Meeting/2012/Teaching Cadre/2017 Dated 07-03-2018 within two consecutive attempts otherwise their appointment order shall be considered as withdrawn/cancelled from the date of declaration of result of the second attempts made in the induction program.
- 10) Concerned Principals/Headmasters are directed to check/verify the documents/extension orders e.t.c. of the regularized teachers once again with the criteria mentioned for regularization, if the teachers don't meet the criteria their services shall be considered as ceased.



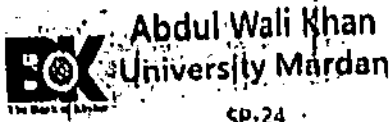

3. That the Directorate advertised DM posts for District Mardan.
4. That my client having score of 138.74 marks in aggregate.
5. That appointment order was issued only of 17 candidates where in my client is placed on serial 4 at DCMHS no 3 Mardan.
6. That my client approached your office regarding verification of degrees till MS from Agriculture University Peshawar which were verified.
7. That my client was regularized vide notification dated 06/12/2022 endst no 10346/G 2019-22 DM regularization.
8. That the DEO issued notice to my client that your Bed is from unrecognized University then my client approached your office and requested in writing that it does not belong to him as he is on merit and last appointed candidate by your office is Muhammad Kashif with score of 138.36 which far below in merit than my client.
9. That my client is punctual and loyal teacher and is performing his duties efficiently. In this already principal of the school concern has given duty performance certificate to your office.

10. That my client has approached time and again your office for release of pay but despite releasing of pay your office has issued showcause notice to which reply has already been submitted and then was called for personal hearing where he appeared and stated that I had never done any Bed from Punjab as my clients Bed is in progress and last semester exam has already been conducted and result is awaited from AWKUM. Documents of first two semesters are available if desired for perusal.

11. That my client was kept engaged till date but of no use.

12. That my client has also requested DSC but that was also ignored.

13. That my client again has made request before you for release of pay order as my client is on merit but you ignored it again and again.

That due to malafide intention you have not considered my client's requests for the said mentioned pay release and issued showcause which is clear violation of principles as in Izaz case DEO has issued corrigendum for deducting unrecognized university marks or give time for degree from recognized institution/university like skill development council case.

14. That my client's requests are self-explanatory but your office has ignored it again and again.

15. That you should issue pay release order to my client with back service benefits and present no excuses.

16. That the said not releasing of pay, amounts to discrimination as to all other appointed with my client has been issued pay release order.

17. That you have violated constitutional fundamental rights of my client and also has ignored the verdict of superior courts on this point and for which you are responsible to correct it and issue pay release order with back service benefits along with withdrawal of showcause notice endst 3578-79 dated 25/06/2024.

18. That you should redress the grievances of my client and issue him release of pay otherwise my client reserves the rights to sue


you by name in court of competent jurisdiction and in that case all the responsibility shall be incurred upon you.




