**Respectfully Sheweth:-**



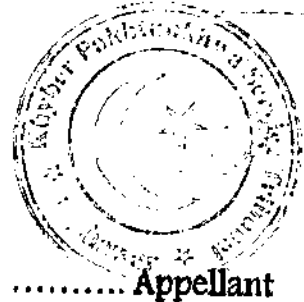
