
Application for Restoration of above mentioned appeal

It is therefore most humbly prayed and requested that the impugned order of non Prosecution may kindly be set aside and the appeal may kindly be restored against its original number.



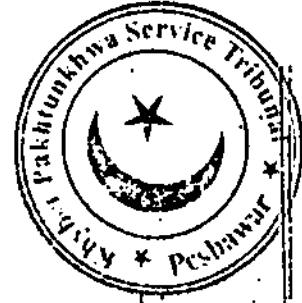
