

Provided that for ongoing projects, salary of existing staff shall be fixed in a way that it is not less than the salary last drawn.
 Provided further that projects where daily waged staff is to be hired as per requirement/nature of project, in all such cases the monthly income of the hired staff shall not be less than the minimum wages fixed by Government from time to time.
 (iv) Negotiable Pay Package: Special Pay Package as determined by the administrative department shall be included in the P.C.I with full justification for such positions which are (a) either specialized in nature, (b) Unique in terms of qualification, experience and availability of such services in market are either scarce or monopolized and (c) highly paid.
 Note: In the instant case BPS system shall not apply. Furthermore, approval of such positions shall be granted by the Additional Chief Secretary, Planning & Development, Khyber Pakhtunkhwa.
 Civil Servants appointed against project posts on deputation basis will get pay and allowances corresponding to their own pay scales, a deputation allowance at the rate of 20% of the basic pay subject to the maximum of Rs.12,000/- per month, and a project allowance equal to two basic salaries last drawn on regular post.
 Provided that if the circumstances warrant for provision of special incentives to the deputationists, the same special incentives will be placed for consideration before the committee to be headed by Additional Chief Secretary, P&D with Secretaries of Finance, Establishment and concerned department as members.
