

APPEAL U/S 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 AGAINST THE LETTER/ORDER DATED 25-06-2024 WHEREE DEPARTMENTAL APPEAL OF THE APPELLANT FILED AGAINST HE SENIORITY LIST OF TRAFFIC WARDENS DATED 10-05-2024, HA BEEN REGRETTED.

PRAYER:-

On accor, the of this appeal the imprigned Letter/Order dated 25-06-2024 and Seniority List of Traffic Wardens dated 10-05-2024, may kindly be modified/rectified and official respondents be directed to issue/prepare the Seniority List of Traffic Wardens in accordance with Police Rules 12 (2) (3) i,e on the basis of age, with all back benefits.

Respectfully Submitted:-

- 1. That the appellant is highly qualified having passed Graduation and was initially enlisted in Police Department as Constable and with the passage of time, was promoted as Head Constable.
- 2. That vide advertisement of the Khyber Pakhtunkhwa Public Service Commission, dated 18-09-2017, applications were invited for appointment to the eighty posts of Assistant Sub Inspectors for Traffic Warden System Peshawar (General Quota), and eighty four posts of Assistant Sub Inspectors for Traffic Warden System Peshawar (In-Service Quota). (Copy of Advertisement is enclosed as Annexure A).
- 3. That the appellant being Graduate Head Constable and being perfectly fit, eligible and coming up to the criteria, as per the advertisement, also applied for appointment to the post of Assistant Sub Inspectors (herein after referred to as ASI), from In-Service quota while respondents No 3 to 67 applied in General Quota and after being qualifying the test and interview, was recommended for appointment to the department. The merit position of respondents No 3 to 67 and the merit position of the appellant was conveyed to the department separately vide Letter dated 20-02-2023, where after, the appellant as well as respondents No 3 to 67 were appointed the same day vide separate Notifications dated 14-05-2019. [Copies of Notifications dated 14-05-2019 are enclosed as Annexure B & C).
- 4. That since appointment, seniority of the appellant as well as private respondents was not fixed, therefore Merit List of the appellant as well as private respondents was provided to the department which was not clear, where after, upon request of the department, another Merit List was provided to respondent No 2 vide Letter dated 20-02-2023. (Copies of Letters dated 17-08-2022, Letter dated 12-10-2022 & Letter dated 20-02-2023 is enclosed as Annexure D).
- 5. That after appointment the issue of seniority and selection for various courses including Special Traffic Course and Elite Command Course surfaced, respondents No 3 to 67 were first selected for Traffic Course on 29-12-2022, against which the appellant approached the official respondents by filing Appeal/Representation wherein the appellant also requested for the fixation of seniority which appeal was duly forwarded but to no fruits. (Copy of Appeal is enclosed as Annexure E).
- 6. That similarly, the appellant also approached respondents vide written application for selection to the Elite Command Course which was duly forwarded. (Copy of Application is enclosed as Annexure F).
- 7. That the issue of fixation of seniority of the appellant as well as private respondents was routed through various offices and finally respondent No 2 informed respondent No 1 vide Letter dated 15-05-

2023 that seniority of Traffic Wardens is to be fixed in accordance with Rule 12 (2) of the Police Rules 1934 and accordingly Seniority List of the Traffic Wardens appointed in the year 2019, i,e the appellant and private respondents was provided to respondent No 1 vide Letter dated 31-08-2023, which was prepared in accordance with the Letter dated 15-05-2023 and Rule 12(2) of the Police Rules 1934 on the basis of age and thus appellant was placed senior to the private respondents. (Copy of Letter dated 15-05-2023, Rule 12 (2) of Police Rules and Seniority List of the PASI,s of Traffic Wardens Peshawar is enclosed as Annexure G, H & I).

- 8. That to the utter shock and surprise, respondent No 1 fixed seniority of Traffic Wardens firstly, in accordance with Rule 12 (6) of the Police Rules 1934 i,e on the basis of date of appointment, secondly on the basis of Score in competitive exam and thirdly on the basis of age, which is totally irrelevant to the case of the appellant vide Order dated 10-05-2024, further shockingly official respondents without waiting or inviting objections, the same day also constituted Departmental Promotion Committee for considering the promotion from ASI,s to Sub Inspectors and thus promoted the private respondents deferring the case of the appellant on the ground of not qualifying mandatory Elite Course vide Notification dated 13-06-2024, against which order the appellant has filed departmental appeal. (Copy of Order dated 10-05-2024 & Letter dated 10-05-2024 is enclosed as Annexure J & K).
- 9. That against the Order dated 10-05-2024, the appellant filed appeal dated 93-05-2024 and also filed Writ Petition No 2758-P/2024, the departmental appeal of the appellant was regretted which was communicated to the appellant vide Letter/Order dated 25-06-2024. (Copy of Departmental Appeal dated 13-05-2024 & Letter/Order dated 25-06-2024 is enclosed as Annexure L & M).
- 10. That the impugned Order dated 10-05-2024 and Letter/Order dated 25-06-2024 whereby appeal of the appellant has been regretted, is a gainst the law, facts and principles of justice on grounds inter-alia as follows:-

GROUNDS:

- **A.** That impugned Order dated 10-05-2024 and Letter/Order dated 25-06-2024 are illegal, unconstitutional, and unlawful, without lawful authority and of no legal effect, therefore need the interference of this honorable Court.
- **B.** That the appellant is denied treatment in accordance with law and rules which being his fundamental right as per Article 4, 10-A and 25 of the Constitution and law of the land.

- C. That the seniority was earlier fixed and provided to respondent No 1 vide Letter dated 31-08-2023 which was in accordance with Rules 12 (2) (3) of the Police Rules 1934 besides the Letter dated 15-05-2023 however the seniority of the appellant has been changed and fixed under Rule 12 (6) (E) of Police Rules 1934, which is applicable to the case of officers promoted under 25% Fast Track Promotion and not relevant to the case of the appellant. (Copy of Rule 12 (6) (E) of Police Rules 1934 is enclosed as Annexure N).
- **D.** That the appellant has been deprived of due seniority in violation of Article 10-A of the Constitution, in violation of the principles of natural justice besides providing him any opportunity of hearing.
- E. That prior to appointment as ASI,s the appellant was enlisted as Constable, some of his colleagues were promoted as Head Constables and were having at least 5 years' unblemished service record at his credit, so are required to had been given the benefit of their age and previous service by placing him senior to the appointees from General Quota. Even the appellant due to previous are to retire earlier than the private respondents, hence too are required to be placed senior to private respondents.
- F. That since Police Rules is special law applicable to the incumbents of the department and Rule 12 (2) (3) is very much clear about fixation of seniority, according to which seniority in such case is to be fixed on the basis of age, hence, seniority is required to be fixed in accordance with special law, as General law cannot override special law.
- G. That it is worth to mention that in case of In-Service candidates, minimum qualification of Bachelor while for General Quota, the minimum qualification of Intermediate is required besides the appellant was also required to have five years' service with some courses/trainings and even Head Constables hence too the appellant cannot be placed juniors to the private respondents.
- H. That even Rule 17 (2) of the Khyber Pakhtunkhwa Civil Servants (Appointment, promotion & Transfer Rules 1989 are also very much clear on the point which also favors the case of the appellant. (Copy of Rule 17 (2) of APT Rules 1989 is enclosed as Annexure O).
- I. That even the Punjab Police Rules are very much clear on the point, according to which, the ASI,s appointed through selection by the Commission from the Graduate Constables or Head Constables shall rank senior to the ASI,s appointed on the same date through initial recruitment, hence the appellant is entitled to the same treatment and should not be discriminated. (Copy of Rule 6 (4) of Punjab ASI (Appointment, Promotion & Conditions of Service Rules is enclosed as Annexure P).
- J. That according to Section 13 (3) of Police Act, 2017, the promotion of Traffic Wardens shall be separate up to the rank of Inspector, separate Seniority

Lists are to be maintained of the ASI,s and Sub Inspectors and a consolidated list is maintained after being promoted to the rank of Inspectors while in instant case, the stated Police Rules are baldy violated, hence though being distinct yet issuing consolidated merit/seniority is not known to law.

- K. That the malafide of respondents is proved from Letter dated 10-05-2024, whereby Departmental Promotion Committee has been constituted for considering the cases of promotion from ASI to Sub Inspector, the same day on which seniority was issued, without waiting for the objections over seniority list.
- L. That the issue herein is not of inter-se seniority as posts in both categories were separately advertised, independent process was conducted, separate Merit Lists were prepared, separate recommendations were sent to department, and separate appointment Orders were issued on General Quota candidates and the In-Service quota candidates.
- **M**. That there is no omission and commission on part of the appellant and the appellant could not be punished for the fault of others if any.
- **N.** That the appellant seeks the permission of this honorable Tribunal for further/additional grounds at the time of arguments.

It is therefore prayed that Service Appeal of the appellant may kindly be accepted, as prayed for.

Any other relief not specifically asked for and deemed appropriate in the circumstances of the case, may also be granted in favor of the appellant.

Physical Endurance Tests-

All the eligible candidates applying for initial recruitment for the post of Assistant Sub-Inspector, shall have to qualify the following physical endurance lesis to be conducted by a team of three members, two from the Public Service Controlssion and one from Police Repartment to be nominated by the Police Repartment.

All categories of Candidates, both general and in service, who qualify the physical endurance test, shall be eligible to appear in the written examination to be conducted by the Khyber Pakktur khwa Public Service Commission.

Paychological Test:

Conditates, both general and in Service, who qualify written examination, shall be talled by the Public Service Commission for Psychological test to be conducted by Psychologist of Khyher Pakhtunkinwa Public Service Commission. The result of this test shall be a guide for the interview panel whether a conditate is suitable for the militar lab and the suitable for the

Yiva Voce Examination:-

Psychological test shall be followed by viva voce exam to be conducted by the Public Service Commission. The candidate shall appear before the interview panel at the time of viva voce examination. Failure in or obsence from viva voce shall mean that the candidate has failed in qualify the examination for the post of Assistant Sub-

Final merit list shall be prepared by the Knyber Pakhtunkhwa Pahlic Service Commission on the basis of marks obtained in written test & viva voce. If the total marks of any of the two candidates are equal, the candidate having higher marks in viva voce test shall be placed higher on merit and, in case, where the marks obtained in viva voce are also equal, the candidate older in age shall be placed higher on merit int.

Candidates recontracted by the PSC for appointment as ASI Traffic Warden shall undergo medical examination to be conducted by Director Realth Services Government of Rhyber Pakhtunkhwa.

issuance of appointment order shall be subject to background clearance reports from intelligence agencies.

GENERAL CONDITIONS

- O Age shall be recknized on 01-01-2018. All the candidates are required to be academically qualified in all respects by 17-10-2017. Candidates not in passession of the required qualification by the last date for receipt of application shall not be considered, Maximum age initi as prescribed in the recruitment rules shall be relaxed upto ten years for government servants who have completed two years continuous service or employees or Ex-employees of development projects of the Govt of Khyber Pakhtunkhwa and employees or Ex-employees of development projects of the Federal Govt under the administrative control of the Govt of Khyber Pakhtunkhwa shall also be entitled to age relaxation equal to the period served in the projects, subject to a maximum limit of ten years provided that this age relaxation stell, not be available in conjunction with any other provisions of the age relaxation rules.





LEGAL GUIDANCE FOR CONFIRMATION AND PROMOTION OF

TRAFFIC WARDENS.

In compliance of Peshawar High court judgment in COC No. 48/-P/2022, In COC No. 166-P/2021, in writ petition No.3530-P/2020 dated 1st November, 2022 and in response to various letters of your office i.e. 141/EC-1, dated 03/01/2023& 2301/EC-1 dated 14/02/2023, regarding the promotion of Traffic wardens, it is submitted that amended Rule 12.4 of Police rules 1934, is a legal instrument and approved Rule for the recruitment, Training/promotional courses (lower, intermediate and upper) and promotion of Traffic wardens. Similarly Rule 12.2 of rules Ibid is explicit for the inter-seniority of Traffic warden.

Moreover, the promotion of Traffic warden shall be separate up to the rank of Inspector at per section 13.3(X) of KP Police Act 2017 and Rule 12.4(4) of Police Rules 1934. Hence, the officials of traffic warden shall be promoted on the following prescribed criteria mentioned Pc Rules 1934;

- The promotion from FC to HC shall be governed as per Rule 12.4(4) read with rule 13.8 of the Rules ibid and their seniority Lists shall be kept in the office of Unit Heads i.e. CTO/DPO.
- The promotion from HC to ASI shall be governed as per Rule 12.4(4) read with rule 13.9 of the Rules ibid and their seniority Lists shall also be kept in the office of Unit Heads i.e. CTO/DPO.
- The promotion from ASI to SI shall be governed as per Rule 12.4(4) read with rule 13.10 of the Rules Ibid and their seniority List-E shall be kept in the respective offices of CCPO/RPOs.
- 4. The promotion from SI to Inspector shall be governe i as per Rule 12.4(4) read with rule 13.15 of Rules ibid and their seniority List-F shall be maintained at CPO level.

However, their transfer/posting shall be treated as per section 13.8 of KP Police Act 2017 and all other matters of Traffic wardens shall be governed as per the rules ibid and Act ibid. Therefore it is communicated to treat Traffic wardens accordingly.

12-2. Seniority and probation.- (1) The seniority of Assistant Superintendents of Police is regulated by the orders passed from time to time by the Secretary of Strip and the Central Government.

No Probationary Assistant Superintendent of Police shall be permanently appointed as an Assistant Superintendent of Police until he has passed the prescribed departmental examinations.

A Probationary Assistant Superintendent of Police who does not qualify by passing these examinations within two years, or at the first examination after two years, from the date of his joining the service, will be removed from Government service; provided that the provincial Government shall have power to relax this rule in special cases, when the Probationary Assistant Superintendent of Police is likely to make a good police officer.

Seniority shall, however, be finally settled by dates of confirmation, the seniority inter se of several officers confirmed on the same date being that allotted to them on first appointment. Provided that any officer whose promotion or confirmation is delayed by reason of his being on deputation outside his range or district shall, on being promoted or confirmed, regain the seniority which he originally held vis-à-vis any officers promoted or confirmed before him during his deputation.

The seniority of lower subordinates shall be reckoned from dates of appointment, subject to the conditions of rule 12-24 and provided that a promoted officer shall rank senior to an officer appointed direct to the same rank on the same date.

It is submitted that seniority list of Traffic Wardens has been issued on 10.05.2024. The applicant has the following objections on the seniority list.

- 1. That seniority list of Traffic Wardens has been issued on 10.05.2024 while on the same date a letter for "Departmental Promotion Committee" has been issued by Capital City Police Officer, Peshawar vide No. 6878-85/EC-I dated 10.05.2024 (Annexure "A") which is against the natural justice as no time limit has been given to the employees of Traffic Wardens for submission of their objections/reservation on the issued seniority list.
- 2. That the Capital City Police Officer, Peshawar has sought opinion from AIG Establishment vide letter No. 14558/EC-1 dated 17.08.2022 (Annexure "B") that seniority list received from KP Public Service Commission is not clear that whether in-service quota candidates will be reckoned senior than general quota or otherwise, as both the seniorities position start with one (01). In response of the letter, Registrar, CPO, KP, Peshawar informed vide letter No. 1863/E-II dated 12.10.2022 (Annexure "C") to follow Rule 12.2(3). Besides CPO has also issued egal guidelines for confirmation and promotion of traffic Wardens vide letter No. 1794/Legal, dated 15.05.2023 (Annexure "D") to follow 12.2(3) of Police Rule 1934 for inter-se-seniority of Traffic Warden but CCPO despite Legal guidelines issued the seniority list of Traffic Wardens vide 8317-22/EC-I dated 10.05.2024 (Annexure "E").
- 3. The in-service quota advertisement (Annexure "F"), merit list (Annexure "G"), notification inservice candidates (Annexure "H") and General candidates (Annexure "f") are separate from general quota but now CCP has issued consolidated merit list of in-service quota and general quota, as the Khyber Pakhtunkhwa Police Rules are silent but on the other side Punjab Police Rules are clear in this regard that the "Assistant Sub-Inspectors appointed through selection by the Commission from the graduate Constables or Head Constables shall rank senior to the Assistant Sub-Inspector appointed on the same date through initial recruitment" (Annexure "I")

Therefore, your good office is hereby requested to kindly cancel/withdraw letter No. 8317-22/EC-I, dated 10.05.2024 (senioritý list) and 6873-85/EC-I, dated 10.05.2024 (DPC) until the completion of mandatory courses of the entire batch and settle the seniority of the in-service PASI's as per rule's.

 - (a) in the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission ⁴⁸[or as the case may be, the Departmental Selection Committee;] provided that persons selected for appointment to post in an earlier selection shall rank senior to the persons selected in a later selection; and
 - (b) in the case of civil servants appointed otherwise, with reference to the date of their continuous regular appointment in the post; provided that civil servants selected for promotion to a higher post in one batch shall, on their promotion to the higher post, retain their inter se seniority as in the lower post.

Explanation-1:- If a junior person in a lower post is promoted to a higher post temporarily in the public interest, even though continuing later permanently in the higher post, it would not adversely effect the interest of his seniors in fixation of his seniority in the higher post.


Explanation-II:- If a junior person in a lower post is promoted to a higher post by superseding a senior person and subsequently that senior person is also promoted the person promoted first shall rank senior to the person promoted subsequently; provided that junior person shall not be deemed to have superseded a senior person if the case of the senior person is deferred for the time being for want of certain information or for incomplete record or for any other reason not attributing to his fault or demerit.

Explanation-III:- A junior person shall be deemed to have superseded a senior person only if both the junior and the senior persons were considered for the higher post and the junior person was appointed in preference to the senior person.

- (2) Seniority in various cadres of civil servants appointed by initial recruitment vis-à-vis those appointed otherwise shall be determined with reference to the dates of their regular appointment to a post in that cadre; provided that if two dates are the same, the person appointed otherwise shall rank senior to the person appointed by initial recruitment.


