Respectfully Sheweth:

Reply to the Preliminary Objections:

All preliminary objections raised by the respondents are illegal, vogue, without substance, therefore not worth consideration, the Hon'ble Tribunal has got jurisdiction to adjudicate upon the matter, the appellant has got jurisdiction to adjudicate upon the matter, the appeal is maintainable, therefore is no manipulation, the appeal is well within time, appellant has come to the court with clean hands and there is no mis-joinder or non-joinder of the case.

(Copies of the documents related to the respondents no. 3 to 5 & other are attached as Annexure AA)
4. That the scoring criteria has now been revealed by the respondents against which relevant evidence has already been attached.
5. That Annexure E & acknowledgement of the DSO on page 39 of the main appeal is very clear.
- 6-7. Contents of Para 6 & 7 are confusing just to mislead. Further to add that the appellant filed grievances against the tentative senior list which were not resolved and then final seniority list was issued against which the appellant filed the departmental appeal which was dismissed.

G R O U N D S:

All the replies to the grounds are baseless and without any cogent reason. The appellant through compelling evidence has brought to the knowledge of this honourable Tribunal of how grave violations of constitution of Pakistan, attracted Rules and Regulations have been blatantly committed by the respondents, just to

illegally accommodate the private respondents.
