Correct to the extent that the mentioned amendment has been made by the Establishment Department in light of the judgment dated 14-01-2021 of Khyber Pakhtunkhwa Service Tribunal in appeal No. 868/2019 titled Iftikhar Khan, Assistant (BPS-16) Khyber Pakhtunkhwa Service Tribunal VS Government of Khyber Pakhtunkhwa through Chief Secretary and three other respondents which has been challenged before the Apex Court and pending for adjudication. It is submitted that under Rule 3(2) of the Khyber Pakhtunkhwa, Civil Servants APT Rules, 1989, the method of appointment, qualification and other conditions applicable to post shall be such as laid down by the Department concerned in consultation with S&GAD and Finance Department (Annex-I) Under the Rule ibid SSRC has been constituted vide Establishment Department's Notification dated 09-02-2022 (Annex-II), which has the mandate inter alia to: (i) frame service Rules and make amendments thereto in respect of Provincial Government Departments; (ii) Administrative Department will prepare draft amendment notification and will get the same vetted by Law Department; (iii) Rules or amendments thereto will be notified after

obtaining approval of the Secretary Establishment. It is further submitted that in light of observations contained in Service Tribunal's Judgment dated 14-01-2021 in S.A. 868/2019, the service rules of the staff of the Service Tribunal were discussed in detail in a meeting of SSRC held on 10-01-2024 (minutes at Annex-III) wherein the forum had agreed inter-alia to the amendment in the Service rules of the post of Additional Registrar /Superintendent/Budget and Account Officers (BS-17) without the condition of having any required qualification. However, at the vetting stage. Law Department raised certain observations vide letter dated 22-03-2024 (Annex-IV) thereby advising to reconsider the same in SSRC meeting. Law Department's observations include that employees with lower qualification if promoted as Additional Registrar/Superintendent /Budget & Account Officers (BS-17) would not be able to run the affairs of such posts. Therefore, the matter was again placed before the meeting of SSRC held on 29-03-2024 (minutes at Annex-V) and after due deliberation the forum agreed inter alia to service rules of the post of AR/Supdt/B&A Officer (BS-17) with graduation as mandatory, qualification. The amendments were notified vide Establishment Department Notification dated 01-04-2024 (Annex-VI) after vetting by Law Department.

- 7. As already explained in Para-6 above.
- 8. Incorrect, as stated in the preceding paras and observations of Service Tribunal judgement dated 14.01.2021 in Service Appeal No 868/2019, a joint Seniority list is required to be maintained of Office Assistants, Assistant Registrar, Law Drafter and Cashier-cum-Assistant (BPS-16) by clubbing them and giving effect that the office Assistants (BPS-16) have nine posts with meagre promotion prospects against the only post of Superintendent (BPS-17).
- 9. Correct to the extent that the official submitted his departmental appeal and the Khyber Pakhtunkhwa Service Tribunal was requested vide letter No.SOE-III(E&AD)/5-1/KP-ST/ SR-M/2024 dated 14.05.2024 for views / comments. Accordingly, Khyber Pakhtunkhwa Service Tribunal replied vide letter No.1470/ST dated 05.06.2024 and stated that rules were amended vide Notification No.SOE-III(E&AD)/5-1/KP-ST/SR-M/2024 dated 01.04.2024 passed by Khyber Pakhtunkhwa Service Tribunal in pursuance of judgment in Service Tribunal No.868/2019 dated 14.01.2021. It is further stated in the reply of Khyber Pakhtunkhwa Service Tribunal that "No further comments / views are required to be furnished" (Annex-VII).

#### **GROUNDS:**

# Agenda: Amendment in Service Rules of staff of Khyber Pakhtunkhwa Service Tribunal in light of Court Judgment.

The representative of Services Tribunal, Khyber Pakhtunkhwa briefed the forum regarding amendments in Service Rules of Ministerial Staff of Khyber Pakhtunkhwa Service Tribunal stating that one, namely Mr. Iflikhar Khan, Office Assistant(BS-16) had filed Service Appeal before the Hon'ble Service Tribunal, Khyber Pakhtunkhwa praying for amendments in the existing Service Rules to the extent that a joint seniority may be maintained of Assistant Registrar, Assistant, Law Drafter and Cashier-cum-Assistant(BS-16) for the purpose of promotion to the post of Superintendent/Additional Registrar/Budget & Account Officer (BS-17). Accepting the said appeal, the Khyber Pakhtunkhwa Service Tribunal vide its judgment 868/2019 dated 14.01.2021 directed to amend the Service Rules in order to give fair chance of promotion to the Assistants to the post of Superintendent/Additional Registrar/Budget & Account Officer (BS-17).

After detailed discussion the forum unanimously agreed to the proposed amendments in the existing Service Rules of ministerial staff of Khyber Pakhtunkhwa Service Tribunal as per Appendix-I.

#### Local Government Department.

Agenda: Amendments in the Service Rules of the Directorate General Local Government and Rural Development Department, Khyber Pakhtunkhwa.

The representative of Local Government Department briefed the forum on agenda item wherein amendments in the existing Service Rules of Assistant Director (BPS-17) has been proposed. He maintained that under the Local Government Act, 2013 as amended in 2019 the Local Government setup has been devolved to Tehsil level which has led to creation of 96 new posts of Assistant Director (BS-17). Presently all the posts falling under initial quota are lying vacant. The situation has led to acute shortage of Assistant Directors. Therefore, Administrative Department has proposed to increase the promotion quota for Assistant/Senior Scale Stenographer(BS-16) along with proposal of doing away with promotional exam being time consuming exercise.

During the course of discussion, it was proposed that nine (09) weeks of mandatory training may be prescribed for promotion of Assistant/Senior Scale Stenographer (BS-16) to the post of Assistant Director(BS-17) in lieu of promotional exam.

After detailed discussion, the forum unanimously agreed to the proposed amendments in

# MINUTES OF THE MEETING OF STANDING SERVICE RULES COMMITTEE (SSRC) HELD ON 10.01.2024.

I am directed to refer to your letter No. SOE-III(E&AD)/5-1/KP-ST/SR-M/ 2024, dated: 08.03.2024, on the subject noted above, and to state that the proposed draft Notification, carrying amendments in the service rules of the Khyber Pakhtunkhwa Service Tribunal, has been examined, especially in light of the minutes of SSRC and existing service rules, and as such this Department has observed the following:

- (i) that the posts of Additional Registrar, Superintendent and Budget and Accounts Officer, reflected at Serial Nos. 2, 3 and 4 of the existing service rules, have been decided to be clubbed at Serial No.
  2, as evident from the minutes of SSRC, enclosed with your above quoted letter, however, amendment in the draft Notification is only to the extent of Column No. 5, which needs rectification;
- (ii) that the posts of Additional Registrar, Superintendent and Budget and Accounts Officer, reflected at Serial Nos. 2, 3 and 4 of the existing service rules, after clubbing at Serial No. 2, as per minutes of the SSRC, equally requires necessary deletion of Serial Nos. 3 and 4, being redundant, however, it has been observed that no such deletion has been proposed in the draft Notification, hence, the same also needs rectification;

- that as a result of clubbing the posts of Additional Registrar, Superintendent and Budget and Accounts Officer, the Office Assistants, Assistant Registrars, Law Drafters and Cashier-cum-

(BPS-17) and the same irrelevancy is also found in the post of Cashier-cum-Assistants (BPS-16), which needs reconsideration; and

(iv) that the Store Keeper (BPS-14), as per existing service rules, is appointed by initial recruitment, having qualification of at least Diploma in Commerce or Business Administration and as such he is promoted to the post of Cashier-cum-Assistant (BPS-16) having at

least five years service as such, so with this low qualification, would

 he be able to hold the post of Additional Registrar or Superintendent or Budget and Accounts Officer or otherwise.

2. Keeping in view the above, the Administrative Department is, therefore, advised that the matter may be placed before the SSRC for re-consideration, accordingly.

4. However, at the vetting stage Law Department raised certain observations vide letter <u>No. Legis:3(5)1974/3993-97 dated 22.03.2024</u> thereby advising to re-consider the same in SSRC meeting.


