- 1. That the Appellant is not the "AGGRIEVED" person.
- 2. That the Appellant is estopped by his own conduct.
- 3. That the Appellant has not come to the honorable Tribunal with clean hand.
- 4. That the Appellant has no cause of action/locus standi to file the instant appeal.
- 5. That instant Appeal is against the prevailing law and rules.
- 6. That the appellant has concealed the material facts from this Honorable Tribunal. Hence not entitled for any relief and appeal is liable to be dismissed without any further processing.
- 7. That the appeal is groundless and based on malafide, ulterior motive, hence the same is liable to be dismissed.




