**PRELIMINARY OBJECTIONS.**

1. That the Appellant has got no cause of action.

**ON FACTS**

6. In police department, promotion is always subject to seniority cum fitness and fulfillment of eligibility criteria. Correct to the extent, that colleagues of the appellant were promoted as they fulfilled the mandatory criteria required according to Police Rules 1934, but the appellant was deferred due to non fulfillment of the criteria i.e mandatory courses under Rule 19.25 (A). Minutes of the DPC meeting dated 14.07.2023 is attached.

It is pertinent to mentioned that, as the appellant fulfilled the criteria, he was promoted in the subsequent DPC meeting held on 31.07.2024 as an officiating Sub.Inspector. (Minutes of the DPC 2023 & 2024 is attached as A & B)


7. Incorrect, the appeal of the appellant was devoid of merit/law/rules, the appellant being deficient in eligibility criteria.


**GROUNDS:**

1. Incorrect, the colleagues of the appellant were promoted because of fulfill their requirements and the appellant was dropped due to incomplete mandatory training courses under Police Rules 19.25 (A)
2. Incorrect, the reply has already been given in the above Para no.1.
3. Incorrect, all officials were treated similarly and equally under the law as well as per the judgments of the apex court. No discrimination has been done by the department but the appellant was deferred due to not fulfill the required criteria.
4. Incorrect, the appellant was dropped due to incomplete mandatory training courses under Police Rules 19.25 (A).
5. Incorrect, the promotion order dated 14.07.2023 did not ignoring the appellant from promotion to the rank of officiating Sub-inspector but he was deferred due to incomplete mandatory training courses under Police Rules 19.25 (A).

**PRAYER:**

In view of the above Para wise comments, it is most humbly prayed that the Appeal of the Appellant may kindly be dismissed with cost.
