RESPECTFULLY SHEWETH:

Preliminary Objections:

- Dated 12-11-24
- 1. That the appellant has no locus standi and cause of action.
- 2. That the appellant has not come with clean hands.
- 3. That the appeal is not maintainable.
- 4. That the appeal is bad for non-joinder and misjoinder of parties.
- 5. That the appeal is estopped by his own conduct to file the present appeal.
- 6. That the appeal of the appellant is suffering from material, factual and legal defects.
- 7. That the appellant has filed the instant service appeal before this tribunal just to pressurize the replying respondents and tries to make interference in public service as well as in smooth sunning of official business.
- 8. That the appellant better knows that respondent No.5 to 12 is senior to him in service etc.

FACTS:

- 1. Pertains to record. Moreover, the replying respondents is senior from appellant as they were upgraded/re-designated as District Sports Officers BPS-17 in 2018 and appellant was promoted to BPS-17 in year 2019. Copy of notification are annexed as A.
- 2. Incorrect, misleading. The department maintained the 1st joint seniority list of District Sports Officers. Assistant Director and Administrators (BPS-17) in year 2019 wherein the name of the replying respondent is shown in seniority list at serial No. 14 to 21 while the appellant was not shown in seniority list of 2019 for the reason that at that time appellant was not promoted in BPS-17. Copy of seniority list attached as annexure A1.
- 3. Incorrect and misleading. That the replying respondents were upgraded/re-designated to BPS-17 by the competent authority through a proper channel that the meeting was held on 25-1-2018 ,in which agenda NO.1 was clearly about the up-gradation/Redesignation of post of Deputy District Officer (BPS 16) to District Sport Officer (BPS-17), while in next week 15-2-2018 summary for the restructuring of the post of Deputy District Sports Officer (BPS-16) to the post of District S ports Officer (BPS 17) was moved to the Chief Secretary for the approval. Thereafter, the recommendation of up-gradation Committee was put on note to Chief Secretary Khyber Pakhtunkhwa on 28/02/208 for approval, which was properly approved by the competent authority, on the basis of which a notification dated 08.03.2018 was issued whereby the post of Deputy District Officer BPS-16 to District Officer BPS-17 was upgraded with immediate effect. Copy of notification is attached as Annex-B.
- 4. Misleading and concealed the original fact, that objections filed by the appellant on the tentative seniority are properly replied by the respondent department through notification dated 10.07.2021, in which the competent authority clarify that the position of present appellant that "Muhammad Shakil got promoted from the post of Superintendent and budget and accounts officer respectively on 28.05.2019)". Further while in Para-7 of the notification the respondent department clarified the position of the appellant and the replying respondent that:-

For inclusion in the joint seniority list for promotion to DDS/RSOs, BPS-18, Mr. Amjad Iqbal and Mr. Shakeel Ahmad had to be in the seniority list of Ads for being eligible to be in the list. Both officers entered the list of date 28.05.2019, while other officers at serial No. 08, 09 and 10 were in the seniority list circulated in 2015, and on which promotion of an officer had already taken place. Hence, it is equivalent to challenge the established right of officers at Sr. No. 08, 09 and 10; and



The officers from serial number 11 to 15 had taken charge on the upgraded posts (that is DSO, BS-17) on 08.03.2018, while Mr. Amjad Iqbal and Mr. Shakeel Ahmad promoted to equivalent post of AD, BS-17 on 28.05.2019

Copy of notification dated 10.09.2021 is attached as Annex-C

- 5. Incorrect. Moreover as explain in above Para-4.
- 6. Denied for want of knowledge. Moreover as Atready explain in Para-4 above.

GROUNDS.

A. Incorrect hence denied that replying respondent upgrade/restructured to the post of BPS-17 in 08.02.2018, while the appellant promoted to the post of BPS-17 in 28.05.2019, that while APT Rules, 1989 (Rule 171) is much clear about that and judgment of the Apex Court much clearly about the seniority 2010 SCMR-450,

Bashir Ahmad V/s Muhammad Ali Khan (2010 PLD 1960) seniority has been considered as a vested right which cannot be reserved without lawful justification and in case titled Bashir Ahmad (Supra) the principle of the vested right of the seniority were determined as follows:-

- (i) Every officer is graded service has a vested right to a proper place in the seniority list.
- (ii) This is of the highest importance to him, as well as to the maintenance of proper discipline and order within the service, and consequentially to the public interest which is deeply involved in the maintenance of a proper spirit of order and discipline within the service.
- (iii) Seniority rules are not of the same nature and quality as the great body of departmental rules applicable to the conduct of officers and other such matters relating to the service as a whole, which are capable of being altered by the Government. These rules are of the highest validity and have the quality of settling the important matter of seniority among officers of service."
- **B.** Incorrect hence denied and misleading, that it is a case of upgradation/re-designation and the replying respondents upgraded to the re-designated post with immediate effect dated 08.03.2018
- C. Already explained in Para-1 above.

- **D.** Misleading hence denied that seniority list was made according to law.
- E. Incorrect hence denied.
- F. Incorrect hence denied, Rule-17 (2) of APT Rules Civil Servant Act, 1989 is much clear about the seniority.
- **G.** Incorrect hence denied rules are made in 2019 and at that time no rules were framed.
- H. Misconceiving that this Para is not applicable in this case.

It is, therefore, most humbly prayed that the appeal in hand may be dismissed with cost throughout being merit less and devoid of any legal footing.

AND WHEREAS, the tentative joint seniority list includes the (oliowing officers in the order of seniority as follows: (1) Sikandar Shah (already promoted on Acting Charge Basis) (2) Muhammad Jamshed (3) Muhammad Suleman (4) Anwar Karnal (5) Arnir Zahld Shah (6) Zakir Ullah (7) Razi Ullah Khan (8) Muhammad Ismail Khan (9) Tariq Muhammad (10) Asad Khan (1) Ahmad Zaman (12) Munir Abbas (13) Kashif Farhan (14) Hazrat Ullah (15) Gutrukh Gulfam (16) Amjad Iqbal and (17) Shakeel Ahmad:

AND WHEREAS, Mr. Amjad Iqbal and Mr. Shakeel Ahmad have submitted objections on the said tentalive seniority list that upgradation of posts of Deputy District Sports Officers of (DDSO). BS-16 on 08-03-2018 address only lowards upgradation of posts and not towards promotion of incumbents, therefore, from serial # 08 till 15 were junior to them;

AND WHEREAS, separately, but connected to the instant issue, Mst. Nazia Zaki, AD, HS-17 (previously working in the Directorate of Sports, FATA) has submitted an application to the DG with the subject Appeal For Absorption / Adjustment of Employees of Erstwhile FATA Sports Directorate Into Sports Department (sic) Khyber Pakhtunkhwa Against Regular Position for determination of her seniority in the Directorate of Sports, Khyber Pakhtunkhwa, consequent to the merger of FATA into her relevant cadre;

AND WHEREAS, on 24-05-2021, the DG has submitted two cases of relevant nature to the Secretary Sports and Tourism Department; one, includes a joint application of Mr. Munic Abbas (S#12 above) and Mr. Kashif Farhan (S#13 above) which has relevant documents attached and slipulates opposing comments on the objections/ observations of Mr. Amjad lighal and Mr. Shakeel Ahmad as mentioned above; and, the second, delineates the history of creation of these posts, and the processes adopted for creation of these posts, and subsequent actions, which is signed by the DG:

AND WHEREAS, in order to dispose of these separate but connected applications, a case was moved to the Secretary Sports and Tourism, Department (16 pages excluding the pages of documents, files referred to, and gist of service history of each officer obtained from their personal files) with annexures till C stipulating therein complete examination of case in light of applicable laws and rules and precedents;

AND WHEREAS, the aforementioned objections / observations of the Mr. Amjad legal and Mr. Shakeel Ahmad have been examined and it came to fore that the objections / observations do not stand due to the following reasons:

(1) The inter-se-seniority of serial numbers 08, 09 and 10 (appointed in DDSO, BS-16 between 2006 till 2009 on the recommendations of PSC) was determined and communicated by the PSC vide letter no. NWFP-PSC-SR-VI/16153 dated 03-04-2010, and also vide letter no. K.P.K-PSC-SR-VII/037945 dated 29-08-2012 that it was free from all kinds of discrepancies / anomalies along with stating that such lists are prepared under rule 33 of KPK PSC Regulation, 2003. While Mr. Amjad Iqbal and Mr. Shakeel Ahmad were adjusted as Assistant, BS-14 after being

(2) On the upgradation of posts of Assistants from BS-14 to BS-16 Mr. Amjad lobal and Mr. Shakeel Ahmad assumed charge on the upgraded posts and no DPC was

(3) in pursuance of upgradation of posts of Superintendent from 85-16 to 85-17; Assistant from BS-14 to BS-16; Senior Clerk from BS- 09 to BS-14; and Junior Clork from BS-07 to BS-11 vide Finance Department notification no. FD/SO(FR)10-22/2014 dated 20-05-2014 employees working on these posts took charge on the uppraded posts without any OPC, and without any detriment to their seniority:

(4) in judgement in Writ Petition No. 428-P/2012, Peshawar High Court, Peshawar (PHC) announced on 19-06-2013 (allowed the) petition and direct[ed] the-respondents to apprade the post of the petitioners to 85-16 with immediate effect. And, the judgement announced in CPLA of the case on 26-11-2015. The Government appraised the post, and Finance Department issued the Molification. Again, no DPC was held, and the incumbents took over charges on the upgraded

(5) Fundamental Rules 12-A, 13, and 14 dwells on matters of lien, which cannot be terminated except for the reasons stipulated therein, which are not applicable to the instant case. The officers mentioned in the application had a flen on the post of DDSO, 8S-16, which were upgraded, so the lien is transferred. Otherwise, the officer yould have been without a lien w.e.f the date of upgradation of post to higher scale till the date of notification under DPC

(6) Service Rules of Olrectorate of Sports, Khyber Pakhtunkhwa notified on 29-04-2019 provides that: (1) 40% of Superintendents, BS-17 with two years' service as such will get promoted to Assistant Directors (2) 10% of 88A Officers, 8S-16 with two years' service as such will get promoted to Assistant Directors, BS-17 and (3) 50% by initial recruitment. Mr. Amjad Iqbal and Mr. Shakeel Ahmad got promoted from the post of superintendent and Budget and Accounts Officer respectively on 28-05-2019, as ADs;

(7) For inclusion in the joint seniority list for promotion to DDs/RSOs, 8S-18, Mr. Amjad Iqbal and Mr. Shakeel Ahmad had to be in the seniority list of AOs for being eligible to be in the list. Both officers entered the list of date 28-05-2019, while other officers at serial numbers 08, 09, and 10 were in the seniority list circulated in 2015, and on which promotion of an officer had already taken place. Hence, it is equivalent to challenge the established right of officers at serial numbers 08, 09 and 10; and,

(8) The officers from serial number 11 to 15 had taken charge on the upgraded posts (that is DSO, BS-17) on 08-03-2018, while Mr. Amjad Igbal and Mr. Shakeel Ahmad promoted to equivalent post of AD, BS-17 on 28-05-2019.

AND WHEREAS, the request of Mst. Nazia Zaki is concerned, the Establishment Depailment had opined on it that "the department may examine and dispose-off the case at its own level in light of Rule-17 of the Khyber Pakhtunkhwa Clvil Servants (Appointment, Promotion & Transfer) Rules, 1989 which slipulates that in event of merger Liestructuring of the Departments, Attached Departments or Subordinate Offices, the mich so acountly of civil servants effected by the merger frestructuring as aforesald shall pe determined in accordance with the date of the regular appointment to a cadre or post;

AND WHEREAS, her date of regular appointment as AD, BS-17 in the corresponding cadre of Directorate of Sports, ex-FATA is w.e.f 09-09-2013, as Assistant Director, BS-17;

AND WHEREAS, by this, all officers mentioned above were in BS-16 as DDSO in the year 2013, while Mst. Nazla Zaki was in BS-17 as AD in the same year;

AND WHEREAS, Service Rules stipulate at serial # 3 the criteria for promotion from BS-17 (ONLY ADs and DSOs) to the Deputy Director (Regional Sports Officer, BS-18 as
