Respectfully Sheweth;

The facts forming the back grounds of instant service appeal are arrayed as under;-

- 1. That the appellant was serving as Dak Runner in Police Department District Torghar. The appellant performed his duties with due diligence to the required standard of the police service.
- 2. That on 17/11/2023, the Reader to SP Investigation
 District Torghar claimed that he had handed over
 the case file bearing FIR No. 174 under Section
 302 PPC Police Station Karore to the appellant and
 it was fraudulently shown fake signature of the
 appellant in mail register. But in fact the appellant
 was not aware about the matter and did not receive
 the said file from the reader S.P Investigation
 District Torghar. Copies of Challan Dak etc are
 attached as Annexure "A" & "B".
- 3. That the respondents' department issued charge sheet and the appellant replied the said charge sheet. Reply of charge sheet submitted by the appellant is attached as Annexure "C".

- 4. That respondent No.3 awarded dismissal order of the appellant from service on 15/02/2024. Copy of impugned dismissal from service order dated 15/02/2024 is annexed as Annexure "D".
- That the appellant filed departmental appeal against the impugned dismissal from service order dated 15/02/2024 on 27/02/2024. Copy of the departmental appeal is annexed as Annexure "E".
- of the appellant on 03/09/2024 which was received by the appellant from the office of respondent No.3 on 27/09/2024. Copy of rejection order dated 27/09/2024 is annexed as Annexure "F". Hence, the instant service appeal is filed inter-alia, on the following grounds;-

GROUNDS:-

a) That the appellant was dismissed from service on fake entries and fake signature of the appellant in mail register maintained in the office of S.P Investigation Torghar.

₹ c)

Thus, the appellant committed no misrepresentation and the so-called allegation which was attributed to the appellant was not considered by the Inquiry Committee.

- proceeding against the appellant was supposed to sent the specimen of signature of the appellant as well as the signature affixed in Mail Register to FSL for ascertaining the genuineness and otherwise of the signatures in the Mail Register.
 - That the appellant cannot be dismissed from service unless or until proper inquiry is conducted as per law but here in this case, the appellant was not provided opportunity of cross examining the concerned officials who affixed the fake signature of the appellant in the Mail Register. Therefore, the impugned dismissal from service order dated 15/02/2024 of the appellant is without lawful authority, justification and is against the law.

- 18/11/2023 as the marriage ceremony of one of his cousin was to be scheduled on held on 18/11/2023. Besides, the mother of the appellant was also hospitalized in Civil Hospital Darband Tehsil Mansehra and she was referred to Abbottabad Hospital. Copies of Marriage Card of the cousin of the appellant and prescription slips of ailing mother are attached as Annexure "G" & "H".
- e) That the appellant signs in English but the signature on the Dak is in Urdu which is not the signature of the appellant.
- the period of limitation and the matter relates to the terms and conditions of service. Therefore, this Honourable Tribunal has jurisdiction to entertain the lis.
- g) That the other grounds shall be urged at the time of arguments with the permission of Honourable Tribunal.

It is humbly prayed that on acceptance of instant service appeal the impugned dismissal from service order dated 15/02/2024 may be set-aside and the respondents may graciously be directed to re-instate the appellant in service with all service back benefits.



ORDER

This order will dispose off the departmental enquiry initiated against Israr No.429 while posted as Daak Runner. A letter vide No.475-78/2023/DP2/TOR dated 18.12.2023 received from the office of DPP, Torghar revealed that the case file vide FIR No.174 dated 28.09.2023 u/s 302/34 PPC, PS Karor was not received to his office. However, the case file vide FIR No.mentioned above was handed over to him by the Reader of Head of Investigation, Torghar vide official Challan Daak on 17.11.2023, for submitting to the office of the DPP. Torghar, but he had not submitted the subject case file and misplaced it.

He was charge sheeted for the allegations mentioned above by the Head of Investigation, Torghar vide his office Memo No.647-48//PA dated 21.12.2023 and enquiry was entrusted to Fida Muhammad, SDPO Circle Judbah. He after conducting detailed enquiry into the allegations recommended him for major punishment Dismissal from Service in his report as he has been proved guilty for the allegations mentioned in the Charge sheet and statement of allegations, similarly, the Head of Investigation, Torghar submitted the enquiry file to the undersigned as the defaulter official was serving in Operation Wing, District Torghar. He was called in Orderly Room and heard him in person but he can not advance any cogent reason to prove him innocent.

After going through enquiry file, his negligence of misplacing case file of a henious crime, lack of interest towards his assigned duties and in the light of recommendation of Enquiry Officer and Head of Investigation, Torgnar vide his office letter No.66/Reader dated 19.01.2024. 1, Mohammad Ishtiaq (PSP) District Police Officer, Torghar, being competent authority in exercise of power under the relevant provision of KPK Police Rules, 1975 (with amendment 2014) am constrained to award him major punishment. Therefore, Israi No.429 is hereby awarded major punishment of "Dismissal from service" with immediate effect. Order announced in his presence.

ORDER

This order will dispose of departmental appeal under Rule 11-A of Khyber Pakhtunkawa Police Rules, 1975 submitted by Ex-Constable Muhammad Israr No. 429 of district Torghar against the order of punishment i.e. dismissal from service awarded by DPO, Torghar vide OB No.34 dated 15-02-2024.

"Brief facts leading to the punishment are that the appellant while posted as Daak Runner, a letter vide No.475-78/2023/DPP/FOR dated 18.12.2023 received from the office of DPP, Torghar revealed that the case file vide FIR No.174 dated 28.09.2023 u/s 302/34 PPC, PS Karor was not received to his office. However, the case file vide FIR No. mentioned above was handed over to him by the Reader of Head of Investigation, Torghar vide official Challan Daak on 17.11.2023, but he had not submitted the subject case file and misplaced it."

The appellant was issued charge sheet along with summary of allegations and DSP, Circle, Judbah Torghar was deputed to conduct departmental enquiry. The EO held the appellant responsible of misconduct. He was called in OR and heard in person. However, he failed to advance any cogent justification in his defense. Consequently, DPO Torghar awarded him major punishment of dismissal from service. Hence, the appellant submitted this present appeal.

After receiving his appeal, comments of DPO, Torghar was sought and examined/perused, the appellant appeared before the RPO Hazara on 22-05-2024 and contended that he is innocent and was awarded punishment unjustly. In order to provide him another opportunity of defense his case was remanded back to DPO, Torghar for denovo enquiry through SP Investigation, Torghar. The EO in his findings held the appellant responsible of misconduct.

After receiving the enquiry report of SP Investigation, Torghar the appellant was again called in OR and provided with reasonable opportunity to defend the allegation of misconduct. However, he failed to advance any plausible justification in his defense.

In view of the above, the punishment awarded by DPO Torghar seems evenhanded. Therefore, in exercise of the powers conferred upon the undersigned, upheld the order of District Police Officer, Torghar, and under Rule 11-4 (a) of Khyber Pakhtunkawa Police Rules, 1975 the instant appeal is hereby rejected/filed with immediate effect,
