**SERVIC APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST UNDUE ASCENSION OF RESPONDENTS NO. 05 TO 12 IN SENIORITY WITH THEIR ENLISTMENT AT Sr. NO. 01 TO 08 IN THE FINAL SENIORITY LIST OF FORESTERS IN LOWER HAZARA FOREST CIRCLE, ABBOTTABAD, AS STOOD ON 31.10.2023 and 30-04-2024; AND AGAINST THEIR CONSEQUENT PROMOTION TO THE POST OF DEPUTY RANGER.**

Respectfully Sheweth,

The appellant seeks to submit this Service Appeal with the submissions as follow:-

1. That the appellant was appointed as Forester on 08.03.2016 by initial recruitment and the same date is reflected against his name in the seniority lists of Foresters in Lower Hazara Forest Circle, Abbottabad, issued from time to time after his appointment including the disputed lists dated 31.10.2023 and 30.04.2024.
2. That 04 newly promoted Forest Guards of Siran Forest Division, Mansehra (Private respondents No. 06 to 09) were included in the tentative seniority list of Foresters as stood on 31-12-2022. The said list was issued in the month of March, 2023. They i.e. respondents No. 06 to 09 were placed at Sr. No. 01 to 04 in the said list issued in the month of March 2023, with reference to certain orders described in the remarks column No. 10 against name of each of the said respondents. (Copy of the tentative seniority list dated 31-12-2022 is Annexure "A" and of the orders as Annexure "B/1" and "B2")
3. That the appellant and 04 others with lead name of Syed Tauqeer Ahmed, Forester jointly filed objections against inclusion of the names of above-mentioned four persons in the tentative seniority list at the top. The said objection petition was filed before the Respondent No. 2 and copy of objections was sent to Respondent No. 1 who rejected vide his letter No. 10329/Esttt dated 17-05-2023. (Copy of the objections and rejection letter are respectively Annexure "C" and "D")
4. That a final seniority list of Foresters as stood on 31-10-2023 was issued but kept concealed without its circulation under due course. The appellant came to know about it in the month of February 2024. It may be pointed out that in the tentative seniority list as stood on 31-12-2022, Respondent No. 06 to 09 were wrongly included and the appellant alongwith others raised objections as to their inclusion. However, in purported final seniority list as stood on 31-10-2023, 04 other newly promoted Foresters from the Siran Forest Division i.e. Respondents No. 01 & 10 to 12 were also included. Thus, total 08 newly promoted Foresters of Siran Forest Division (Respondents No. 05 to 12) were included in the said list who were promoted by single order No. 32 dated 19-08-2022 by DFO Siran Forest Division, Mansehra. (Copy of the disputed seniority list dated 31-10-2023

is Annexure "E" while of the promotion order dated 19-08-2022 is Annexure "F").

5. That on the basis of some orders described in Column-10 of Remarks in the disputed seniority lists, the respondents have been respectively enumerated at Sr.No.1 to 8 in disregard to the actual date of their appointment as Forester by promotion; and accordingly, they have been wrongly ascended in the seniority list of Foresters relegating the appellant and few others in seniority under them. (In addition to the copies of orders already annexed as B & B/1 in respect of respondents No. 6 to 9, the copy of Order No. 61 dated 06/06/2023 in respect of respondents # 5, 10 & 12 and of order No. 58 dated 25/03/20 in respect of respondent # 11 are Annexure "G/1 to G/2" respectively).
6. That the appellant alongwith other Foresters sent a joint appeal/objections with the lead name of Syed Tauqeer Ahmed to the Respondent No. 2 and vide Department's letter No.SO(Estt)FE&WD/1-3/Lower Hazara-2023/196 dated 04-01-2024 addressed to the Respondent No. 1 (Conservator of Forest, Lower Hazara Forest Circle, Abbottabad); and with reference to the rules cited in said letter of the Department, it was advised to decide the appeal in line with the cited rules and prepare the seniority list accordingly. (Copy of appeal and of the letter dated 04-01-2024 are Annexure "H" and "I" respectively).
7. That the Department through yet another letter bearing No. SO/FE&WD/13/DPC/872-874 dated 22-01-2024 addressed to Respondent No. 4 (Chief Conservator Of Forest (CCF), Northern Forest Region-II, Abbotabad) with reference to his office letter dated 11-01-2024 on the subject of appeal against seniority list of Foresters, required him to furnish parawise comments through the respondent No. 3 to settle the issue once for all; and Respondent No. 3 was also requested in the same letter dated 22-1-2024 to examine the case in line with the relevant Act/Rules/policies/instructions on the subject upon receipt of complete case from the office of Respondent No. 4 and to submit the case alongwith specific recommendations to the Department for further course of action. (Copy of letter dated 22-01-2024 is Annexure "J").
8. That attested copy of disputed seniority list as stood on 31-10-2023 was delivered to the appellant through proper channel i.e. DFO Haripur and the appellant and others filed appeal/objections before the Respondent No. 4 (CCF, Northern Region-II, Abbottabad) on 15-02-2024. It may be pointed out that the

Respondent No. 1 who issued the disputed seniority list also happened to hold the additional charge of the post of CCF-II Abbottabad (office of respondent No. 4); and he did not take any action on the said appeal. (Copy of the appeal is Annexure "K")

9. That from combined reading of letters dated 04-01-2024 (Annex-J) and letter dated 22-01-2024 (Annex-K), it may be deduced that the Department required re-determination of the seniority of Foresters with reference to the service record of the respondents as Forest Guards. The appellant is at loss to understand when the Department referred the disputed seniority list with reference to appeal of appellant and others to Respondent No. 4 for parawise comments and respondent No. 3 (CCF-I, Peshawar) for examination of the case in accordance with service record of respondents and for furnishing of his specific recommendations to the Department, why comments of Respondent No. 4 and recommendations of Respondent No. 3 were not procured or materialized; and how could it reasonably become possible to issue another final seniority list of Foresters in Lower Hazara Forest Circle Abbottabad as stood on 30-04-2024, keeping the settlement of seniority dispute in vacuum. However, it happened keeping the appellant in dark by not circulating the same under due course for communication of the enlisted officials including the appellant. The appellant and two others submitted a joint application dated 08-05-2024 to respondent No. 1 under Right to Information Act, 2017 for provision of documents including the latest final seniority list of Foresters but in vain. However, the appellant, by anyway, succeeded to get the copy of final seniority list as stood on 30-04-2024 and of the working paper for promotion as well as the promotion order of the respondents No. 05 to 12. (Copy of application dated 08-05-2024, of the Seniority List dated 30-04-2024, of the working paper for promotion as Deputy Ranger, and of the promotion order of said respondent are Annexure "L" "M" "N" & "O" respectively)

10. That unfortunately, the appellant and others were left high and dry by ignoring their joint appeal for correction of their seniority against the respondents under due process, while a panel of Foresters from the disputed seniority list dated 30-04-2024 was prepared including the respondents No. 05 to 12 and appellant with others, keeping the respondents in ascending order above the appellant. Consequently, the respondents 05 to 12 have been benefited by their promotion to the post of Deputy Ranger on the basis of wrong and undue seniority position.

11. That the appellant being aggrieved from the seniority lists dated 31-10-2023 had already filed appeal/objection on 15-02-2024 as discussed in para-9 supra which were yet to be decided but in the meantime final seniority list dated 30-04-2024 was issued as discussed in para-10 supra, and promotion of the respondents No. 05 to 12 as Deputy Ranger was made simultaneously on the basis of seniority list as stood on 30-04-2024. The appellant on getting the copies of the said list and promotion order of the private respondent after a week from submission of application dated 08-05-2024, the preferred departmental appeal before the Respondent No.2 and 3 within time on 11-06-2024 and the same thereafter was processed vide a letter from office of respondent No. 3 addressed to respondent No. 4 and 1 respectively. However, despite expiry of 90 days statutory period, there is no clue as to further dealings with the said appeal. So, a legal presumption as to the rejection of appellant's departmental appeal is inevitable compelling him to invoke the jurisdiction of this Hon'ble Tribunal. (Copy of Departmental appeal is Annexure "P" and of the letter of Respondent No. 3 and of Respondent No. 4 are Annexure "Q" & "R" respectively)
12. The appellant seeks to impugn to the seniority lists mentioned above, orders of Respondent No. 1 antedating promotion of respondents No. 05 to 12 as Forester and their consequent promotion as Deputy Ranger, on the grounds *inter alia* as follow:-

#### GROUNDS

- a) That it is the matter of fact that the respondents No. 05 to 12 were initially appointed as Forest Guard in the Siran Forest Division, Masehra. Survey of seniority list of the Forest Guard of said Forest Division as stood on 30-11-2014, 31-03-2015, 31-01-2017, 31-01-2018, 31-12-2019, 31-12-2020, 31-12-2021 & 31-05-2022 would reveal that they throughout remained Forest Guard in the Siran Forest Division until their promotion as Forester made vide order No. 32 dated 19-08-2022 (Annex-G) on their having come in the promotion zone. (Copies of the aforementioned seniority lists are respectively Annexure S/1 to S/8).
- b) That it is an undeniable fact that the appellant was appointed through direct recruitment on 08-03-2016. At the time of appointment of the appellant through initial recruitment, the respondents were holding a lower post of Forest Guard BPS-08 in the Siran Forest Division, Mansehra.
- c) That the Respondents No. 05 to 12 for the first time came in promotion zone for the post of Forester on the basis of seniority list of Forest Guards as stood on 31-05-2022

(Annex-T/8) in the Siran Forest Division and were promoted in the same year on 19-08-2022. They were promoted as Forester with immediate effect on recommendation of Departmental Promotion Committee (DPC) vide order dated 19-08-2022 but by the orders Annexure B/1 & B/3 and H/1 & H/2 issued by Respondent No. 1, their promotion has been antedated to the date of their appointment as Forest Guard in the Siran Forest Division. The said orders passed by the Respondent No. 1 are not only misleading in factual terms but have been passed in violation of all laws and rules on the subject of promotion and seniority. Hence, the orders as to antedated promotion of respondents are liable to annulled and reversed under the facts and law.

- d) That date of regular appointment is the determinative factor for fixation of *Inter se* seniority of persons appointed through initial recruitment and those appointed by promotion. If date of appointment is the same, the the persons appointed through promotion shall rank senior to those appointed by initial recruitment. In case of the appellant and of the respondents, date of appointment is not the same. The appellant was appointed as Forester on 08-03-2016 while the respondents were appointed as Forester on 19-08-2022 but despite their promotion being with immediate effect on recommendation of DPC, the Respondent No. 1 in violation of law/rules/policy on the subject, proceeded to grant antedated promotion to the respondents in sheer misuse and excess of his authority. Thus, the seniority of the Respondents No. 5 to 12 as determined under orders of the Respondent No. 1 and their consequent promotion to the post of Deputy Ranger being illegally gotten gains are not maintainable and liable to be reversed.
- e) That by reversal of seniority and promotion of the respondents, they are liable to be demoted to the post of Forester and appellant is entitled to be promoted in their place with back benefits.
- f) That this service appeal is within time and if a question arises during hearing about its being time barred, the appellant may be allowed to seek condonation of delay within meaning of Rule-8 of the Khyber Pakhtunkhwa Service Tribunal Rules, 1974.
- g) That other grounds will be raised, if needed, during personal hearing as and when afforded.


With the foregoing facts and grounds, it is respectfully prayed that on acceptance of this appeal, the antedated seniority of respondents No. 05 to 12 may be annulled by setting aside the orders of Respondent No. 1 granting antedated seniority to them with direction for its correct determination having regard to date of their appointment as Forester; and consequently, the seniority of appellant may be restored with placement of his name senior to the said respondents and the latter may be

demoted to the post of Forester and appellant be promoted as Deputy Ranger with back benefits.


Any other relief as deemed fit to redress the grievances of the appellant may also be granted.

I am directed to refer to the subject cited above and to enclose herewith a joint application alongwith its enclosures preferred by Syed Tauqeer Ahmad and other five Foresters having reservations on the seniority list of Forester of Lower Hazara Forest Circle, Abbottabad.

2. The subject case has been examined. As per Rule-17(4) of Khyber Pakhtunkhwa Civil Servants (APT) Rules 1989 "the inter-see-seniority of civil servants in a certain cadre to which promotion in made from different lower posts, carrying the same pay scale shall be determined from the date of regular appointment / promotion of the civil servant in the lower post. Moreover, Explanation -II under Rule 17(1) of the Rules ibid further stipulate that if junior person in a lower post is promoted to a higher post by superseding a senior person and subsequently that senior person is also promoted the person promoted first shall rank senior to the person promoted subsequently; provided that junior person shall not be deemed to have superseded a senior person if the case of the senior person is deferred for the time being for want of certain information or for incomplete record or for any other reason not attributing to his fault or demerit.

3. The above quoted rules clarified that civil servant selected for promotion to higher posts on an earlier date shall senior to those selected for such promotion on a later date and if a civil servant deferred by the DPC he will gain his inter-see-seniority from his juniors who were promoted earlier.

4. Above in view, it is advised that the instant appeal may be decided in line with the above rules by preparing the seniority list accordingly. In case any ambiguity arrived in the subject issue, the case may be referred to this Department through Head of Attach Department for further course of action.



Subject: APPEAL/REPRESENTATION AGAINST UNDUE ASCENSION OF NEWLY PROMOTED FORESTERS IN SENIORITY WITH THEIR ENLISTMENT AT Sr. NO. 01 TO 08 IN THE FINAL SENIORITY LIST OF FORESTERS IN LOWER HAZARA FOREST CIRCLE, ABBOTTABAD, AS STOOD ON 31.10.2023 and 30-04-2024.

Respected Sir,

The appellant seeks to submit this appeal/representation with the submissions as follow:-

1. That the appellant was appointed as Forester on 08.03.2016 by initial recruitment and the same date is reflected against his name in the seniority lists of Foresters in Lower Hazara Forest Circle Abbottabad issued from time to time after his appointment including the disputed lists dated 31.10.2023 and 30.04.2024.
2. That 04 newly promoted Forest Guards of Siran Forest Division, Mansehra were included in the tentative seniority list of Foresters as stood on 31-12-2022. The said list was issued in the month of March, 2023. Those included in the list were Muhammad Iltaf, Zafeer Ahmed, Muhammad Tasleem, Tahir Ayub who were place at Sr. No. 01 to 04 with reference to certain order described in the remarks column No. 10 against name of each of the said four persons. (Copy of the tentative seniority list dated 31-12-2022 is Annexure "A" and of the orders as Annexure "B/1" and "B2")
3. That the appellant and 04 others with lead name of Syed Tauqeer Ahmed, Forester jointly filed objections against inclusion of the names of above-mentioned four persons in the tentative seniority list at the top. The said objection was filed before the Conservator of Forest, Lower Hazara Circle Abbottabad who issued the said list and copy of objections was sent to CCF-II, Abbottabad. The said objections were rejected by the Conservator, Lower Hazara Circle, Abbottabad vide his letter No. 10329/Esttt dated 17-05-2023. (Copy of the objections and rejection letter are respectively Annexure "C" and "D")
4. That having reliably learnt about rejection of their objections before issuing of letter dated 17-05-2023, the appellant and others filed an appeal before worthy Secretary Forest on 26-04-2023. (Copy of appeal is Annexure "E")
5. That a final seniority list of Foresters as stood on 31-10-2023 was issued but kept concealed without its circulation under due course. The appellant came to know about it in the month of February 2024. It may be pointed out that in the tentative seniority list as stood on 31-12-2022, 04 Foresters were wrongly included in the list and the appellant

alongwith others raised objections as to their inclusion. However, in purported final seniority list as stood on 31-10-2023, 04 newly promoted Foresters from the Siran Forest Division were included in the seniority list as stood on 31-10-2023 in addition to those whose inclusion was objected to. Thus, total 08 newly promoted Foresters of Siran Forest Division included who were promoted by single promotion order No. 32 dated 19-08-2022 by DFO Siran Forest Division, Mansehra. Their names are Ishtiaq Ahmed, Muhammad Iltaf, Zafeer Ahmed, Muhammad Tasleem, Tahir Ayub, Muhammad Haroon, Sajjad Ahmed and Syed Ejaz Hussain Shah and they shall be referred as respondents collectively hereinafter. (Copy of the disputed seniority list dated 31-10-2023 is Annexure "F" while of the promotion order dated 19-08-2022 is Annexure "G").

6. That on the basis of some orders described in Column-10 of Remarks in the disputed seniority lists, the respondents have been respectively enumerated at Sr.No.1 to 8 in disregard to the actual date of their appointment as Forester by promotion; and accordingly, they have been wrongly ascended in the seniority list of Foresters relegating the appellant and others in seniority under them. (Copies of said orders are Annexure "H/1 to H/8" respectively).
7. That the appellant alongwith other Foresters sent a joint appeal/objections with the lead name of Syed Tauqeer Ahmed jointly appealed to the worthy Secretary to Government of Khyber Pakhtunkhwa, Climate Change, Forestry, Environment & Wild Life Department, Peshawar and vide Department's letter No. SO(Estt)FE&WD/1-3/Lower Hazara-2023/196 dated 04-01-2024 addressed to the Conservator of Forest, Lower Hazara Forest Circle, Abbottabad; and with reference to the rules cited in said letter of the Department, it was advised to decide the appeal in line with the cited rules and prepare the seniority list accordingly. (Copy of appeal and of the letter dated 04-01-2024 are Annexure "I" and "J" respectively).
8. That the Department through yet another letter bearing (SO/FE&WD/13/DPC/872-874 dated 22-01-2024 addressed to Chief Conservator Of Forest (CCF), Northern Forest Region-II, Civil Line Forest Offices, Abbotabad with reference to his office letter dated 11-01-2024 on the subject of appeal against seniority list of Foresters, certain record was required to be furnished to the Department through CCF Region-I Peshawar. CCF Region-I was requested there in the same letter dated 22-1-2024 to examine it in line with the relevant Act/Rules/policies/Instructions on the subject upon receipt of complete case from the office of CCF Region-II Abbotabad; and to submit the case alongwith specific recommendation to the Department for further course of action. (Copy of letter dated 22-01-2024 is Annexure "K").
9. That attested copy of disputed seniority list as stood on 31-10-2023 was delivered to the appellant through proper channel i.e. DFO Haripur and the appellant and others filed appeal before the Chief Conservator of Forest (CCF), Northern Region-II, Abbottabad on 15-02-2024. It may be pointed out that the Conservator of Forest, Lower Hazara Circle Abbottabad who issued the disputed seniority list also happened to hold the additional charge of the post of with copy to CCF-I and CCF-II and did not take any action on the said appeal so far. (Copy of the appeal is Annexure "L")
10. That from combined reading of letters dated 04-01-2024 (Annex-J) and letter dated 22-01-2024 (Annex-K), it may be deduced that the Department required re-determination of the seniority of Foresters with reference to the service record of the respondents as Forest Guards. The appellant is at loss to understand when the Department referred the

disputed seniority list with reference to appeal of appellant and others to CCF-I, Peshawar for examination in accordance with service record of respondents and for his specific recommendations to the Department, why such recommendations were not procured or materialized; and how it become possible to issue another final seniority list of Foresters in Lower Hazara Forest Circle Abbottabad as stood on 30-04-2024, keeping the settlement of seniority dispute in vacuum. (Copy of Seniority List dated 30-04-2024 is Annexure "M")

11. That unfortunately, the appellant and others were left high and dry by ignoring their joint appeal for correction of their seniority against the respondents under due process, while a panel of Foresters from the disputed seniority list dated 30-04-2024 was prepared including the respondents and appellant with others, keeping the respondents in ascending order above the appellant. Consequently, the respondents have been benefited by their promotion to the post of Deputy Ranger on the basis of wrong and undue seniority position. Copy of working paper and promotion order are Annexure "N" and "O" respectively)
12. The appellant seeks to impugn to the seniority lists dated 31-10-2023 and 30-04-2024 and promotion of the respondents as Deputy Ranger made against the facts and in violation of law/rules/policy on the subject, on the grounds *inter alia* as follow:-

## GROUNDS

- a) That it is the matter of fact that the respondents were initially appointed as Forest Guard in the Siran Forest Division, Masehra. Survey of seniority list of the Forest Guard of said Forest Division as stood on 30-11-2014, 31-03-2015, 31-01-2017, 31-01-2018, 31-12-2019, 31-12-2020, 31-12-2021 & 31-05-2022 would reveal that they throughout remained Forest Guard in the Siran Forest Division until their promotion as Forester made vide order No. 32 dated 19-08-2022 (Annex-G) on their having come in the promotion zone. (Copies of the aforementioned seniority lists are respectively Annexure P/1 to P/8).
- b) That it is an undeniable fact that the appellant was appointed through direct recruitment on 08-03-2016. At the time of appointment of the appellant through initial recruitment, the respondents were holding a lower post of Forest Guard BPS-08 in the Siran Forest Division, Mansehra.
- c) That the respondents for the first time came in promotion zone for the post of Forester on the basis of seniority list of Forest Guards as stood on 31-05-2022 (Annex-P/8) in the Siran Forest Division and were promoted in the same year on 19-08-2022. They were promoted as Forester with immediate effect on recommendation of Departmental Promotion Committee (DPC) vide order dated 19-08-2022 but by the orders Annexure H/1 to H/8 issued by Mr. Muhammad Yousaf Khan, Conservator of Forests, Lower Hazara Forest Circle, Abbottabad, their promotion has been antedated to the date of their appointment as Forest Guard in the Siran Forest Division. The orders passed by aforementioned Conservator of Forest are not only misleading in factual terms but have been passed in violation of all laws and rules on the subject of promotion and seniority. Hence, the orders as to antedated promotion of respondents are liable to annulled and reversed under the facts and law.
- d) That date of regular appointment is the determinative factor for fixation of *inter se* seniority of persons appointed through initial recruitment and those appointed by



promotion. If date of appointment is the same, the the persons appointed through promotion shall rank senior to those appointed by initial recruitment. In case of the appellant and of the respondents, date of appointment is not the same. The appellant was appointed as Forester on 08-03-2016 while the respondents were appointed as Forester on 19-08-2022 but despite their promotion being with immediate effect on recommendation of DPC, the Conservator of Forests, Hazara Forest Circle, Abbottabad in exercise of powers not vested in him under the fact and law, proceeded to grant antedated promotion to the respondents in sheer misuse and excess of his authority. Thus, the seniority of the respondents as determined under orders of the Conservator of Forests, Hazara Forest Circle, Abbottabad and their consequent promotion to the post of Deputy Ranger being illegally gotten gains are not maintainable and liable to be reversed.

- e) That by reversal of seniority and promotion of the respondents, they are liable to be demoted to the post of Forester and appellant and similarly placed other Foresters are entitled to be promoted in their place with back benefits.
- f) That other grounds will be raised, if needed, during personal hearing as and when afforded.

g) With the foregoing facts and grounds, it is respectfully prayed that on acceptance of this appeal, seniority of respondents may be determined according to date of their appointment as Forester and that of the appellant may be restored with placement of his name senior to the respondents and the latter may be demoted to the post of Forester and appellant be promoted as Deputy Ranger with back benefits.

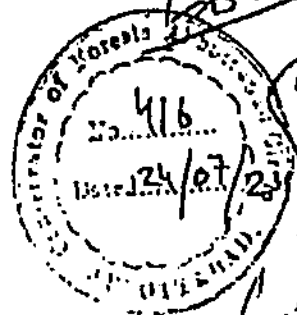


