




1. That the above mentioned Service Appeal was pending before this Hon' able tribunal which has been dismissed in default on 28/10/2024.

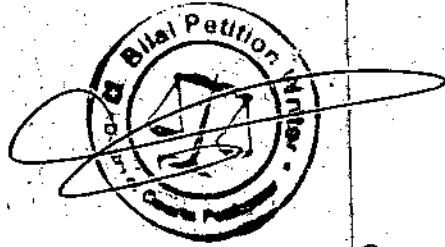


