



RESPECTFULLY SHEWETH:


1. That the instant appeal No. 1248/2022 was filed before this Honorable Tribunal against the preforma promotion.

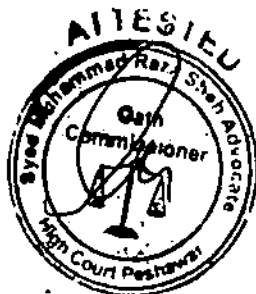


