SUBJECT: PARAWISE COMMENTS ON BEHALF OF RESPONDENT NO. 1.

Preliminary Objections:-

- 1. The Appellant has no locus standi to file the instant service appeal.
- 2. The Service Tribunal in bereft of jurisdiction as the case pertains to NADRA.
- 3. The Appeal in hand is lapsed by doctrines of daches.
- 4. The Appeal is based on assumptions as the same is not relevant to service matters.
- 5. The Applicant cannot invoke extra-ordinary jurisdiction of the Hon'ble Service Tribunal on the basis of apprehension.

Reply on Facts:-

- 1. Pertains to record.
- Incorrect hence, denied. As is evident from the service record and NDRA's documents, the actual date of birth of the appellant is 01-04-1965.
- 3. Correct.
- 4. As admitted by the appellant himself that his date of birth in his credentials is 01-04-1965 according to the GFR-116, date of birth once entered into service record could not be altered except for clerical errors (Annex-A).
- 5. Incorrect. Respondent No. 1 has nothing to do with issuance of CNIC and other personal credentials of the appellant.
- 6. Does not pertain to R No. 1 hence, no comments.
- 7. As above.
- 8. Respondents No. 3 would be in better position to reply this para.
- 9. Pertains to record.
- 10. Correct. It is however, clarified that letter dated 21/03/2024, the appellant request was regretted on the ground that R-I has no jurisdiction to entertain such like cases (Annex-B).
- 11. The Appeal being bereft of merit is not maintainable.

Reply on Grounds:-

- A. Incorrect hence, denied. The appellant was dealt within four-corners of law.
- B. Pertains to record.
- C. Pertains to R-3 hence no comments.

- D. Incorrect hence, denied. As per GFR-116, date of birth once entered into service record could not be altered except for clerical errors.

Subject: CHANGE IN THE RECORDED DATE OF BIRTH OF THE CIVIL SERVANTS
Sir

I am directed to say that under the existing rules, immediate after his induction in service, every civil servant is required to declare certificate of his birth by the Christian era with as far as possible along with confirmatory / conclusive evidence such as matriculation certificate, municipal certificate and so on. This is supplemented by the opinion of the Civil Standing Medical Board. The Department after full satisfaction with on the basis of Medical Examination of the new entrant in the department enter the same in an authentic documents, i.e Service Book/History of service etc. The said document is maintained by the department / audit and is always checked periodically.

The date of birth of a civil servant as recorded in his service documents remains constantly in his knowledge. This is reinterred in his ACRs and the seniority list is issued by the Department from time to time. The preparation of service record of an officer is an official and according to law. It is presumed to be correct GFR-116 also provides that the date of birth once recorded cannot be altered except in the case of clerical error, without the previous orders of the Local Administration. Despite this certain government servants are complacent with the state of affairs and sleep over their rights for decades. Knowing fully about their dates of birth entered in their service books etc. It would therefore be too much to accept such a belated claim from as civil servant that he has born on Departmental appeal date other than the one entered in his service documents and that the delay in representation was due to ignorance of the alleged entry. After all there is always attached finality to decisions taken by competent authorities.

After all, there is always attached condity to decisions taken by competent authorities.
