WHEREIN THE APPELLANTS WERE WRONGLY PLACED BELOW THE PRIVATE RESPONDENTS FROM 4 TO 26 AND WAS SHOWN JUNIORS TO THEM IN UTTER VIOLATION OF RULES & APEX COURT JUDGMENT AND AGAINST NOT TAKING ACTION ON DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN STATUTORY PERIOD OF 90 DAYS.

## **CONSOLIDATED JUDGMENT**

KALIM ARSHAD KHAN CHAIRMAN: Through this single judgment, the above six appeals, are jointly taken up, as both are similar in nature and almost with the same contentions, therefore, can be conveniently decided together.

Appellants' cases in brief, as per averments of appeals 02. are that upon their selection against different teaching posts of BPS-17 advertised by the Khyber Pakhtunkhwa Public Service Commission through Advertisement No.02/2011, they were appointed accordingly; that as per the merit list of the commission, seniority list was issued; that the private respondents, in the light of the decision of the Hon'ble Peshawar High Court, Peshawar passed in Writ Petition No.1289-P of 2010, were regularized with immediate effect, vide Notification dated 31.12.2012, and for giving effect from 01.01.2009 to their regularization, they approached this Tribunal, however, the said relief was denied to them; that the respondent department issued tentative seniority list on which the appellants filed objections, but without removing their objections, seniority list, dated 27.06.2022, as stood on was made wherein, the private respondents, 31.12.2021 allegedly junior to the appellants, were placed senior to them; that feeling aggrieved, they filed departmental appeals on 05.07.2022, but the same were not responded, hence, the instant service appeals.

03. On receipt of the appeals and their admission to full hearing, the respondents were summoned who put appearance and contested the appeals by filing replies. The defense setup was a total denial of the claim of the appellants.

- 04. We have heard learned counsel for the appellants, learned counsel for private respondents and learned Deputy District Attorney for official respondents.
- O5. The learned counsel for the appellants reiterated the facts and grounds detailed in the memo and grounds of the appeals while the learned Deputy District Attorney District Attorney, assisted by the learned counsel for private respondents, controverted the same by supporting the impugned order(s).
- ·06. In brief, the appellants' cases, as outlined in their appeals, involve a dispute regarding their seniority and the regularization of their positions. The appellants were appointed to teaching posts in BPS-17 as per the merit list of the Khyber Pakhtunkhwa Public Service Commission and were subsequently placed on a seniority list. However, the private respondents, who were also appointed through the same commission, were regularized with retrospective effect from January 1, 2009, as per a decision by the Hon'ble Peshawar High Court in Writ Petition No. 1289-P of 2010, and a subsequent notification dated December 31, 2012. The appellants contend that, despite raising objections to the respondent department's tentative seniority list, their concerns were not addressed, and a final seniority list dated June 27, 2022, was issued, which placed the private respondents—

allegedly junior to the appellants—above them in seniority. The appellants filed departmental appeals on July 5, 2022, but these appeals remained un-responded, prompting them to file the present service appeals before this Tribunal.

- The main issue involved in theses is that the appellants were senior to the private respondents. The appellants had been appointed on different dates in the year 2013 when the private respondents had already been regularized vide Notification dated 31.12.2012. So how the appellants could be placed senior to the private respondents, is a question which has an answer as big NO.
- In view of the above, we see no merits in these appeals 08. and dismissed the same with costs. Copy of this judgment be placed on file of connected case. Consign.
