



Appeal Under Section 4 of Khyber Pakhtunkhwa Service Tribunal Act 1974, against the Seniority List issued on the year 2023, whereby the appellant Seniority position has been changed or not assigned on the Testimony of civil servant act 1972 read with APT rules 1972 further respondent no 4 to 8 which is juniors from appellant is considered seniors from appellant and Departmental appeal of the appellant has not been decided, hence the instant Service Appeal.

Respectfully Sheweth

- 1) That the Appellant is a naturally born bonafide citizen of Islamic Republic of Pakistan and hails from a respectable family and appointed as Teacher (BPS-15) in the respondents department/Khyber Pakhtunkhwa elementary and secondary education department on NTS merit basis and stood at 1st position as eligible for promotion to consider his seniority "SST (B.S) (BPS-16)"
(Copy of Appointment Order is annexed herewith as Annexure "A")

Pakhtunkhwa elementary and secondary education department on NTS merit basis and stood at 1st position as eligible for promotion to consider his seniority "SST (B.S) (BPS-16).

- 2) That the office of the assistant director (Estab-M-1) elementary and secondary education Khyber Pakhtunkhwa Peshawar, vide office order No.2119_90F. No, /01/promotion to SSTs/2023/Estab_1 (M) Peshawar dated 22_08_2023 call for DPC meetings schedule for promotion of SCT/CT, SAT/AT, STT/TT, SD/DM, PSHT/SPST/PST & CT(II) to the post of SST(G),SST (bio/Chem), SST(math's/physics) & SST (IT) BPS_16, Schedule for 19_09_2023 & 10_10_2023 in which appellant is not selected due to not considered of the seniority of the appellant, which act on the part of the respondent is illegal, unlawful, and void-ab_intio.

- 3) That feeling aggrieved the Appellant preferred a Grievance application before the district education officer (Male) dir Upper and the same were accepted the seniority of the appellant but till the date no action has been taken in favor of appellant, then feeling aggrieved the Appellant again preferred a Departmental Appeal before respondents but futile. Not decided yet. Justice delayed; justice denied, with best regards.

- 4) That after feeling exhausted the Appellant prefer the instant service appeal for Seniority to the post of Secondary School Teacher-SST (BPS-16) with all back benefits upon the following grounds inter-alia:-

Grounds:

- A) That the appellant is naturally born bonafide citizen of the Islamic Republic of Pakistan & is fully & equally, on equality basis entitled to all basic & fundamental rights as enshrined in the fundamental law of the

land, interpreted, guaranteed & enforced by the laws & law courts of the land.

- 5) That as per admission of seniority of appellant by district education officer (male) upper dir. and the lists of Appointment letter, appellant is eligible for promotion as per subsection 4 of section 8 of the Khyber Pakhtunkhwa civil servant act 1973 which narrated that "**Seniority in a post, service or cadre to which a civil servant is promoted shall take effect from the date of regular appointment to that post**" but in seniority list of 2023 the appellant is not considered as senior as per above mentioned law.
(Copy of merit/seniority list 2023 is annexed).

- B) That the impugned Seniority list 2023 is wrong, illegal and void and not sustainable at all by being not considering seniority of appellant.
- C) That the impugned Seniority list 2023 is the result of colorful exercise of the discretionary power vested in the respondents and not tenable at all.
- D) That even the right of Seniority of the appellant has been recommended by district education officer in the senior list, and other documents, but even than the appellant has not consider senior, which act is not tenable in the eye of law.
- E) That the impugned Seniority list 2023 passed at the back of the appellant and thus the appellant has been kept away from the fruit of Seniority.
- F) That under the mandate of Article 4 of the constitution, no one should be treated otherwise than in an accordance with law, wherein article 25 postulates that alike, but here a different discriminative approach has been used to treat the appellant.

(Q)

- G) That discrimination in any form is highly abominable and bête noir and is always checked down in derisorious manner by the superior courts of the land.
- II) That the law and law court of the land have always prepared and encouraged that rules and policies are to be followed and have always discouraged, deplored, and depreciated any variation from the rules or policies.
- I) That as per the prevailing rules & law governing the subject, the Appellant is fully eligible in all aspects and is fully and equally entitled to be considering Senior on regular basis.
- J) That it is cherished principle of law that where a law requires a thing to be done in particular manner, then that has to be done in that very manner & not otherwise.
- K) That deferment of the subject seniority being not considering is based on malafide & liable to be struck down.
- L) That violation of section 8 of the Khyber Pakhtunkhwa civil servant Act, 1973 and the Khyber Pakhtunkhwa civil servants (appointment, promotion, & transfer) rules, 1989 was committed by respondents.
- M) That district education officer (Male) admitted the seniority of the appellant.
- N) That any other ground not raised here may graciously be allowed to be raised at the time of arguments.

(5)

- A) That respondent no 4 to 8 are considered seniors from appellant which are not entitled the act of respondent no 1 to 3 is illegal against the constitution of Pakistan and liable to be set aside.
- B) That any other ground not raised here may graciously be allowed to be raised at the time of arguments.

It is, therefore, most humbly prayed that on acceptance of the instant Service Appeal, impugned Seniority lists may kindly be rectified by placing the appellant at this very position as per law and rules and respondent no 4 to 8 considered juniors from appellant.

Any other relief not specifically asked for may graciously be extended in favor of the appellant in the circumstances of the case.







6. Their services are liable to termination on one month's prior notice from either side. In case of resignation without notice their one month pay/allowances shall be forfeited to the Government treasury.
7. Pay shall not be drawn until and unless a certificate issued by this office that to the effect that their documents have been verified.
8. They should join their posts within 30 days of the issuance of this notification. In case of failure to join the post within 30 days of the issuance of this Notification their appointment shall stand expired automatically and no subsequent appeal etc. shall be entertained.
9. Health & Age Certificate should be produced from the Medical Superintendent before taking over charge.
10. They will be governed by such Rules and Regulations as may be issued from time to time by the Government.
11. Their services shall be terminated at any time in case their performance is found unsatisfactory during their service period. In case of misconduct, they shall be proceeded against under the relevant rules & regulations announced from time to time.
12. Their appointment is Ad hoc and school based. They shall have to serve at their place of posting and their services are not transferable to any other station.
13. Before handing over charge to them, their documents may be checked and if found bogus or fake they may be reported to this office for necessary action.
14. Posting within the selected five schools is the wholly sole authority of the appointing authority and no one has the right to claim for a specific school.
15. All the Principal / Headmasters are required to collect an affidavit from each candidate that he will follow all the terms and condition listed above and will keep it on record.
16. Errors and omissions will be acceptable within the specified period.

- Their services shall be governed by the Khyber Pukhtunkhawa Civil Servants Act, 1973, the Khyber Pukhtunkhawa (Appointment, Deputation, Posting & Transfer of teacher, Instructors & Doctors) Regulatory act, 2011, and such rules and regulations as may be issued from time to time by the Government.

As the case may be, who are in service on regular basis on the commencement of the Khyber Pukhtunkhawa Employees of Elementary And secondary Education (Appointment and Regularization of services) act, 2017 (Khyber Pukhtunkhawa Act No.1 of 2018) and shall also junior to such other persons, if any, who, were appointed on regular basis to the respective service or cadre before the commencement of this Act, irrespective of their actual date of appointment.

8. The seniority of the employees, whose are regularized under this Act within the same service or cadre, shall be determined on the basis of their merit position in such service or cadre.
9. Their seniority shall be determined on the basis of their continuous service in cadre; provided that if the date of continuous services in the case of two or more employees is the same, the employee older in age shall be rank senior to the younger one.
