

**Assigned on the Tchestone of civil servant act 1972 read with APT**  
**rules 1972 further respondent no 4 to 8 which is juniors from**  
**appellant is considered seniors from appellant and Departmental**  
**appeal of the appellant has not been decided, hence the instant**  
**Service Appeal.**

**Respectfully Sheweth,**

- 1) That the Appellant is a naturally born bonafide citizen of Islamic Republic of  
Pakistan and hails from a respectable family and appointed as Teacher  
(BPS\_15) in the respondents department/Khyber Pakhtunkhwa  
elementary and secondary education department on NTS merit basis  
and stood at 1<sup>st</sup> position as eligible for promotion to consider his  
seniority "SST (B.S) (BPS-16)  
(Copy of Appointment Order is annexed herewith as Annexure "A)

2) That the office of the assistant director (Estab-M-1) elementary and secondary education Khyber Pakhtunkhwa Peshawar, vide office order No.2119\_90F.No, /01/promotion to SSTs/2023/Estab\_1 (M) Peshawar dated 22\_08\_2023 call for DPC meetings schedule for promotion of SCT/CT, SAT/AT, STT/TT, SD/DM, PSHI/SPST/PST & CT(IT) to the post of SST(G),SST (bio/Chem), SST(math's/physics) &SST (IT) BPS\_16, Schedule for 19\_09\_2023 & 10\_10\_2023 in which appellant is not selected due to not considered of the seniority of the appellant, which act on the part of the respondent is illegal, unlawful, and void-ab\_intio. **(Copy of office order no.2119\_90F.No, /01/promotion to SSTs/2023/Estab\_1 (M) Peshawar dated 22\_08\_2023 is annexed).**

3) That feeling aggrieved the Appellant preferred a Grievance application before the district education officer (Male) dir Upper and the same were accepted the seniority of the appellant but till the date no action has been taken in favor of appellant, then feeling aggrieved the Appellant again preferred a Departmental Appeal before respondents but futile. Not decided yet. **Justice delayed; justice denied, with best regards.** **(Copy of Departmental Appeal and office order of DEO upper dir are annexed)**

4) That after feeling exhausted the Appellant prefer the instant service appeal for Seniority to the post of Secondary School Teacher-SST (BPS-16) with all back benefits upon the following grounds inter-alia: -

**Grounds:**

A) That the appellant is naturally born bonafide citizen of the Islamic Republic of Pakistan & is fully & equally, on equality basis entitled to all basic & fundamental rights as enshrined in the fundamental law of the

land, interpreted, guaranteed & enforced by the laws & law courts of the land.

- 5) That as per admission of seniority of appellant by district education officer (male) upper dir and the lists of Appointment letter, appellant is eligible for promotion as per subsection 4 of section 8 of the Khyber Pakhtunkhwa civil servant act 1973 which narrated that "Seniority in a post, service or cadre to which a civil servant is promoted shall take effect from the date of regular appointment to that post" but in seniority list of 2023 the appellant is not considered as senior as per above mentioned law.  
(Copy of merit/seniority list 2023 is annexed).
- B) That the impugned Seniority list 2023 is wrong, illegal and void and not sustainable at all by being not considering seniority of appellant.
- C) That the impugned Seniority list 2023 is the result of colorful exercise of the discretionary power vested in the respondents and not tenable at all.
- D) That even the right of Seniority of the appellant has been recommended by district education officer in the senior list, and other documents, but even than the appellant has not consider senior, which act is not tenable in the eye of law.
- E) That the impugned Seniority list 2023 passed at the back of the appellant and thus the appellant has been kept away from the fruit of Seniority.
- F) That under the mandate of Article 4 of the constitution, no one should be treated otherwise than in an accordance with law, wherein article 25 postulates that alike, but here a different discriminative approach has been used to treat the appellant.

G) That discrimination in any form is highly abominable and bête noire and is always checked down in derisorous manner by the superior courts of the land.

II) That the law and law court of the land have always prepared and encouraged that rules and policies are to be followed and have always discouraged, deplored, and depreciated any variation from the rules or policies.

I) That as per the prevailing rules & law governing the subject, the Appellant is fully eligible in all aspects and is fully and equally entitled to be considering Senior on regular basis.

J) That it is cherished principle of law that where a law requires a thing to be done in particular manner, then that has to be done in that very manner & not otherwise.

K) That deferment of the subject seniority being not considering is based on malafide & liable to be struck down.

L) That violation of section 8 of the Khyber Pakhtunkhwa civil servant Act, 1973 and the Khyber Pakhtunkhwa civil servants (appointment, promotion, & transfer) rules, 1989 was committed by respondents.

M) That district education officer (Male) admitted the seniority of the appellant.

N) That any other ground not raised here may graciously be allowed to be raised at the time of arguments.

- A) That respondent no 4 to 8 are considered seniors from appellant which are not entitled the act of respondent no 1 to 3 is illegal against the constitution of Pakistan and liable to be set aside.
- B) That any other ground not raised here may graciously be allowed to be raised at the time of arguments.







2. Charge reports should be submitted to all concerned.
3. Appointment is purely on temporary/ad hoc basis for one year period with effect from 22.05.2017 to 21.05.2018.
4. They should not be handed over charge if their age exceeds 35 (Thirty Five) or below 18 years of age.
5. Appointment is subject to the condition that their certificates/documents must be verified from the concerned authorities and anyone found producing bogus certificate/s or degree/s

- their appointment shall be cancelled and they will be reported to the Law enforcing agency for further legal action.
- 6. Their services are liable to termination on one month's prior notice from either side. In case of resignation without notice their one month pay/allowances shall be forfeited to the Government treasury.
- 7. Pay shall not be drawn until and unless a certificate issued by this office that to the effect that their documents have been verified.
- 8. They should join their posts within 15 days of the issuance of this notification. In case of failure to join the post within 15 days of the issuance of this notification their appointment shall stand expired automatically and no subsequent appeal etc. shall be entertained.
- 9. Health & Age Certificate should be produced from the Medical Superintendent before taking over charge.
- 10. They will be governed by such Rules and Regulations as may be issued from time to time by the Government.
- 11. Their services shall be terminated at any time in case their performance is found unsatisfactory during their service period. In case of misconduct they shall be proceeded against under the relevant rules & regulations announced from time to time.

### Terms & Condition:

1. Their services shall be governed by the Khyber Pukhtunkhawa Civil Servants Act, 1973, the Khyber Pukhtunkhawa (Appointment, Deputation, Posting & Transfer of teacher, Instructors & Doctors) Regulatory act, 2011, and such rules and regulations as may be issued from time to time by the Government.
2. Their services shall be considered regular and they shall be eligible for pension / deduction of GP Fund in terms of the Khyber Pukhtunkhawa Civil Servant Act, 1973 as amended in 2013.
3. They shall possess the same qualification and experience required for the regular post.
4. Their services are liable to termination on one month notice from either side, in case of resignation without notice, their one month pay/allowances shall be forfeited to the Government.
5. Their regularization shall not affect the promotion quota of existing holders of posts in respective service cadres.
6. The regularization shall not be in favor of those, who have not taken over charge or have remained absent from duty or resigned from service and also not for those who are under disciplinary proceedings.
7. The Employees whose services regularized under the Khyber Pukhtunkhawa Employees of the Elementary & Secondary Education (Appointment and Regularization of Services) Act, 2017 (Khyber Pukhtunkhawa Act No.1 of 2018) or in the process of attaining service at the commencement of Khyber Pukhtunkhawa Employees of Elementary and secondary Education (Appointment and Regularization of services) Act, 2017 (Khyber Pukhtunkhawa Act No.1 of 2018) shall rank junior to all civil servants belonging to the same service or cadre. As the case may be, who are in service on regular basis on the commencement of the Khyber Pukhtunkhawa Employees of Elementary And secondary Education (Appointment and Regularization of services) act, 2017 (Khyber Pukhtunkhawa Act No.1 of 2018) and shall also junior to such other persons, if any, who, were appointed, on regular basis to the respective service or cadre before the commencement of this Act, irrespective of their actual date of appointment.



8. The seniority of the employees, whose are regularized under this Act within the same service or cadre, shall be determined on the basis of their merit position in such service or cadre.
9. Their seniority shall be determined on the basis of their continuous service in cadre, provided that if the date of continuous services in the case of two or more employees is the same, the employee older in age shall be rank senior to the younger one.

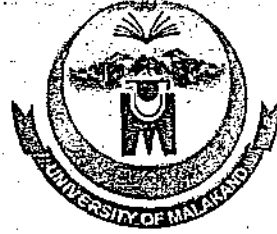


