

Appeal Under Section 4 of Khyber Pakhtunkhwa Service Tribunal Act 1974, against and the impugned notification: 4868 73/file/promotion to SST/2023 Peshawar dated 08/12/2023 office of the respondent no 2, whereby the private respondents no 4 to 8 who is juniors to the appellant has been promoted and ignored the appellant being eligible in all respect to be promoted to the post of SST bio/chem and against not taking action on the departmental appeal of the appellant within statutory period of 90 days.

That the Appellant is a naturally born bonafide citizen of Islamic Republic of Pakistan and hails from a respectable family and appointed as Teacher (BPS-15) in the respondents department/Khyber.

Respectfully Sheweth,

1) That the Appellant is a naturally born bonafide citizen of Islamic Republic of Pakistan and hails from a respectable family and appointed as Teacher (BPS_15) in the respondents department/Khyber Pakhtunkhwa elementary and secondary education department on NTS merit basis and stood at 1st position as eligible for promotion to "SST (B.S) (BPS-16).
(Copy of Appointment Order is annexed herewith)

2) That before opening the main epitome of the instant appeal, it is pertinent to mention here, that Before the impugned notification dated 08/12/2023, departmental promotion committee (DPC) was made in the year 2022 which appellant was deprived from his legal right on pretext of insufficient document in shape of B. ED degree and in the first DPC order (Ends no; 1192-99/F. No15/DEO (M) ADEO/Est (s) dated; 24/12/2022) appellant was excluded from legal promotion nevertheless possessing B. ED degree since 2018, that letter on the appellant became astonished when he finds out that one of candidate namely Mr. Riyaz Ullah B. ED entry was made in the service book and merit list without having B. ED degree than appellant filed addition application dated 25/07/2022 for entry of B. ED and M. ED in the service book and presented his grievance before district education officer (DEO) male dir upper and the DEO responded that on upcoming December we will include your B. ED and M. ED entry as well as count your seniority, that after December appellant severely visited to District education officer (Male) dir upper office to filed corrigendum application then latter on filed addition of seniority application but DEO (male) didn't respond, that ongoing all hectic approaches and dedications meanwhile respondent's department revealed merit list of DPC 2023 which the appellant name was not added by respondent, that after revealing of final

merit list of DPC 2023 appellant went to district education officer (DEO) (male) upper dir office with grievance. appeal then DEO (male) admits the seniority of appellant from the 1st appointment. (Copy of acceptance order DEO upper dir and other relevant document are annexed herewith).

3) That now coming to the main crux of the instant service appeal, that the office of the assistant director (Estab-M-1) elementary and secondary education Khyber Pakhtunkhwa Peshawar, vide office order No.2119_90F.No, /01/promotion to SSTs/2023/Estab_1 (M) Peshawar dated 22_08_2023 call for DPC meetings schedule for promotion of SCT/CT, SAT/AT, STT/TT, SD/DM, PSHT/SPST/PST & CT(IT) to the post of SST(G),SST (bio/Chem), SST(maths/physics) &SST (IT) BPS_16, Schedule for 19_09_2023 & 10_10_2023.
(Copy of office order no.2119_90F.No, /01/promotion to SSTs/2023/Estab_1 (M) Peshawar dated 22_08_2023 is annexed herewith).

4) That as per admission of seniority of appellant, by district education officer (male) upper dir and the lists of seniority private respondent no 4 to 8 are juniors from appellant (having score (124.75) and appellant is eligible for promotion as per subsection_4 of section 8 of the Khyber Pakhtunkhwa civil servant act 1973 which narrated that "Seniority in a post, service or cadre to which a civil servant is promoted shall take effect from the date of regular appointment to that post"
(Copy of merit/seniority list of 2017, 2022, and 2023 are annexed as Annexure "G, H, and I").

5) That DPC has been conducted, vide impugned notification: 4868_73/file/promotion to SST/2023 Peshawar dated; 08/12/2023 of the office of director of elementary and secondary education Khyber Pakhtunkhwa Peshawar, whereby the promotion order of the appellant has not been made against quota of SST bio/Chem) is fixed for, which act on the part of the respondent is illegal, unlawful, and void-ab_intio.
(Copy impugned notification: 4868_73/file/promotion to SST/2023 Peshawar dated; 08/12/2023 is already annexed)

6) That feeling aggrieved the Appellant preferred a Departmental Appeal, but futile. Not decided yet. **Justice delayed; justice denied**, with best regards.

(Copy of Departmental Appeal is annexed herewith as Annexure "G")

7) That after feeling exhausted the Appellant prefer the instant service appeal for promotion to the post of Secondary School Teacher-SST (BPS-16) with all back benefits upon the following grounds inter-alia: -

Grounds:

- A) That the appellant is naturally born bonafide citizen of the Islamic Republic of Pakistan & is fully & equally, on equality basis entitled to all basic & fundamental rights as enshrined in the fundamental law of the land, interpreted, guaranteed & enforced by the laws & law courts of the land.
- B) That the impugned promotion notification is wrong, illegal and void and not sustainable at all by not promoting appellant.
- C) That the impugned promotion notification is the result of colorful exercise of the discretionary power vested in the respondents and not tenable at all.
- D) That even the right of promotion of the appellant has been recommended by district education officer in the senior list, and other documents, but even than the appellant has not been promoted, which act is not tenable in the eye of law.
- E) That the impugned promotion notification has been passed at the back of the appellant and thus the appellant has been kept away from the fruit of promotion.
- F) That under the mandate of Article 4 of the constitution, no one should be treated otherwise than in an accordance with law, wherein article 25 postulates that alike, but here a different discriminative approach has been used to treat the appellant.
- G) That discrimination in any form is highly abominable and bete noire and is always checked down in derisorous manner by the superior courts of the land.
- H) That the law and law court of the land have always prepared and encouraged that rules and policies are to be followed and have always

discouraged, deplored, and depreciated any variation from the rules or policies.

- l) That as per the prevailing rules & law governing the subject, the Appellant is fully eligible in all aspects and is fully and equally entitled to be promoted on regular basis as Secondary School Teacher SST from the date of 1st DPC meeting.
- g) That it is cherished principle of law that where a law requires a thing to be done in particular manner, then that has to be done in that very manner & not otherwise.
- k) That as per minutes of the 1st meeting of DPC posts of Secondary School Teacher- SST available for promoting from PBS-15 to PBS-16, but the respondent department have illegally & unlawfully deferred the promotion & that too without mentioning any reasons which is illegal, unlawful & against the regulations.
- l) That from every angle, the appellant is entitled to be promoted as Secondary School Teacher -SST (from BPS-15 to BPS-16) on regular basis, at least from date of 1st DPC meeting.
- m) That deferment of the subject promotion for the subject post in the impugned DPC is based on malafide & liable to be struck down.
- n) That violation of section 8 and 9 of the Khyber Pakhtunkhwa civil servant Act, 1973 and the Khyber Pakhtunkhwa civil servants (appointment, promotion, & transfer) rules, 1989 was committed by respondents.
- o) That district education officer (Male) admitted the seniority of the appellant.
- p) That any other ground not raised here may graciously be allowed to be raised at the time of arguments.

It is, therefore, most humbly prayed that on acceptance of the instant Service Appeal, impugned notification: 4868_73/file/promotion to SST/2023 Peshawar dated; 08/12/2023 of the office of director elementary and Secondary Education Khyber Pakhtunkhwa Peshawar may kindly be set aside to the extent of private respondent no 4 to 8 and the appellant may kindly consider for promotion to the post of SST bio/Chem BPS_16, with effect from when his junior colleague were promoted with all back benefit.

Any other relief not specifically asked for may graciously be extended in favor of the appellant in the circumstances of the case.







Terms & Condition:

1. Their services shall be governed by the Khyber Pukhtunkhawa Civil Servants Act, 1973, the Khyber Pukhtunkhawa (Appointment, Deputation, Posting & Transfer of teacher, Instructors & Doctors) Regulatory act, 2011, and such rules and regulations as may be issued from time to time by the Government.
2. Their services shall be considered regular, and they shall be eligible for pension / deduction of GP Fund in terms of the Khyber Pukhtunkhawa Civil Servant Act, 1973 as amended in 2013.
3. They shall possess the same qualification and experience required for the regular post.
4. Their services are liable to termination on one month notice from either side, in case of resignation without notice, their one month pay/allowances shall be forfeited to the Government.
5. Their regularization shall not affect the promotion quota of existing holders of posts in respective service cadres.
6. The regularization shall not be in favor of those, who have not taken over charge or have remained absent from duty or resigned from service and also not for those who are under disciplinary proceedings.
7. The Employees whose services regularized under the Khyber Pukhtunkhawa Employees of the Elementary & Secondary Education (Appointment and Regularization of Services) Act, 2017 (Khyber Pukhtunkhawa Act No.1 of 2018) or in the process of attaining service at the commencement of Khyber Pukhtunkhawa Employees of Elementary and secondary Education (Appointment and Regularization of services) Act, 2017 (Khyber Pukhtunkhawa Act No.1 of 2018) shall rank junior to all civil servants belonging to the same service or cadre. As the case may be, who are in service on regular basis on the commencement of the Khyber Pukhtunkhawa Employees of Elementary And secondary Education (Appointment and Regularization of services) act, 2017 (Khyber Pukhtunkhawa Act No.1 of 2018) and shall also junior to such other persons, if any, who, were appointed on regular basis to the respective service or cadre before the commencement of this Act, irrespective of their actual date of appointment.


8. The seniority of the employees, whose are regularized under this Act within the same service or cadre, shall be determined on the basis of their merit position in such service or cadre.
9. Their seniority shall be determined on the basis of their continuous service in cadre, provided that if the date of continuous services in the case of two or more employees is the same, the employee older in age shall be rank senior to the younger one.


