APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST NOT CONSIDERING THE APPELLANT FOR PROMOTION SUPERINTENDENT(BPS-17) FROM HIS DUE DATE AND NOT TAKING ANY ACTION ON THE APPEAL OF THE APPELLANT WITHIN STATUTORY PERIOD OF 90 DAYS.'

#### PRAYER:

THAT ON ACCEPTANCE OF THIS APPEAL THE INACTION AND NOT DECIDING THE DEPARTMENTAL APPEAL OF THE APPELLANT BY THE RESPONDENTS MAY BE DECLARED AND ILLEGAL UNLAWFUL, AGAINST THE PRINCIPLE OF JUSTICE WITH FURTHER DIRECTION TO THE RESPONDENTS TO CONSIDER THE APPELLANT FOR PROMOTION AS SUPERINTENDENT WITH EFFECT FROM HIS DUE DATE AND IN LIGHT OF NOTE OF DPC OBSERVATIONS WITH ALL BACK BENEFITS. ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT MAY ALSO BE AWARDED IN FAVOUR OF THE APPELLANT.

### RESPECTFULLY SHEWETH:

#### **FACTS:**

- 1. That the appellant joined the Respondent Department as Junior Scale Stenographer BPS-14 on 15.06.2015 and has been performing his duties upto the entire satisfaction of his superior and has never given a chance of complaint to his high ups and the service record of the appellant is the evidence of his dedication and professionalism. Copy of the appointment order is attached annexure-A.
- 2. That the appellant was promoted from (Jr. Scale Stenographer BPS-14 to Senior Scale Stenographer BS-16 on 19.05.2021. Presently the appellant at serial NO.01 of the seniority list. Copy of promotion order and seniority list is attached as Annex-B, B1.
- 3. That on 23.12.2023 a DPC was convened to the post of superintendent BPS-17 the committee observed that 02 vacant post of superintendent are available, one post falls to the share of office assistant BPS-16 and the other falls in the share of Senior Scale Stenographer BPS-16. However, incumbent of Senior Scale Stenographer is not available therefore the same may also be filled from the eligible Assistant (BS-16). However upon the recommendation of section officer (R-IV) Establishment, both the post falls in the share /quota of senior scale stenographer. The Sr. Scale lengthy of service by less then three years, thus he is eligible for acting charge appointment. Therefore, he may be recommended on acting charge appointment. The second lefty over post may be filled from other clause i.e (Assistant) as per proviso in the Service Rule.

## Copy of minutes of the meeting & Service Rules are attached as Annex-C, C1.

- 4. That the appellant being an eligible candidate for the promotion on acting charge basis and was waiting for such result as observed, but the appellant got no response, finally the appellant filed departmental appeal on 12.08.2024 but the same was not responded within the statutory period of 90-days. Copy of departmental appeal is attached as Annex-D.
- 5. That having no other remedy against the acts/omissions of the respondents and the appellant is constrained to come to this august Tribunal on the following grounds amongst the others.

#### **GROUNDS:-**

- A) That the inaction of the respondents and not considering the appellant for promotion to BPS-17 as per observation and not taking any action on the appeal of the appellant within statutory period of 90 days are against the law, facts, norms of justice, principles governing acting charge promotion cases. Therefore, such inaction of the respondents is not tenable under the law.
- B) That not responding the departmental appeal with in statutory period of 90 days is against the Judgment of Supreme Court as 2011-SCMR 01, as such the impugned inaction of the respondent is illegal, unlawful, without and lawful authority, thus calling interference of this learned Tribunal.
- C) That according to the observations made by SO (R-IV) Establishment Department the senior scale stenographer of the cadre is short of required length of service by less than three years, he is eligible for acting charge appointment. But despite to clear therefore observation no further action was taken.
- D) That as per KP Civil Servant APT Rules, 1989 Rule-9 (1) (Appointment of acting charge basis or current charge basis) "where the appointing authority considered it to be in the public interest to fill a post reserved under the rules for departmental promotion and the most senior civil servant belonging to the cadre or service concerned, who is otherwise eligible for promotion, not possess the specified length of service the authority may appoint him to that post on acting charge basis".
- E) That it was the right of the appellant to be promoted on acting charge basis and the same was also observed by the Apex Court in its judgment reported as 2024-SCMR-1341.
- F) That the appellant was not treated according to the law and rules and has been deprived from his legal right of promotion.
- G) That appellant was not considered for promotion inspite of observation of SO(R-IV) Establishment Department with out giving any reason, and as such the acts/omissions of the respondents are against the spirit of Article-2A, 4, 9, 25 & 38 of the Constitution.
- H) That the appellant being eligible candidate for promotion and was not considered for promotion which is totally against the law, norms of

justice and Superior Court Judgments wherein it has held that no one should be suffered for the fault of others.

- I) That the appellant has been made to suffer for belated his promotion in an illegal and fanciful manner, which is not permissible in the eyes of law.
- J) That the appellant has not been dealt with in accordance with law rules and principles laid down by Superior Courts.
- K) That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.
